ACCEPTANCE OF THE TERMS AND CONDITIONS

BY DOWNLOADING, INSTALLING, COPYING, ACCESSING, USING THE SOFTWARE OR SOFTWARE SERVICES OR SIGNIFYING YOUR ACCEPTANCE TO THIS AGREEMENT, YOU AGREE TO THE TERMS OF THIS AGREEMENT ON YOUR OWN BEHALF AND ON BEHALF OF THE LICENSEE. YOU REPRESENT AND WARRANT THAT YOU HAVE FULL AUTHORITY TO BIND THE LICENSEE TO THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS AND DO NOT HAVE THE AUTHORITY AS PROVIDED HEREIN, DO NOT DOWNLOAD, INSTALL, COPY, ACCESS, OR USE THE SOFTWARE.

This Agreement shall be the sole and exclusive license agreement binding Blue Ridge Networks, Inc. ("BLUE RIDGE") and LICENSEE.

- 1. AGREEMENT: Pursuant to the terms and conditions of this License Agreement, BLUE RIDGE shall grant to LICENSEE a non-exclusive, non-transferable license to use BLUE RIDGE packaged computer programs either in object code or within the device delivered (the "Software") and related documentation (the "License"), with the functionality of the Software and Software Services described on the applicable product information pages on www.blueridgenetworks.com/products. The term of this License shall be indicated on the applicable sales invoice, order confirmation or receipt ("Sales Order"), which Sales Order is incorporated herein by reference.
- 2. PAYMENT: The price to be paid by LICENSEE for the License and the payment terms are as defined on the Sales Order. If LICENSEE has not paid for the License, BLUE RIDGE only grants the license rights to LICENSEE for a limited period of thirty (30) days after the first download of the Software and BLUE RIDGE may, at its discretion, provide limited function Software.
- 3. RESTRICTED USE: Each copy of the Software is licensed for the limited use indicated on the applicable Sales Order. LICENSEE may make back-up or archival copies of the Software provided that LICENSEE reproduces all confidentiality and proprietary notices on each of these copies and maintains an accurate record of their location. LICENSEE agrees that BLUE RIDGE or its licensors retains all exclusive right, title, interest and ownership in and to the Software, components and related documentation and all derivative works, modifications, and extensions thereto, no matter by whom created, as well as any patent, trademark or copyrights associated with the Software, components and all derivative works, modifications, and extensions thereto and related documentation. In the event any derivative works, components, modifications, and extensions of BLUE RIDGE Software or documentation do not fall within the specifically enumerated works that constitute works made for hire under the applicable copyright or patent laws, LICENSEE hereby, on its own behalf and on behalf of any entity that it is contracting with, irrevocably, expressly and automatically assigns all right, title and interest worldwide in and to such works to BLUE RIDGE, including, without limitation, all copyright, patent rights, trade secrets, trademarks, moral rights and all other applicable proprietary and intellectual property rights. LICENSEE may use the Software for its internal use only and may not use the Software as part of a hosted, leased or subscription service for the benefit of any third party. LICENSEE agrees that any Third Party Programs (as defined below), are not to be used except as an integrated component of the Software and any Third Party Program application development interfaces may not be used for any purpose. LICENSEE will not copy, translate, modify, decompile, disassemble, reverse engineer or adapt the Software except as specifically authorized under applicable law or by BLUE RIDGE in writing. All rights not specifically granted h
- WARRANTY: BLUE RIDGE warrants that the medium on which the Software is furnished will be free from defects in materials and workmanship under normal use for a period of thirty (30) days from the date of delivery to LICENSEE. BLUE RIDGE will replace any Software that fails to meet this limited warranty. BLUE RIDGE will provide updates and fixes, if any, as they become available. THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, TO LICENSEE OR ANY OTHER PARTY, FOR SOFTWARE, SERVICES, AND PRODUCTS PROVIDED UNDER THIS AGREEMENT, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE OR OTHER WARRANTIES FOR NON-INFRINGEMENT, SATISFACTORY QUALITY, OR AGAINST LATENT DEFECTS. BLUE RIDGE SPECIFICALLY DENIES ANY IMPLIED OR EXPRESS REPRESENTATION THAT THE SOFTWARE. WILL (a) FIT LICENSEE'S REQUIREMENTS; (b) OPERATE IN COMBINATIONS WHICH MAY BE SELECTED FOR USE BY LICENSEE; (c) OPERATE UNINTERRUPTED OR ERROR-FREE OR PROVIDE OR FACILITATE A COMPLETE DEFENSE AGAINST MALWARE, VIRUS OR OTHER INTRUSIONS OR DATA THEFT OR UNAUTHORIZED DISCLOSURE; OR (d) HAVE ALL DEFECTS CORRECTED. IT IS LICENSEE'S RESPONSIBILITY TO PROVIDE ADEQUATE HARDWARE AND SOFTWARE EQUIPMENT NECESSARY TO ENSURE THE PROPER FUNCTIONING OF THE SOFTWARE. THE SOFTWARE IS NOT FAULT-TOLERANT AND IS NOT DESIGNED, MANUFACTURED OR INTENDED FOR USE OR RESALE IN HAZARDOUS ENVIRONMENTS REQUIRING FAIL-SAFE PERFORMANCE, WHERE ANY FAILURE OF THE SOFTWARE COULD LEAD DIRECTLY TO SIGNIFICANT PROPERTY OR DATA LOSS OR DISCLOSURE, DEATH, PERSONAL INJURY, OR SEVERE PHYSICAL DAMAGE ("HIGH RISK ACTIVITIES"). ACCORDINGLY, BLUE RIDGE, ITS LICENSORS AND ITS SUPPLIERS SPECIFICALLY DISCLAIM ANY EXPRESS OR IMPLIED WARRANTY OF FITNESS FOR HIGH RISK ACTIVITIES. LICENSEE AGREES THAT LICENSOR AND ITS SUPPLIERS WILL NOT BE LIABLE FOR ANY CLAIMS OR DAMAGES ARISING FROM THE USE OF THE SOFTWARE IN SUCH APPLICATIONS.
- 5. DATA COLLECTION: LICENSEE agrees that BLUE RIDGE may collect and use technical data, other data and related information, including but not limited to technical information about LICENSEE's device, system, servers, application software, and peripherals that is gathered periodically. BLUE RIDGE may use this information for all purposes of performance hereunder, and for other purposes as long as it is in a form that does not personally identify LICENSEE.
- 6. METHOD OF DELIVERY: The Software, as well as all future program and documentation enhancements to the Software and patches or updates for error corrections, will be offered in media or form determined by Blue Ridge.
- 7. INDEMNITY:
 - (a) <u>Indemnity.</u> If an action is brought by a third party against LICENSEE claiming that the Software infringes a patent or copyright of a third party, BLUE RIDGE will defend LICENSEE at BLUE RIDGE's expense and, subject to this Section and Section 8, pay the damages and costs finally awarded against LICENSEE in the infringement action, but only if (1) LICENSEE notifies BLUE RIDGE promptly upon

- learning that the claim might be asserted; (2) BLUE RIDGE has sole control over the defense of the claim and any negotiation for its settlement or compromise; and (3) LICENSEE takes no action that, in BLUE RIDGE's judgment, is contrary to BLUE RIDGE's interest.
- (b) Alternative Remedy. If a claim described in Section 7(a) may be or has been asserted, LICENSEE will permit BLUE RIDGE, at BLUE RIDGE's option and expense, and as the sole and exclusive remedy of LICENSEE to (1) procure the right to continue using the Software; (2) replace or modify the Software to eliminate the infringement while providing materially equivalent functionality; or (3) accept the return of the Software and refund to LICENSEE an amount equal to the pro-rata portion of license price actually paid by LICENSEE for the period the Software could not be used. THIS INDEMNITY UNDER SECTION 7 SHALL BE THE SOLE AND EXCLUSIVE OBLIGATION OF BLUE RIDGE FOR ANY CLAIM OF INFRINGEMENT.
- 8. NO CONSEQUENTIAL DAMAGES: IN NO EVENT WILL BLUE RIDGE OR ITS LICENSORS, RESELLERS, SUPPLIERS OR AGENTS BE LIABLE FOR (a) ANY COSTS OF PROCUREMENT OF SUBSTITUTE OR REPLACEMENT GOODS AND SERVICES, LOSS OF PROFITS, LOSS OF USE, LOSS OF OR CORRUPTION TO DATA, BUSINESS INTERRUPTION, LOSS OF PRODUCTION, LOSS OF REVENUES, LOSS OF CONTRACTS, LOSS OF GOODWILL, OR ANTICIPATED SAVINGS OR WASTED MANAGEMENT AND STAFF TIME; OR (b) FOR ANY CONSEQUENTIAL, INDIRECT, SPECIAL, PUNITIVE, OR INCIDENTAL DAMAGES OR LOST PROFITS, WHETHER FORESEEABLE OR UNFORESEEABLE, BASED ON LICENSEE'S CLAIMS (INCLUDING, BUT NOT LIMITED TO, CLAIMS FOR LOSS OF DATA, GOODWILL, USE OF MONEY OR USE OF THE SOFTWARE, FAILURE OF SOFTWARE, INTERRUPTION IN USE OR AVAILABILITY OF DATA, STOPPAGE OF OTHER WORK OR IMPAIRMENT OF OTHER ASSETS) ARISING OUT OF BREACH OR FAILURE OF EXPRESS OR IMPLIED WARRANTY, BREACH OF CONTRACT, MISREPRESENTATION, NEGLIGENCE, STRICT LIABILITY IN TORT OR OTHERWISE. IN NO EVENT WILL THE AGGREGATE LIABILITY WHICH BLUE RIDGE OR ITS LICENSORS, RESELLERS, SUPPLIERS OR AGENTS MAY INCUR IN ANY ACTION OR PROCEEDING EXCEED THE TOTAL AMOUNT ACTUALLY PAID BY LICENSEE FOR THE SPECIFIC SOFTWARE PRODUCT THAT DIRECTLY CAUSED THE DAMAGE FOR A PERIOD OF SIX MONTHS BEFORE SUCH CLAIM. THIS SECTION WILL APPLY EXCEPT WHEN AND TO THE EXTENT THAT APPLICABLE LAW SPECIFICALLY REQUIRES LIABILITY, DESPITE THE FOREGOING EXCLUSION AND LIMITATION.
- 9. CONFIDENTIALITY: LICENSEE acknowledges that the Software incorporates confidential and proprietary information developed or acquired by or licensed to BLUE RIDGE and agrees to take all reasonable precautions necessary to safeguard the confidentiality of the Software. LICENSEE shall not use or permit others to use the Software beyond the scope permitted in the applicable Sales Order or disclose the Software to any third party. The confidential information includes without limitation, source code, object code, interfaces, APIs, dashboards, and all components of the Software.
- 10. TERMINATION: BLUE RIDGE may terminate this License Agreement, upon reasonable notice and without judicial or administrative resolution, if LICENSEE or any of LICENSEE's employees, consultants, or customers breach any term or condition hereof. Upon the termination of this License Agreement for any reason, all rights granted to LICENSEE hereunder cease, and LICENSEE will destroy all copies of the Software. The provisions of Sections 3, 7, 8, 9, 10, 13 and 14 will survive the termination of this License Agreement. Upon any termination or expiration of this License Agreement: (a) LICENSEE shall no longer be authorized to use or possess the Software; and (b) LICENSEE's Software license keys shall be terminated.
- 11. ASSIGNMENT: LICENSEE shall not assign, delegate or otherwise transfer this License Agreement or any of its rights or obligations hereunder without BLUE RIDGE's prior approval.
- 12. U.S. Government Rights: The Software and related documentation are "Commercial Items," as that term is defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation," as such terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. Consistent with 48 C.F.R. §12.212 or 48 C.F.R. §227.7202-1 through 227.7202-4, as applicable, the Commercial Computer Software and Commercial Computer Software Documentation are being licensed to U.S. Government end LICENSEEs (a) only as Commercial Items and (b) with only those rights as are granted to all other commercial end LICENSEEs pursuant to the terms and conditions berein
- 13. COMPLIANCE WITH LAWS: LICENSEE shall carry out the transactions contemplated hereby and shall otherwise deal with the Software in conformity with all applicable laws, rules, and regulations of all governmental authorities, including, without limitation, the Export Administration Act, and shall obtain all permits and licenses required in connection with the license, installation, or use of the Software. The Software may be subject to restrictions as to export, re-export or disclosure to certain foreign persons. LICENSEE agrees that it is solely responsible for compliance with such export laws and controls.
- 14. THIRD PARTY PROGRAMS. The Software may contain third party software programs ("Third Party Programs") that are available under open source or free software licenses. This License Agreement does not alter any rights or obligations LICENSEE may have under those open source or free software licenses. The disclaimer of warranties and the limitation of liability provisions in this License Agreement shall apply to such Third Party programs except where third party license terms provide LICENSEE with lesser rights or greater obligations than are provided for in this License Agreement, in which case such third party license terms apply. The list of Third Party Programs and applicable licenses are included in the Third Party Legal Notice Section of the Blue Ridge website.
- 15. MISCELLANEOUS: All notices or approvals required or permitted under this License Agreement must be given in writing. Any waiver or modification of this License Agreement will not be effective unless executed in writing and signed by BLUE RIDGE. This License Agreement will bind LICENSEE's successors in interest. This License Agreement will be governed by and interpreted in accordance with the laws of the Commonwealth of Virginia, USA. If any provision of this License Agreement is held to be unenforceable, in whole or in part, such holding will not affect the validity of the other provisions of this License Agreement, unless BLUE RIDGE in good faith deems the unenforceable provision to be essential, in which case BLUE RIDGE may terminate this License Agreement effective immediately upon notice to LICENSEE. Except for payment obligations hereunder, neither party shall be responsible for delays or failures in performance resulting from acts reasonably beyond the control of that party. This License Agreement, along with the Sales Order, constitutes the complete and entire statement of all conditions and representations of the agreement between BLUE RIDGE and LICENSEE with respect to its subject matter and supersedes all prior writings, representations, warranties or understandings. The United Nations Convention on Contracts for the International Sale of Goods shall not apply.
