8A Task Force Charge

The Task Force (TF) was established by the Commanding General (CG), 8A, in April 2011, in order to assess the overall implementation of programs initiated to assist victims, prosecute perpetrators, prevent occurrences, and provide an environment of safety, which supports the command and enhances Soldier and mission readiness.

Methodology

- General Survey from all Army units served in Korea
- Open Small Groups Discussion: Composed of Command teams (Company Commanders and First Sergeants), helping professionals (Sexual Assault Response Coordinators (SARCs), Unit Victim Advocates (UVA), medical personnel, counselors), and Soldiers by gender.
- Facility visits
- Reference to Department of Defense Task Force on Sexual Assault in the Military (DODTFSAM) Report from 2009
- Regulations and Policies Review
- Best Practices

Recommendations

Recommendations that were developed after a thorough analysis of the inspections, interviews, and highlighted best practices. The recommendations include the following:

- Standardize barracks policies and physical security procedures
- Increase command emphasis on training, selection, and duties of the UVA
- Create alcohol policies that focus on responsibility verses consequences
- Create a training program better suited to reach the target audience
- Standardize medical resources for sexual assault cases
- Establish better leadership awareness
- Execute a campaign plan to address myths, acceptable behavior, and intervention
- Create a culture of accountability and foster healthy relationship
- Increased physical security, self-locking doors and install camera surveillance systems within barracks
