PARTICULARS OF CLAIM

---

**The Parties**

1. The Claimant is a former Borough councillor in his own area of Welwyn-Hatfield and is currently studying as a weekend student for an LL.M LPC (Master's in Law with Solicitor's Certificate). I have been praised by judges, including Mostyn J, for my charitable activities as a McKenzie Friend. For example, Mostyn J thanked me for my 'sensible' and 'reasonable' submissions.
2. The Defendants are users and also the operators of the website EncyclopediaDramatica.se (ED). ED is a purportedly satirical website, which uses the same encyclopedia (wiki) software as well known website Wikipedia.
3. Because of complaints and controversy, the site takes steps to anonymise itself, for example it uses a service called Cloudflare that acts as a proxy and hides the country it is in and the real IP address of the servers it is hosted on. Editors and staff use pseudonyms. A previous, UK based administrator was arrested on convicted as a member of hacking group Lulzsec.
4. Whilst it is satirical, much of what ED says is accurate and this accounts for its popularity. The site has exposed genuine wrongdoing and other material of interest. So whilst the site is purportedly satirical what it says is often believed – it is much like a more vulgar online Private Eye magazine.

**Events and Publication Complained Of**

5. For some time there has been an article about me on ED. In essence it called me a zealot in child protection matters because of a blog I operate (MatthewHopkinsNews.com), which

deals with case law and sometimes child protection matters. I did not consider the original article objectionable but rather legitimate satire.

6. Between 10 May 2016 and 12 May 2016 users of the site known as 'KiwiDynastia' and 'Likeicare' (an Administrator) amended the article to state that, "*Samuel Collingwood Smith is a Pedophile and Child Rapist*" and variously that I was a paedophile and child rapist. The version at the time of writing is attached as Annex I per PD 53 2.2 (1).
7. I set out the specimen words complained of and the defamatory meanings imputed below as follows to comply with PD 53 2.3 (1) (a) -
8. "*KNOWN CHILD MOLESTOR*" to which I impute the meaning that I am a child molester – one who commits sexual offences against children
9. "*His salivating lust for young ass is apparent*" - to which I impute the allegation that I am attracted to children
10. "*<Vordrak> i love being able to violently mouth fuck my own mother and she forgets it 5 minutes later*", which is a purported internet chat log to which I impute the meaning that I sexually abuse my mother.
11. The heading "*Samuel Collingwood Smith is a Pedophile and Child Rapist*" to which I impute the facial meaning, and everything below it, which includes a falsified internet chat log in which I am depicted to claim that I enjoy child pornography and seeing children hurt. It is actually a real log of another individual referred to on their site with my username falsely substituted in.
12. All of the above factual imputations are denied. I have no criminal convictions, cautions or even warnings for (for example, 'child rape'). I did once receive a police information notice for harassment, but it was officially rescinded when I complained because an investigation revealed my actions were lawful. The police apologised and I have a completely clean record. Also the alleged victim was an adult.
13. I believe the authors of the defamatory statements are retaliating because of an article I wrote. Recently I was tipped off that a website operated by a friend of theirs, <http://kiwifar.ms> was hosting child pornography. When I complained to the site's hosting company, they confirmed it was true and banned the site. The matter is now being investigated by UK and US police. Kiwifar.ms has subsequently sprung up again but been moved by other hosts on several times.
14. The person going by KiwiDynastia uses the name on several sites and I recently caught him in the *actus re* of sending a photograph of his penis to a Twitter hashtag used by minors. I reported him to police, who are investigating and this is likely to be part of his motivation. I also wrote an article about it.

#### **Pre-Action Conduct**

15. On 13 May 2016 I discovered the changed article and complained politely. The usual way to complain on a Wiki is to write on the talk pages of officials. I posted my complaint to several of the highest officials of the site, known as Bureaucrats.
16. I received a prompt reply from an administrator, 'Likeicare'. The reply was delivered on my own talk page and stated, "*fuck off lol*". Another administrator 'DarkLordTR' amplified

stating that if I continued in my course I would be banned and they would see to it that my article came high up in the Google page rankings.

**17.** I responded with a notice under S5 Defamation Act 2013 and also a letter before claim posted again to the talk pages of the Bureaucrats and my own talk page. I received a response, again delivered by the administrator 'Likeicare'. The S5 notice was served at 00:08 14/05/2016 and therefore expired at 00:08 on 16/05/2016.

**18.** The response to the Letter of Claim and S5 Notice was -

**19. \*\*\*\*OFFICIAL RESPONSE FROM MYSELF, AND ON BEHALF OF KIWIDYNSATIA AND ENTIRETY OF ED STAFF\*\*\*\***  
LOL DONT CARE FAGGOT, GO FOR IT

**20.** This was centred and in bold. Other administrators and bureaucrats logged on but did not demur. After the response, I found myself unable to respond on the site and it displayed a montage of revolting gory and sexual images. I believe this is used for banned persons.

**21.** I do not know the real world identities of 'Likeicare' and 'Kiwidynastia'. It has been suggested that Likeicare is called 'Chris Jones' and lives in Australia but I do not know if this is true.

**22.** There is one mistake in the letter of claim, I stated that I might apply to increase the amount of damages sought once the anonymous people had been identified. I have since discovered this is not allowed per *Lewis v Hadaway [2015] EWHC 3503* so I will not make any such application and will live with the amount on the claim form, barring further wrongdoing by the Defendants after issue. By the time I realised this, I had discovered the Defendants' anonymised email addresses on the site, and sent a correction to them also.

**23.** A copy of the pre-action exchange is appended at Annex II, including the correction.

### **Malice**

**24.** On the basis of the facts above, I assert that the Defendant was motivated by malice. If that fails, I allege ordinary defamation.

### **Serious Harm – S1 Defamation Act 2013**

**25.** Encyclopedia Dramatica is a publication which is often believed and the allegations it frames in this case are amongst the most serious crimes known in this jurisdiction. It is evident that the allegation has the potential to cause serious harm. If you Google my name, "*Samuel Collingwood Smith*" at the time of writing it is the first result. As employers often Google the names of potential employers now, this most likely will make many unwilling to employ me. It will most likely make some social acquaintances unwilling to socialise.

### **Jurisdiction – S9 Defamation Act 2013**

**26.** The perpetrators of the defamation complained of purposely obscure their locations and are in any event in multiple jurisdictions. The damage and the tort are here because this is the only place where I seek employment or have any reputation *per se*. A key remedy is likely to be an order prohibiting the repetition of the allegations.

**27.** The Court's attention is drawn to *Sloutsker v Romanova [2015] EWHC 545 (QB)* and in particular paragraph 69 regarding the fact that the gravity of an allegation is a factor that supports engaging the jurisdiction of the English courts.

28. At Annex III I have attached an Alexa.com report for the website. Alexa is a service that measures page popularity. Alexa says that 49.5% of ED's traffic is from the United States where it has 361,880 unique visitors per month. 10.1% is from the United Kingdom and that means 73822 unique visitors per month in the UK. That is a real and substantial tort being committed here.

#### **Human Rights Issues – Human Rights Act 1998**

29. The allegations made and their prominence engages my Article 8 rights. It is trite law that Article 8 encompasses both work and relationships. Willingness to employ me or indeed relate to me is likely to be severely impaired by these allegations and any failure to provide a remedy in this jurisdiction.

#### **Website Operator Immunity – S5 Defamation Act 2013**

30. The website operator's official response to my complaint was, 'fuck off' and the response to the s5 notice and letter of claim was, 'LOL DONT CARE FAGGOT, GO FOR IT'. Firstly, I submit the court should take that as a 'failure' to respond under s5 (3) (c). In any event the time limit has now expired. In addition, the response is obviously malicious and so s5 (11) is engaged.

#### **Particulars of Loss**

31. The potential losses in this case are greater than the actual losses. As I believe that the Defendants are likely to be impecunious, I have plead this claim at £10,000 because of the issue fee, which may not be recoverable.

32. Of the £10,000 sought, £9,000 reflects hurt feelings and £1,000 sought is aggravated damages. The factual basis for this is the childish and threatening response to the polite initial complaint and the letter of claim.

33. The claimant seeks interest 8% under S35A Supreme Court Act 1981 on any damages.

34. The total damages sought on present knowledge are £10,000.

#### **Equitable Remedies**

35. A permanent injunction restraining further publication and requiring the publication complained of to be removed. Even if the Defendants are outside the jurisdiction this is likely to be beneficial to me because other more reputable institutions will act on it. For example, Google policy would be to de-list the site.

#### **Costs**

36. Because of the response to the letter of claim, costs are sought on the indemnity basis, even if a later challenge to jurisdiction or other defence is raised.



The facts:

- Samuel has never mentioned anywhere at any point having a lover.
- Samuel was stalking Amy Lee from Evanescence at the age of 32.

## Welwyn-Hatfield

Sam Smith was elected to represent Welwyn-Hatfield's Haldens ward in June 2005 (<http://www.welhat.gov.uk/index.aspx?articleid=2054>) . Smith was a member of the Labour party at the time. Smith ceased serving the Council in 2008, and in March 2009, Smith joined the Conservative party ([http://www.whtimes.co.uk/news/ex\\_welwyn\\_hatfield\\_councillor\\_turns\\_on\\_divided\\_labour\\_1\\_22554](http://www.whtimes.co.uk/news/ex_welwyn_hatfield_councillor_turns_on_divided_labour_1_22554)) and was embraced by Grant Shapps (<http://www.shapps.com/forum/index.php?action=media;sa=item;in=120;asc>) , the Conservative MP for Welwyn-Hatfield.

Within a week after joining Shapps's forum (<http://www.shapps.com/forum/index.php?action=profile;u=1548>) , Smith made headlines ([http://www.whtimes.co.uk/news/storm\\_over\\_new\\_tory\\_s\\_baby\\_rapist\\_comments\\_1\\_13305](http://www.whtimes.co.uk/news/storm_over_new_tory_s_baby_rapist_comments_1_13305)) . Vordrak compared the Liberal Democrats to a lady pedophile for supporting drug reform proposals:

*Liberal policy poses a greater threat to our children than [pedophile and rapist] Tanya French does.*

Vordrak's comment was deleted, and after receiving media attention, Vordrak apologized ([http://www.whtimes.co.uk/news/tory\\_new\\_boy\\_apologises\\_for\\_lib\\_dem\\_baby\\_rapist\\_comparison\\_1\\_18565](http://www.whtimes.co.uk/news/tory_new_boy_apologises_for_lib_dem_baby_rapist_comparison_1_18565)) :

*I would like to apologise unreservedly for writing insensitive comments in the heat of debate.*

*I completely appreciate that it was inappropriate and offensive.*

Afterwards, Vordrak rarely posted to shapps.com (<http://www.shapps.com/forum/index.php?action=profile;area=showposts;u=1548>) , and threads about him disappeared (<http://www.shapps.com/forum/index.php?topic=4830.0>) .

## "Promoting positivity on evthreads"

Vordrak was an avid Evanescence dork and fanboy (despite his age) (<https://web.archive.org/web/20101230093229/http://evthreads.com/showthread.php?t=17940>) :

Hi guys,

I know many of us think about this but we have never made a thread explicitly for it so ... this is the thread where we plan to make Amy happy.

The goal here is to make Amy feel loved and supported. We each have our own ways of doing this. Some people make videos. My friends and I have organised a campaign team. Others bake cupcakes.

The point of this is for us all to get together and be positive.

My contribution -

- (1) This year I will be trying to make Amy Hartzler happy by -
  - (i) Organising promotion of the new album ...
  - (ii) ... and the muppets CD.



EvThreads, gone thanks to Vordrak.

- (iii) Attending some concerts if she has any.
- (iv) Sending her fun silly stuff.
- (v) Promoting positivity on evthreads.

My question to everyone else is ... how will **\* you \*** be supporting Amy?

(Just to be clear, my buddies and I have other threads going for the band in general and for specific other members. For example, we made a thread about 'The Snobs' regarding Tim's old band. We have lots of nice things planned for the other band members. We have plenty of love to go around. But this thread is about *Amy*.)

- Vordrak

Vordrak joined Ethreads in February 2009. He became a moderator (<http://www.evboard.com/1263396-post85.html>) , but was shocked to learn to he couldn't transform Ethreads into a Puritanical utopia. The site's management didn't allow him to (<http://www.forbes.com/sites/wenjiazhao/2012/07/25/anonymous-targets-singer-and-record-company-in-operation-pedochat/>) take action against self-professed pot smokers or people who published 4chan-esque tales ("paedophile material including a story about sexual offences against a physically disabled male minor") and lolicons ("cartoons with pre-teens in lawful poses but with sexualised captions"). As a true Puritan witchfinder, Vordrak wanted to report these Internet shenanigans to UK authorities, but Amy Lee and her lawyers didn't think that it was such a big deal. Vordrak also seems to take a claim of suicide seriously (<http://www.publications.parliament.uk/pa/cm201213/cmhsrd/cm120717/pettext/120717p0001.htm>) , when anyone with a brain knew the claim of suicide was a fake (<http://www.evboard.com/1263396-post85.html>) .

In short, for Vordrak, the Internet is serious business. In 2012, Vordrak used his connections to political leaders to create a petition (<http://www.publications.parliament.uk/pa/cm201213/cmhsrd/cm120717/petntrtext/120717p0001.htm>) and then used Anonymous as his personal army (<http://archive.is/dKGRR>) ([1] (<https://web.archive.org/web/20140326134114/http://anonnews.org/press/item/1682/comments/>)). This resulted in the closure of Evthreads (<http://www.evboard.com/evthreads-closed-41320.html>).

## Matthew Hopkins

In February 2013 (<http://whois.domaintools.com/thewitchfindergeneral.com>) , Vordrak registered the "thewitchfindergeneral.com" domain and started his blog. Despite his 2009 apology

([http://www.whtimes.co.uk/news/tory\\_new\\_boy\\_apologises\\_for\\_lib\\_dem\\_baby\\_rapist\\_comparison\\_1\\_18565](http://www.whtimes.co.uk/news/tory_new_boy_apologises_for_lib_dem_baby_rapist_comparison_1_18565)) , by October 2013, Vordrak was once again trying to link the Left to pedophilia and compared the Left to the Islamic Republic of Iran (<http://matthewhopkinsnews.com/?p=247>) :

*The world's children will never be safe from the clutches of the organised left while they exist. The only difference in Iran is that at least the Iranians expect the men to marry the girls first.*

In November 2014, Vordrak accused the Left of racism and used Twitter messages as "evidence" (<http://matthewhopkinsnews.com/?p=723>) . Then in January 2015, Vordrak whined about the Holly Fisher meme and compared liberals to children over a Twitter post (<http://matthewhopkinsnews.com/?p=826>) . Again, as in the Evthreads drama, Vordrak takes things said on the Internet far too seriously.

## GamerGate

2015 has been a very productive year for Vordrak's blog with double the amount of published entries than the previous year. Vordrak joined the GamerGate bandwagon and made war on James Billingham's Block Bot. In April 2015, a former Block Bot developer AuntySarah accused Vordrak of harassment, but Vordrak and his knowledge of law allowed him to handle the claims easily (<http://matthewhopkinsnews.com/?p=1430> ) .

Vordrak also tried to build a case against Block Bot (<http://matthewhopkinsnews.com/?p=1349>) but discontinued it in May (<http://matthewhopkinsnews.com/?p=1512>) . Vordrak also started "Operation Untechnica" ([http://thisisvideogames.com/gamergatewiki/index.php?title=Projects:Operation\\_Untechnica](http://thisisvideogames.com/gamergatewiki/index.php?title=Projects:Operation_Untechnica)) , but had difficulties running it: some anons had other ideas (<http://archive.is/zsIFT>) , defacement of the Operation page was plentiful (<http://archive.is/MhnSz>) , and the legitimacy of the entire project was questioned (<https://archive.is/vME70>) . Eventually, Vordrak had to shut the project down (<https://archive.is/HyFjZ>) .

## Wikipedia and Wikipediocracy

In March 2014, Chase me ladies, I'm the Cavalry began a year-long mission to try to connect Contribsx to Grant Shapps. A year later, the Cavalry performed an extensive series of CheckUser actions against Contribsx and blocked Contribsx as Shapps' sockpuppet, all the while in contact with a reporter for *The Guardian*. Cavalry blocked Contribsx as Shapps' sockpuppet, and *The Guardian* publicized the accusations (<http://www.theguardian.com/politics/2015/apr/21/grant-shapps-accused-of-editing-wikipedia-pages-of-tory-rivals>) , but not in that order (oops).

ArbCom performed an investigation into the Cavalry's account of the story, and this drew Vordrak into Wikipedia. Vordrak's first task: suggest a Puritanical approach to which usernames are acceptable ([https://en.wikipedia.org/w/index.php?title=Wikipedia\\_talk:Arbitration/Requests/Case/Sockpuppet\\_investigation\\_block/Proposed\\_decision&diff=665898759](https://en.wikipedia.org/w/index.php?title=Wikipedia_talk:Arbitration/Requests/Case/Sockpuppet_investigation_block/Proposed_decision&diff=665898759)) . Eventually, ArbCom absolved Contribsx and published the Cavalry for his transgressions.

In July 2015, Wikipedia critic forum Wikipediocracy published a blog entry on Vordrak (<https://archive.is/wM4C2>) , and Vordrak retaliated by publishing a blog entry on thekohser (<https://web.archive.org/web/20150717003733/http://matthewhopkinsnews.com/?p=1882>) . Vordrak was apparently under the impression that thekohser was a serious journalist and that examiner.com was a serious online newspaper when neither are. Puritan Vordrak also displayed his lack of appreciation for the lulz and his lack of knowledge about Ceiling Cat:

One of Mr Kohs' admitted accounts is called, "*Feline Who Watches You Masturbate From Above*". The strange, sexualised account name is indicative of his indecorous social conduct

Vordrak and Wikipediocracy later took their blog entries on each other down. Vordrak claimed that this was due to a "reciprocal end to hostilities" ([http://www.reddit.com/r/KotakuInAction/comments/3dk4ki/people\\_oc\\_dishonest\\_gamergate\\_opponent\\_journalist/](http://www.reddit.com/r/KotakuInAction/comments/3dk4ki/people_oc_dishonest_gamergate_opponent_journalist/)) , but it only shows that Vordrak believes in *quid pro quo* and is corruptible: he'll censor his own blog in exchange for favors.



## Ban from Wikipedia

Vordrak, still high off of his victory against Wikipediocracy, decided to take his arch-nemesis Mark Bernstein to ArbCom, but he overplayed his hand. Despite his buddy AmethyGloriCorn advertising the case on Reddit ([http://www.reddit.com/r/KotakuInAction/comments/3dqupr/dramapaedia\\_vordrak\\_has\\_just\\_submitted\\_an\\_arbcom/](http://www.reddit.com/r/KotakuInAction/comments/3dqupr/dramapaedia_vordrak_has_just_submitted_an_arbcom/)) , Vordrak's cause received virtually no support at Wikipedia (<https://en.wikipedia.org/w/index.php?title=Wikipedia:Arbitration/Requests/Case&oldid=672034757#MarkBernstein>) . Seeing that his case was sinking fast, Vordrak began making veiled threats:

*ORLY? Well, alright then ...*

*—Vordrak getting serious (<https://en.wikipedia.org/w/index.php?title=Wikipedia:Arbitration/Requests/Case&diff=672017860>)*

*I have archived Gamaliel's comments about his proposed reasons for blocking me here (<https://archive.is/UkEJg>) . I am not entirely sure he has thought it through but invite him to reconsider. I am not entirely sure he has thought it through but invite him to reconsider.*

*—Vordrak implying consequences (blog entry about those comments) (<https://en.wikipedia.org/w/index.php?title=Wikipedia:Arbitration/Requests/Case&diff=672017860>)*

*Under the latter circumstances [me as an outsider] I am free to say what I like and to reveal the real world names of people I would not otherwise have named.*

*—Vordrak implying that it would be unwise to cast him out (<https://en.wikipedia.org/w/index.php?title=Wikipedia%3AArbitration%2FRequests%2FCase&diff=672018708&oldid=672018451>)*

In response to these messages, Floquenbeam banned Vordrak (<https://en.wikipedia.org/w/index.php?title=Special%3ALog&type=block&page=User%3AVordrak>) :

17:36, 18 July 2015 Floquenbeam (talk | contribs) blocked Vordrak (talk | contribs) with an expiry time of indefinite (account creation blocked, email disabled, cannot edit own talk page) (veiled (very thinly) threats to out others [https://en.wikipedia.org/w/index.php?title=Wikipedia:Arbitration/Requests/Case&oldid=672018719#Statement\\_by\\_Vordrak](https://en.wikipedia.org/w/index.php?title=Wikipedia:Arbitration/Requests/Case&oldid=672018719#Statement_by_Vordrak))

As being banned for intimidation doesn't make for a good martyr story, Vordrak spun the story by claiming that he was banned by the reasons suggested by Gamaliel (<https://web.archive.org/web/20150718221130/http://matthewhopkinsnews.com/?p=1962>) . Being banned for threats of "negative media scrutiny" and for suggesting a fun, little "satirical animated GIF" contest sounds a long better to Gamergate drones than "veiled (very thinly) threats to out others". Floquenbeam and his stated reasons for the ban aren't even mentioned in Vordrak's blog entry.

The original version of Vordrak's blog entry (<https://web.archive.org/web/20150718221130/http://matthewhopkinsnews.com/?p=1962>) concluded with the following:

*I am now free to name Wikipedia editors where there is public interest and / or to take legal action if I wish.*

*Starting by naming Gamaliel. Watch this space.*

*—Vordrak telling Wikipedia, "I told it would be unwise to cast me out. Waahhh."*  
*(<https://web.archive.org/web/20150718221130/http://matthewhopkinsnews.com/?p=1962>)*

Sorry, Vordrak, but ED been there and done that already.

Ultimately, Vordrak decided not to publish Gamaliel's dox (<http://matthewhopkinsnews.com/?p=1974>) and replaced the "Starting by naming..." line with a claim (<http://matthewhopkinsnews.com/?p=1962>) that Floquenbeam and the other Wikipedia sysops follow Gamaliel's every word, worship his every step, and savor his every breath.

## TheGGGreatWork

In June 2015, Vordrak and AmethyGloriCorn created a subreddit called TheGGGreatWork ([http://www.reddit.com/r/TheGGGreatWork/comments/3a7ybu/introduction\\_to\\_the\\_great\\_work/](http://www.reddit.com/r/TheGGGreatWork/comments/3a7ybu/introduction_to_the_great_work/)) in order to encourage and coordinate the countering of alleged SJW infiltration within Wikipedia. They encouraged users to be patient and build "Wikipedia Capital" by giving each other Barnstars and engaging in RecentChanges and anti-vandalism paroling.

In July, after Vordrak's ban from Wikipedia, Vordrak's partner in crime AmethyGloriCorn announced a new approach to influencing Wikipedia ([http://www.reddit.com/r/TheGGGreatWork/comments/3exn2c/introduction\\_to\\_the\\_great\\_work\\_revised/](http://www.reddit.com/r/TheGGGreatWork/comments/3exn2c/introduction_to_the_great_work_revised/)) :

*The only way to achieve justice on Wikipedia is to achieve power on Wikipedia and that means we need our members to achieve administratorship. On Wikipedia that is relatively easy as there is an elected system called RFA. We therefore advise editors to build up edits in non-contentious areas and complete RFA before going anywhere near GamerGate or related topics. Edit articles about water gardens. Sprockets. Anything but GG. Water gardens are cool.*

In other words, AmethyGloriCorn is asking for willing Manchurian Candidates to infiltrate Wikipedia, hide their true agenda, and then when the time is right, dupe naive voters who aren't aware of their hidden motives into voting for them.

When AmethyGloriCorn shared his or her plan on KotakuInAction ([http://www.reddit.com/r/KotakuInAction/comments/3exr2i/dramapedia\\_goals\\_the\\_great\\_work\\_has\\_a\\_change\\_of/](http://www.reddit.com/r/KotakuInAction/comments/3exr2i/dramapedia_goals_the_great_work_has_a_change_of/)) , Vordrak not only expressed his support but "better yet", also suggested obtaining sysops bits in order to "arbitrarily block" their opponents ([http://www.reddit.com/r/KotakuInAction/comments/3exr2i/dramapedia\\_goals\\_the\\_great\\_work\\_has\\_a\\_change\\_of/ctjfovr](http://www.reddit.com/r/KotakuInAction/comments/3exr2i/dramapedia_goals_the_great_work_has_a_change_of/ctjfovr)) :

*[O]n Wikipedia administrators are elected. Anyone can be put forward at any time for what is called RFA (requests for adminship). The 'community' votes. In reality about 100 people participate in most RFAs. If someone gets 80% + votes then bam! They are an admin.*

*KiA has nearly 48,000 members. You do the math. Instead of whining at administrators to deal with Bernstein, AmethyGloriCorn is proposing KiA members become administrators and deal with him and the article themselves.*

*Better yet, normally administrators cannot just arbitrarily block people but thanks to ArbCom imposed GamerGate discretionary sanctions they are allowed to [arbitrarily block people] in relation to GamerGate controversies. :) Furthermore there are already many calls for most of the anti-GG people.*

*One admin willing to shoulder some flack could block the entire aGG slate. And we do not anticipate there being just one. admin.*

In other words, Vordrak is asking for patient assassins to infiltrate Wikipedia, become sysops, and then stab unsuspecting ideological opponents in the back.

## Adam Roberts

In late July 2015, Vordrak attempted to pick a fight with ([https://www.reddit.com/r/KotakuInAction/comments/3flkxz/goal\\_guardian\\_runs\\_article\\_by\\_adam\\_roberts/](https://www.reddit.com/r/KotakuInAction/comments/3flkxz/goal_guardian_runs_article_by_adam_roberts/)) author Adam Roberts, going as far as butt into a conservation between Adam Roberts and Natascha de Waal (<http://archive.is/VliMX>) while promising to publish an exposé so shocking that it would prevent Adam Roberts from giving public speeches ever again. Yet nothing come of this. Vordrak has yet to publish any blog entries about Adam Roberts.

## Github

After making such bold talk about exposing Adam Roberts on his blog yet not actually doing it, Vordrak shifted gears again and found a target that would dominate Vordrak's attention for the next couple of weeks: Github and Todogroup's draft "Open Code of Conduct" (<http://todogroup.org/opencodeofconduct/>). Todogroup's "Open Code of Conduct" contains the following SJW self-righteous lunacy:

*Our open source community prioritizes marginalized people's safety over privileged people's comfort. We will not act on complaints regarding:*

- 'Reverse' -isms, including 'reverse racism,' 'reverse sexism,' and 'cisphobia'

The draft code divides communities to a first class ("marginalized people") to be prioritized and a second class ("privileged people") to be, well, *marginalized*.

The Code began sanely enough

(<https://github.com/todogroup/opencodeofconduct/commit/02f7253ef0b84e8a97bf6b5062c3dade252c3af0>) , but on June 22, 2015, "ammeep" appeared (<https://github.com/todogroup/opencodeofconduct/pull/8>) and sought to incorporate, word-for-word (<https://github.com/todogroup/opencodeofconduct/commit/45aa6da5e2b5fcbe6e1185ca05b1f75e141591558>) , the Geek Feminism Code of Conduct's "Definitions" section (<http://geekfeminism.org/about/code-of-conduct/>) , including the aforementioned controversial text, into the Open Code of Conduct. Fortunately, "caniszczyk" merged only a modest amount of ammeep's contributions into the master branch (<https://github.com/todogroup/opencodeofconduct/pull/8#issuecomment-117367373>).

On July July 20, ammeep made a second attempt (<https://github.com/todogroup/opencodeofconduct/pull/17>) to incorporate Geek Feminism Code of Conduct's "Definitions" section

(<https://github.com/todogroup/opencodeofconduct/commit/b00eff579ded8c76cee0d2cb6b5beed6e84258fb>) , and on the 29th, "Bkeepers" conceded to ammeep's demands

(<https://github.com/todogroup/opencodeofconduct/commit/10e57b28978a2bd1d63e8fc0f2b4c437f3619f69>).

Several days later, Vordrak picked up on this and send a draft copy of his exposé to Github for review. Github objected, claiming copyright violations and "actionable, factual misrepresentations" (<http://matthewhopkinsnews.com/?p=2055>) . Such vague legal threats from a popular website and business would unnerve most, but as a law student, Vordrak knew that Github was full of shit and proudly leveraged this fact. Vordrak published a blog entry (<http://matthewhopkinsnews.com/?p=2035>) filled with exclamations marks and **bold, green text** and bragged about how dumb Github staffers are for licensing their photos under Creative Commons open source licenses, and when Vordrak finally published his blog entry about the Open Code of Conduct (<http://matthewhopkinsnews.com/?p=2030>) , he devoted a few of its paragraphs to speaking about how inept Github's lawyers are and they forfeited the ability to gain money from suing Vordrak when they decided to not take Vordrak seriously and to not reply back.

Now, onto that blog entry (<http://matthewhopkinsnews.com/?p=2030>) , which Vordrak advertised on Twitter as "[Does Github believe that it's] Ok to Harass White Women?" (<http://archive.is/PUmG>) Sensationalism sells, and Vordrak knows it. Although "reverse racism / sexism / whatnot" usually takes the form of affirmative action critique (i.e. "X got the job instead of me because of his race / sex" ([https://twitter.com/\\_peppercats/status/628409014993481730](https://twitter.com/_peppercats/status/628409014993481730))) , Vordrak marketed "reverse racism" as "[permissible] to harass white women".

On August 10th, ammeep's fiancé "martin308" challenged Vordrak via Twitter

(<https://twitter.com/martin308/status/630895334294601728>) , claiming that Vordrak had his name wrong. Vordrak revised his article (<http://archive.is/1biNs>) but warned martin308 not to mess to him (<http://archive.is/CADoN>).

## Beef with Kiwi Farms

Starting on April 16th, 2016 Vordrak began writing daily articles on Null and the Kiwi Farms. The first article cites the Encyclopedia Dramatica pages as irrefutable evidence that the site admin rapes and murders children and animals (<https://archive.is/tj4ZY>) on a daily basis and uses the Kiwi Farms to do so. His interest was turned to the Kiwi Farms because of a thread on him (<https://kiwifar.ms/threads/vordrak-samuel-collingwood-smith-matthew-hopkins.16771/>) , but did not start writing hit pieces until the site started running a GamerGate parody forum (<https://kiwifar.ms/forums/official-gamergate-hq.68/>) that hurt GG's stellar public image and caused KotakuInAction to shit their pants. Not wanting GamerGate to pick up the reputation of being about harassment, Vordrak began harassing everyone Null's family (<https://archive.is/gvpNi#selection-249.0-252.0>) and everyone he had ever met (<https://archive.is/QR5nW#selection-319.0-322.0>) and promised to do so as long as the Kiwi Farms stayed up (<https://archive.is/hx4NZ#selection-351.0-354.0>) . Thanks to his efforts, GamerGate's reputation was saved and now there are #EthicsInVideoGameJournalism.

Some retard on Kiwi Farms's wiki also 'wrote' an article ([https://lolcow.wiki/wiki/Samuel\\_Collingwood\\_Smith](https://lolcow.wiki/wiki/Samuel_Collingwood_Smith)) on Samuel's adventures, but for some reason no search engine will deliver it as a result. They will show Kiwi Farms pages and other Lolcow Wiki articles that are direct copies of the same page, but not the actual article. Surely this is a coincidence and not the result of Vordrak chimping out and crying to Jewgle about google bombing. Considering he does it to other people he's never met and brags about it (<https://archive.is/F8KcE>) , that would make him a hypocrite, which is impossible as we know Samuel Collingwood Smith is a righteous moral authority and unbiased judicator.





FIRST WITNESS STATEMENT  
OF SAMUEL COLLINGWOOD SMITH  
AND GROUNDS FOR APPLICATION

---

1. I, Samuel Collingwood Smith of 11 By the Mount, Welwyn Garden City, Hertfordshire, AL7 3SY am the Claimant in these proceedings and I shall say as follows -
2. Where I make statements of fact, except as otherwise stated, these are from my first hand knowledge and belief. It is important to read the Particulars of Claim first.

**Service Without Notice and Out of the Jurisdiction**

3. This part of the application is made without notice per the rules under CPR 6.15 (3) (b).

4. I do not have the Defendants' real identities or addresses and so propose to serve them online, with the Court's permission.
5. If any are outside the jurisdiction, I must meet the criteria (gateways) set out in PD 6 3.1, I rely on PD 6 3.1 (2) (A claim is made for an injunction(GL) ordering the defendant to do or refrain from doing an act within the jurisdiction.) and (9) (a tort has been committed and damage will be sustained within the jurisdiction).
6. The Defendants in these proceedings deliberately obscure their identities and have refused to identify themselves. I have seen web pages and articles that suggest they are split between the United States, Australia and Europe. It may therefore be that some reside in this country.
7. I understand that a reason the Defendants obscure their identities is because of previous complaints and litigation causing the site to be taken down. A previous UK based administrator Ryan Cleary was also arrested and charged with hacking offences.
8. I have not been able to identify the operators of Encyclopedia Dramatica. Some opposing websites suggest it is a Serbian man called Sibin Grašić and / or an American Brian Richard Zaiger of the United States. The Encyclopedia Dramatica website claims that Zaiger has retired. I eventually spoke to him IRC and he confirmed this is his story. I cannot confirm he or the other man is the administrator. He ignored my request to tell me who does run the website.
9. I cannot find any information at all about KiwiDynastia's identity. There have been several trolling posts and an email sent to me by persons claiming to be sources after I wrote articles about him, but the identities given upon investigation are false and usually vulnerable members of ethnic minorities. He may live in the UK but I cannot confirm this.
10. I believe that LikeICare may be an Australian man called Christopher Peter Jones but I have not been able to confirm this.
11. In *Sloutsker v Romanova [2015] EWHC 545 (QB)*, Warby J said at 69, "*The graver the imputation the more likely it is to spread, and to cause serious harm. It is beyond dispute that the imputations complained of are all extremely serious.*"
12. Self-evidently in this case the allegations could not be more serious.

#### **Interim Injunction in Defamation**

13. This application is also made without notice per CPR 25.3(1), if there is 'good reason'. These criteria are further expanded by the well known rule in *Re First Express Ltd [1991] BCC 782* that,

14. *"Giving notice is likely to cause the applicant injustice through delay or action that the respondent or others may take before the order can be made."*
15. The Defendants' actions are likely to cause severe injustice by making it harder for me to find work as an IT contractor and they are the cause of any delay giving notice by actively obstructing it by anonymising themselves and banning me from their main site.
16. The second criteria as set out at in First Express is, *"If so, any damage suffered by the respondent as a result of complying with the order may be compensated by the applicant's undertaking in damages [...] or the risk of the respondent suffering uncompensatable loss is outweighed by the risk of injustice to the applicant if the order is not made."*
17. I believe the latter criteria applies, fairly obviously, from the evidence.
18. If so, any damage suffered by the respondent as a result of complying with the order may be compensated by the applicant's undertaking in damages (see below); or the risk of the respondent suffering uncompensatable loss is outweighed by the risk of injustice to the applicant if the order is not made.
19. Turning to an interim injunction the rule in law is strict. In defamation, as per Bonnard v Perryman, one can only obtain interim relief if the claim is bound to succeed or truth is not alleged, *"Although the courts possessed a jurisdiction, 'in all but exceptional cases', they should not issue an interlocutory injunction to restrain the publication of a libel which the defence sought to justify except where it was clear that that defence would fail. Where the defendant contends that the words complained of are true and swears that he will plead and seek to prove the defence of justification, the court should not grant an interlocutory injunction unless, exceptionally, it is satisfied that the defence is one which cannot succeed. The plaintiff must demonstrate that 'it is clear that (the) alleged libel is untrue'"*.
20. Clearly this is such a case because I am neither convicted nor (as far as I am aware) under investigation for any such crimes. The Defendants have not indicated justification, per the pleadings their response to a letter of claim posted under their procedures was 'fuck off'.
21. The relief sought is not moot. It does not matter if the Defendants prove to be in many jurisdictions or initial ignore an injunction because if interim relief is granted companies such as Google will de-index the site per their policies.
22. This in turn will likely encourage the Defendants to remove the statements complained of.
23. I would also rely on the balance of the parties' rights under the Human Rights Act 1998. Specifically, the publication of lurid and baseless allegations that I am a

paedophile endanger my article 8 rights to a family life and to employment. They could put me at risk of violence and permanent physical harm. Set against that is the right of a satirical website known for contentious statements and arrests.

24. If it is necessary that I give a cross-undertaking in damages, I give it.

**Duty of Candour**

25. The website owners are likely to argue that they are out of the jurisdiction. One Bureaucrat, 'Mantequilla', has said they are not in Britain or the US. However, they have not said what jurisdiction they are in and inquiries to several staff have not received a response.
26. The website owners may argue their article is satire of my own work and their website has a disclaimer that it is satire. I have written articles accusing people of paedophilia, usually after they have boasted of it or been convicted.
27. I am very careful to check my facts, and usually link archived logs or similar. The court will need to decide whether it is clear the page is satire, having regard to my evidence that they usually phrase real allegations of wrongdoing in the same terms.
28. There was, as I say at paragraph 22 of the Particulars, a mistake in the letter of claim. It is not generally permitted to issue a claim for one amount and then increase it later, which could be an abuse. However as per the particulars this has been corrected pre-issue.
