PRIVACY NOTICE

This privacy notice sets out how we handle your personal information when you register on kyc.kycwowoo.com

Please read this notice carefully before you register and access our services, and check back regularly to review updated versions on this page to ensure that you stay aware of what information we collect, how we use it and how we might share it.

1. Who are we?

We are Wowoo Pte ("we", "us", "our"), a Singapore limited company, Our registered office is Ltd. Singapore #10-179 UNION BUILDING, 171 TRAS STREET, SINGAPORE 079025

2. What information do we collect from you, and why?

When you register an account with the kyc.kycwowoo.com website we collect:

- your name
- your date of birth
- your contact details such as your home address, email address and telephone number
- Digital identifying information sent by your mobile, computer or access device including but not limited to IP address and web log information.
- blockchain identifiers, such as blockchain addresses and public keys.
- your public key for any wowoo tokens, that will be used to verified your identity
- your government issued identity documents such as a passport or driving licence and audio/visual recording of an interview with you
- your password we will encrypt it before storing it

We may also ask you for other information or documents such as biometric information, proof of address and/or information about your finances/financial arrangements, either to verify your identify or to comply with our anti-money laundering obligations.

We use this information to:

- to carry out our obligations arising from any contracts entered into between you and us and to provide you with the information, products and services that you request from us
- To ensure accuracy and completeness of data collected as required by regulation.
- make sure that you are a real person and that you are who you say you are, including by verifying it with data verification/credit reference agencies. This check leaves a footprint on your credit file which will reference an identity check by us, but will not affect your credit score. If we are not able to verify your identity, then we will not be able to register your public key, or maintain that registration

- comply with our legal or regulatory obligations, including to (1) make sure that you
 are not exchanging money or assets that were obtained unlawfully for money or other
 assets that are 'clean' (i.e. money laundering), or (2) funding terrorism or other
 criminal activity. If we have suspicions about your source of funds, then we will not be
 able to register your public key, or maintain that registration
- communicate with you about our goods and services
- provide you with information about other goods and services we offer that are similar to those that you have already purchased or enquired about
- provide you with information about goods or services we feel may interest you
- notify you about changes to our service
- ensure that content from our website is presented in the most effective manner for you and for your computer
- to assess, maintain, upgrade and improve our products and services
- to carry out education and training programs for our staff
- to manage and resolve any legal or commercial complaints or issues

When you use our website and/or access or use any of the Services that we provide through the kyc.kycwowoo.com, we automatically collect:

- technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform
- information about your visit, including the full Uniform Resource Locators (URL), clickstream to, through and from our site (including date and time), page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), methods used to browse away from the page, and any phone number used to call our customer service number

We use this information to:

- administer our website, the Services that we provide in connection with the kyc.kycwowoo.com and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes
- improve our website and the Services that we provide in connection with thekyc.kycwowoo.com to ensure that content is presented in the most effective manner for you and for your computer
- to keep our website and the Services that we provide in connection with the Kyc.kycwowoo.com safe and secure

We use this information by:

• combining it with information you give to us and information we collect about you for the purposes set out above.

Who do we share your personal information with?

- our staff who need the information to perform their duties
- other businesses, suppliers and sub-contractors who have a contract with us to provide us with services. Those suppliers include credit reference/data verification agencies and forensic AML analytics service providers
- appropriate authorities if we suspect that a registration involves any form of criminality, including identity theft or money laundering
- fraud prevention agencies if we determine that there has been fraud which meets the reporting criteria
- law enforcement or other official authority if we think it is the right thing to do, or we receive a court order requiring us to disclose it
- another business if we buy/sell any business or assets from/to them, or are otherwise combined with that business (including during any negotiations with them)
- third parties if we are under a duty to disclose or share your personal information with them in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements; or to protect the rights, property, or safety of us, registered token holders, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction
- advertisers and advertising networks that require the information to select and serve relevant adverts to you and others. We do not disclose information about identifiable individuals to our advertisers, but we will provide them with aggregate information about our users (for example, we may inform them that 500 men aged under 30 have clicked on their advertisement on any given day). We may also use such aggregate information to help advertisers reach the kind of audience they want to target (for example, women in a particular geographic area). We may make use of the personal data we have collected from you to enable us to comply with our advertisers' wishes by displaying their advertisement to that target audience
- analytics and search engine providers that assist us in the improvement and optimisation of our website

Where do we keep your personal information?

We will send your personal information to, and store it in, countries outside the of Singapore. If we send your personal information to other countries which are outside of Singapore, We ensure that the countries have equivalent standard of protection as that under PDPA or that third party contractors are held to the same standard by contract.

By seeking to register your public key for Wowoo tokens with us, you agree to us sending your personal information to, and processing it outside of Singapore

Data security is of great importance to us, and to protect your data We have put in place suitable physical, electronic and managerial procedures to safeguard and secure data collected through our site.

What are your rights?

You have the right to

- ask us to stop using your personal data, including for marketing purposes
- access information we hold about you
- ask us to correct information we hold about you that is inaccurate
- ask us to delete information we hold about you

If you withdraw your consent to use your information we will no longer be able to provide services. We will cease collecting, using or disclosing your information unless required to do so by law.
