

Goa Dairy Operations for Procurement and Supply of Milk

Milk Being an essential commodity is exempted from the operations of the Total Lockdown

I) Collection and Procurement of milk from the societies

1. The Goa dairy has 178 primary dairy cooperative societies functioning as collection points where Farmers will pour milk at the Primary Dairy cooperative society located in different villages in the State.
2. Goa dairy has installed 28 Bulk Chilling machines in some of these Primary dairy cooperative societies where a portion of the daily collection approx. 50000 litres can be stored for a short duration of 48 hours.
3. Milk collected at the Primary Dairy cooperative society is brought to the Goa Dairy Milk Processing plant at CurtiPonda Goa through 37 Tempo vehicles and three milk tankers (contracted)

A little quantity of milk around 10000 to 15000 litres per day is required to be procured from outside the state to cover up the deficit of milk

II) Processing of Milk at the Milk Processing Plant

Dairy processing plant works in two shifts Morning and Night and requires a total of 45 workers, 26 operators and total 71 staff in two different shifts besides the security staff on round the clock basis.

III) Supply and Marketing of the Processed and packed milk

Goa dairy has a marketing chain as below

- a) 36 Route suppliers and 37 vehicles to supply milk
- b) A total of 548 milk selling points which are operational in the shops
- c) A total of 130 milk booths provided by the Goa Dairy
- d) 2 milk parlors

Milk is transported in the milk vans 37 in nos. from the Dairy dispatch dock to the Selling points through the Route suppliers on cash sales basis the route suppliers on their return journey collect the cash and crates and deposit it with Goa Dairy.

IV) Cattle feed Plant and Cattle feed supply

The Goa dairy also operates a cattle feed plant at Marvasada Ponda Goa. An average 1300 MT of Cattle feed is required to be produced to be supplied to the

farmers on monthly basis. The Supply is done by Goa Dairy through the Primary Dairy Cooperative societies to the Dairy Farmers. All the Raw materials for the production of the Cattle feed is required to be brought from outside of the State.

V)Exemption needed:

- a) **Farmers be allowed to pour milk at the Primary Dairy Cooperative Society maintaining the social distancing in a hygienic manner at the milk collection centers in villages.**
- b) **Travel Permits for Vehicles (37 Tempo vehicles and three milk tankers) all contracted, be permitted to carry milk from these Primary dairy cooperative societies to the Goa Dairy Milk Processing plant.**
- c) **Permission for getting milk around One tanker per day (approx... 12000 liters) from outside the state**
- d) **Permits needed for the staff to come from Home to the Dairy Plant/ cattle feed plant and back.**
- e) **Travel permit for the Route suppliers and their vehicles total 37 vehicles.**
- f) **Permits for the booths to sell milk.**
- g) **Travel permits for the delivery system under the booths**
- h) **Permits for the incoming vehicles and Raw materials for the Cattle feed plant (Interstate)**
- i) **Permits for the Goa dairyvehicles supply of Cattle feed**

VI) Proposed delivery system

- A) Milk will be made available through the Milk Booths and Milk outlets authorized by Goa Dairy on a Call centre basis. The details of the Call centres and their mobile numbers are specified area wise. The Milk Booths and the Milk Outlets will deliver the Milk packets through Home delivery system by putting 2-3 authorized delivery boys. The Milk Booths and the Milk Outlets may charge a service fee/ delivery fee in addition to the milk price as such the maximum price of the Milk packets is also mentioned in the list.

B) Cattle feed will be supplied by Goa Dairy Vehicles through the Primary Dairy Cooperative Societies against the demands received from the Farmers by the Primary Dairy Cooperative societies.
