

Using the NEWS observation chart

The NEWS chart should replace currently used TPR charts. This would provide a standardised system for recording routine clinical data for all clients.

This consistent format, if used in all care settings, would provide familiarity in recognition of patient data and facilitate training in the measurement and recording of such data in a systematic and standardised way by all carers.

The NEWS chart contains dedicated sections to record the frequency of monitoring as defined by the score and the clinical response to a change in score, eg an escalation in acute care – this will facilitate tracking of the response to changes in the NEW score.

The NEWS chart also contains dedicated sections to record urine output and pain severity. These do not form part of the NEW score.

Please note that when the measured physiological parameter exceeds the range on the chart, the actual value should be recorded on the chart.

Please also note that the NEWS is not designed to replace recognised generic scoring systems such as the GCS or disease-specific systems.
