As part of our search for truth as to why Breonna was killed, it's our pledge to her family and our legal obligation to work diligently to find out the whole story. This starts with why an unlawful search warrant was issued and goes all the way through the reasons why there has been no transparency since Breonna's death. The road to get this information has been incredibly difficult. It remains ongoing and has been frustrated by the lack of release of the police file.

Our original lawsuit alleges information which we believed, based upon everything available to us at the time, set forth the basis for liability against the police officers. We have learned much more since that time, prompting us to amend the lawsuit and both add the additional information which we have learned and correct anything which now appears to be inconsistent with newer evidence. For example, our original lawsuit alleged that the officers did not knock or announce prior to entry. There were supporting witnesses who did not hear knocking and only heard gunshots. Now that we have listened to Kenneth's statement, spoken with more witnesses and conducted a further investigation, we are able to assert that there was knocking and no announcing (which is even more dangerous than not knocking or announcing and just making entry).

Also in the amended complaint is a chronological timeline which we believe, based upon the evidence available to date, sets forth the numerous egregious actions that culminated in the unlawful killing of Breonna. The timeline involves much more than a real estate development project. That's just the start.

Indeed, our investigation has presented credible evidence that a police unit was formed to focus exclusively on Elliott Avenue to clean out an area planned for a showcase development that is quietly is in the works. Our issue is not with the revitalization of west Louisville. That is long overdue and needs to happen. The issue is the quiet nature of this police unit formation, the tactics used to try and clean house on Elliott and the absurd and outrageous decision to put the life of Breonna Taylor, who lived in south Louisville, in the mix and in danger. This never should have happened.

This police unit, under direction of those all the way up the chain, engaged in targeted policing, high tech surveillance of Elliott (the camera was quietly removed just days after Breonna's killing), harassment and desperate measures to get people out

measures to get people out.

When these methods didn't work, the result was five no knock warrants designed to get occupants out of a single house on Elliott. These were the first five no knocks of the year; all of them went after residents of a home which was, at most, a low level trap house (when Breonna's death was swept under the rug, a sixth no-knock was executed on the same house a month later. All six no knocks this year targeted the occupants of the same place.) Notably, while the police unit had a stated purpose of targeting Louisville's most violent criminals, these targets had no history of violent crime. And one of them happened to be Breonna Taylor's ex-boyfriend.

On March 12, the assigned officers made error after error. First, the evidence shows that the plan was to never hit Breonna's house. It was just a backup, based on stale intelligence, in case one of the targets was there. They were not and there was no reason to think they were. It is important to note that all officers involved were given pictures of the five targets for the warrants. Breonna's was NOT one of them. When bad intelligence led officers to inaccurately believe that the ex-boyfriend was at Breonna's house, the reckless decision to call on the warrant for her house was made. But when surveillance eventually located the target in a completely different part of town, the evidence reflects that the warrant was called off. More than 70 Impd members, including a fully militarized swat unit, were directed by an on-scene LMPD deputy chief to hit the Elliott houses. The ex-boyfriend was there and arrested. But two other targets, with no relation to Breonna, were not there. So the evidence shows another reckless decision was made again to hit Breonna's house. No real planning was done; they had no idea that the back of Breonna's building was an entirely separate apartment. They didn't know there's not a rear exit. They didn't know that Breonna had driven a new car for two months and that the car was totally different than the one on the warrant. They didn't know who Kenneth Walker was, even though he'd been with Breonna nearly everyday and had been at her home four days in a row. They didn't know Breonna's 20 year sister lived with her (thankfully she was on vacation) in a room that they eventually shot up blindly. They didn't know that a two year old child routinely spent the night there. The evidence reflects that the officers believed two men were in the home. They'd called off the ambulance earlier and didn't call it back for staging.

The death certificate shows Breonna survived for at least five minutes after being shot. Kenny's statement reflects the same. They made no efforts to try and save her. They reported no body camera footage existed from the shooting officers, but also didn't acknowledge that other others assigned to Breonna's home (there were way more than just three people there) who do wear body cameras. They won't discuss body camera footage existence or produce surveillance camera footage from Elliott. They won't reveal the officer who came up to Kenneth after the shooting, but before he was taken to PIU, and in the presence of other officers told him that there was a big misunderstanding. They didn't tell us that their actual target was sitting right at the home of the fifth warrant, which was also being watched by Impd officers; he could have been easily apprehended there with any decent intelligence and if the correct location was hit. They didn't tell us that misrepresentations were made and stale information was used to get a warrant for Breonna's home in the first place. She was not a drug dealer, not a drug user and not a part of any sort of drug ring.

So there you have it. That's what we believe the evidence will prove at this stage. There's always two sides to a story, but ours is grounded in evidence which we believe to be true. This issue is way more than a development project and a police unit formed to focus entirely on one street when the project needed to proceed with haste. The real issue is a series of catastrophic failures on the night of March 12. If any one of them doesn't happen, Breonna is at the hospital today fighting coronavirus and making those around her smile.

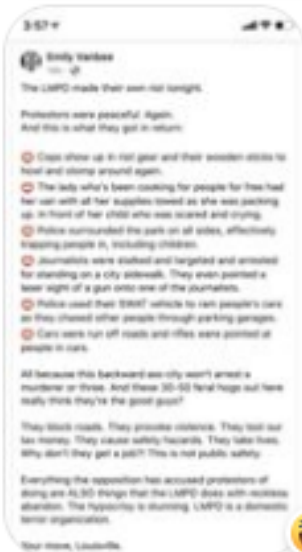

Dear Detective Hankison:

Please be advised of my present intention to terminate your employment with the Louisville Metro Police Department. However, on [REDACTED] you will have an opportunity, with counsel or union representation, if you desire, to provide me with additional information or mitigating factors. I intend to take this action based upon my review of the Public Integrity Unit investigation file, which was initiated on March 13, 2020. The investigation conducted by the Louisville Metro Police Department's Public Integrity Unit was provided to me on Tuesday evening, June 16, 2020 for review. The following is the result of my subsequent review:

Violations of:  
Standard Operating Procedure 5.1.2 Obedience to Rules and Regulations (4 counts) -Sustained  
Standard Operating Procedure 9.1.12 Use of Deadly Force (10 counts) -Sustained

I have determined you violated Standard Operating Procedure 5.1.2 Obedience to Rules and Regulations when your actions displayed an extreme indifference to the value of human life when you wantonly and blindly fired ten (10) rounds into the apartment of Breonna Taylor on March 13, 2020. These rounds created a substantial danger of death and serious injury to Breonna Taylor and the three occupants of the apartment next to Mr. Taylor's. I make my determination pursuant to the preponderance of the evidence.

You further failed to be cognizant of the direction in which your firearm was discharged. Some of the rounds you fired actually traveled into the apartment next to Mr. Taylor's endangering the three lives in that apartment. You have previously been disciplined for reckless conduct that injured a innocent person in Professional Standards Case #17-062 for which you were disciplined on January 9, 2019.

Based upon my review, these are extreme violations of our policies. I find your conduct a shock to the conscience. I am alarmed and stunned you used deadly force in this fashion. You have never been trained by the Louisville Metro Police Department to use deadly force in this fashion. Your actions have brought discredit upon yourself and the Department. Your conduct has severely damaged the image of our Department we have established with our community. The result of your actions seriously impedes the Department's goal of providing the citizens of our city with the most professional law enforcement agency possible. I cannot tolerate this type of conduct by any member of the Louisville Metro Police Department. Your conduct demands your termination. I have the utmost confidence in my decision to terminate your employment for the best interest for the Louisville Metro Police Department and our community.

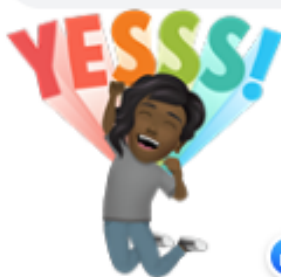

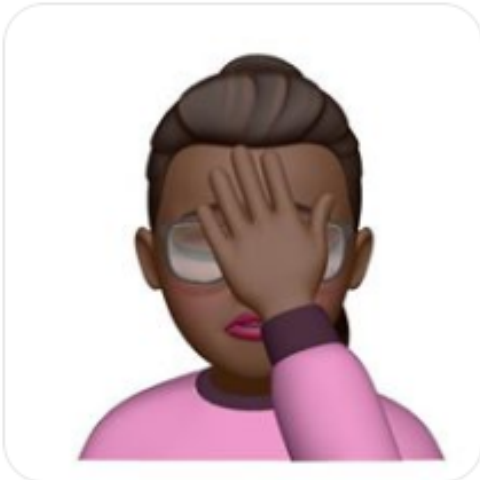

Firing an officer and citizen complaints:

KRS 67C.321 specifically gives the Chief full discretion to suspend, lay off or fire an officer "to promote the efficiency of the services." Chief simply needs to send a letter stating the grounds (such as murder, wanton endangerment, leaving the scene of an active investigation, knowingly conspiring to execute a bad warrant, destroying evidence, sexual assault, etc.)

Then the officer has due process rights pursuant to the statutory bill of rights and FOP contract. Per statute, he or she is afforded a hearing within 60 days to the merit board to present his or her case and seek reinstatement. This is a hearing open to the public and I'm sure the public would appreciate seeing the case be made. Per FOP contract, officer must appeal the discipline. Either way, a hearing is the ultimate result. If the merit board says still fired, the officer then may go to the circuit court system.

Nothing stops LMPD from doing PSU investigation concurrent with criminal investigation. Their choice to not do so is nonsense.

David Mour Sam Aguiar I just reviewed the Collective Bargaining Agreement between the LMPD FOP Lodge and Metro Government. Here is an excerpt:

Article 17, Section 2L:

If a police officer is under arrest, or likely to be arrested, or a suspect in a criminal investigation, he shall be afforded the same constitutional due process rights that are accorded to any civilian, including, but not limited to, the right to remain silent and the right to counsel, and shall be notified of those rights before any questioning commences. NOTHING IN THIS SECTION SHALL PREVENT THE SUSPENSION WITH OR WITHOUT PAY OR REASSIGNMENT OF THE POLICE OFFICER PENDING DISPOSITION OF THE CHARGES.

(I added the all caps)

I am also very familiar with KRS 15.520, aka the Police Officer Bill of Rights which is essentially incorporated into Section 17 above, including the language which allows a police officer to be suspended with or without pay.

So last week I stood and watched the Mayor say he legally could not suspend these officers. Unless I am missing something, and if I am, by all means, speak up, lawyers in particular, the Mayor was not being honest with this community. The families of Breonna Taylor, David McAtee and countless others before them and this community, in particular the African American community, have a right have immediate action taken against these officers. If the Mayor wishes to restore any shred of confidence in local government (it may be too late for LMPD; absent a complete restructuring and the departure of many from top to bottom, very few in this community trust LMPD or give the department and it's officers any credibility) he must act now. Whether it's true or not, given the recent history of LMPD, it appears a cover-up is in the works— an incident report months after Miss Taylor's killing stating "no injury"— which is outrageous.

I also heard the Mayor elaborate that he was afraid to "fire" these officers because they would sue, get their jobs back and get damages and cost the City money. Well maybe they will and maybe they won't. Point is, the Mayor has allowed LMPD to wreak havoc on the citizens of our community— mostly the African American community— for years, e.g., Molestation (and cover up) of explorer scouts, racial profiling on traffic stops, no-knocks, no body cams or no footage, killing of innocent citizens (mostly black) etc., the list goes on. I am certain most of the victims of this police inflicted mayhem are suing or have sued Metro Government which is costing money as well. So once again, inequity.

Step up Mayor. You have said Black Lives Matter. No more words, this community demands action. Do your job. The three who needlessly took an innocent young woman's life and a fourth who it appears provided false information under oath in order to obtain the warrant must at the very least be suspended without pay. Maybe they later get their jobs back; so what, sometimes it's about what is right not dollars.

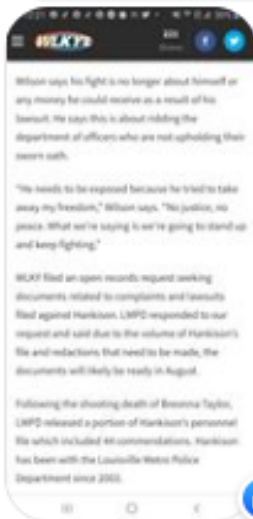

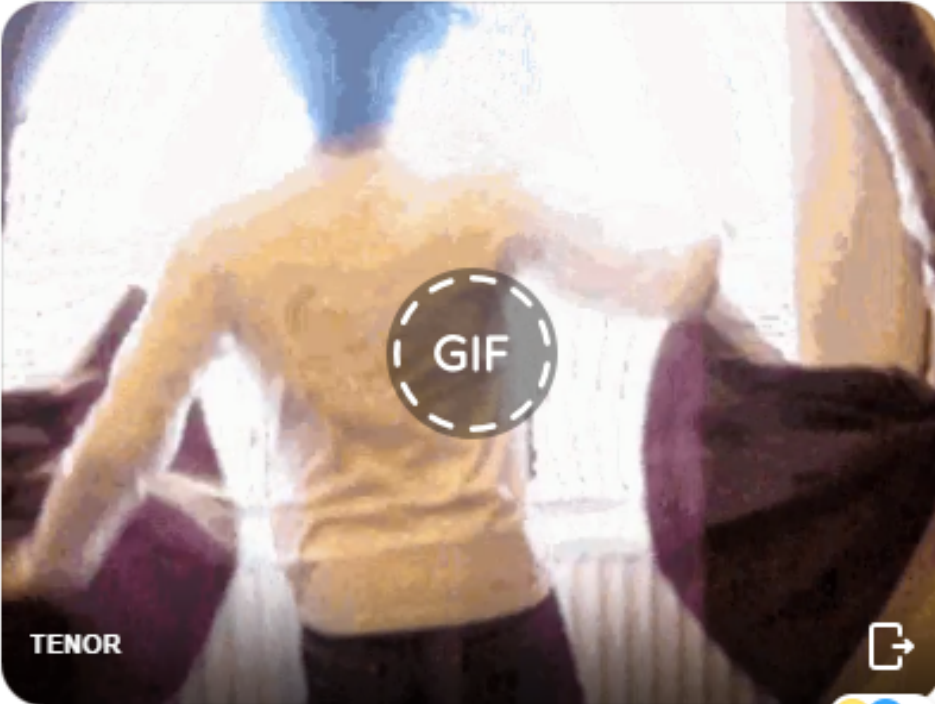

Brainstorming. Lots of people won't like. But straight shooting.

Fewer officers. But the best of the best. Make it easier to fire the bad apples. Clean house; bad ones have to go. 🗑️

But pay the officers who make the cut more money. Our officers really are paid shit (other than those abusing overtime). And you get what you pay for. Those who are the best are likely to leave for more money unless they stay out of loyalty. And the loyal officers doing everything right need to be paid better.

Smaller police force who appreciate better pay, who are the best of the best and who know there is zero tolerance for corruption.

Zero tolerance policy for certain offenses AND the same discipline imposed upon officers who knowingly withhold the wrongdoings as those who commit the wrongdoings.

Take an internal stance to stop warrants and aggressive investigative actions over marijuana. Way too many warrants i am seeing where the only intelligence is marijuana and the only thing found is a marijuana roach or NOTHING. Do we really need 10 officers raiding a home on that intelligence? Waste of resources. Unnecessary incurrence of risks to citizens and officers.

Take away an officer's authority to swear out a warrant if they keep coming up dry.

Do more airport interdiction work if you want to get bigger fish. That's where large amounts of drugs are found. 🐟

Disband pointless units and make certain units, like narcotics, smaller.

Stop assigning seized vehicles to officers. Stop making civil asset forfeiture a bargaining chip for plea deals.

Report the amount of money seized on the execution form. "Unknown amount" is not good for public trust.

Require judges to initial all pages of the warrants and affidavits and for the warrant and affidavit to be filed under seal before it is executed and for it to be unsealed after execution. 🗂️

Require a commanding officer to also swear out a narcotics warrant affidavit (or at least sign off on it on every page before it is presented to a judge).

Require random drug and alcohol testing twice a year. Make the failed results public and fire immediately.

Suspend versus reassign. Reassign sounds like they have easy desk duty. Or a paid vacation. Suspend without pay when there is reasonable evidence of wrongdoing and suck it up and pay the backpay if you're wrong.

Assign officers to their own communities. Incentivize them to live in those communities. Atlanta is a great model for that. Stop appointing PTO's (training officers) who have a history of frequent allegations and policy violations.

Make internal affairs a real internal affairs department composed of direct hires who have not worked side by side with the police for years. Officers and internal affairs should not be friends. Make all closed internal affairs files available online. Do not destroy closed complaints from personnel files.

Assign a dedicated prosecution team for cases involving allegations of officer criminal acts.

Require KSP to work with internal affairs on officer involved cases involving death, sexual assault or officer discharge of a firearm. [\[...\]](#)

Give subpoena power to citizen review boards.

Firing an officer and citizen complaints:

Ok, so here's the deal. There's all kinds of information floating around and most of it is nowhere close to true. An officer can be fired without these six layers of delays that keep being brought up. All of that is nonsense. KRS 67C.321 specifically gives the Chief full discretion to suspend, lay off or fire an officer "to promote the efficiency of the services." Chief simply needs to send a letter stating the grounds (such as murder, wanton endangerment, leaving the scene of an active investigation, knowingly conspiring to execute a bad warrant, destroying evidence, sexual assault, etc.)

Then the officer has due process rights pursuant to the statutory bill of rights and FOP contract. Per statute, he or she is afforded a hearing within 60 days to the merit board to present his or her case and seek reinstatement. This is a hearing open to the public and I'm sure the public would appreciate seeing the case be made. Per FOP contract, officer must appeal the discipline. Either way, a hearing is the ultimate result. If the merit board says still fired, the officer then may go to the circuit court system.

Nothing stops LMPD from doing PSU investigation concurrent with criminal investigation. Their choice to not do so is nonsense.

Maybe the most ridiculous and terrible agreement that needs to be changed by statute: the city agreed in the FOP contract to DESTROY citizen complaint forms in NINETY days from receipt of the complaint if the chief does not initiate an investigation. Disappears from the record completely and never goes into the personnel file. So wait and see: years of sexual assault, theft, planting drugs and use of force complaints will be gone. This needs to change. All of this needs to change.

- viii. **If the complainant declines to file a formal complaint under oath, the PSU shall do one of the following:**
- a) Complete a complaint inquiry form and forward to the Chief's Office if the allegations involve criminal activity.
  - b) Complete a complaint inquiry form if there is information independent of that obtained from the citizen substantiating the allegations of misconduct.
  - c) Handle the complaint in an informal manner. In these cases, no investigative paperwork is entered into a Member's personnel file.
- ix. The complaint inquiry form shall be maintained solely and exclusively by the PSU. The contents of this information shall be transmitted to the Chief or his designee for appropriate handling. **If the Chief or his designee directs an investigation, the procedures outlined in KRS 15.520 and this Agreement shall be followed. If no investigation is directed by the Chief or his designee, the complaint inquiry form shall be destroyed ninety (90) days after receipt.**

Friday would have been Breonna Taylor's 27th birthday. But the emergency room technician wasn't here to see it. But she's not here to celebrate, because shortly after midnight on March 13, Louisville police entered her apartment unannounced—and, after a brief confrontation with her boyfriend, shot her eight times. The officers have not been fired or charged.

Breonna was an award-winning EMT. Her mom says her daughter had plans to become a nurse, buy a house, and start a family. Now, she doesn't even get to celebrate her birthday.

In our fight to remind the world that Black Lives Matter, we need to remember those Black lives also include Black women. So on what would've been her 27th birthday today, let's speak her name: Breonna Taylor.

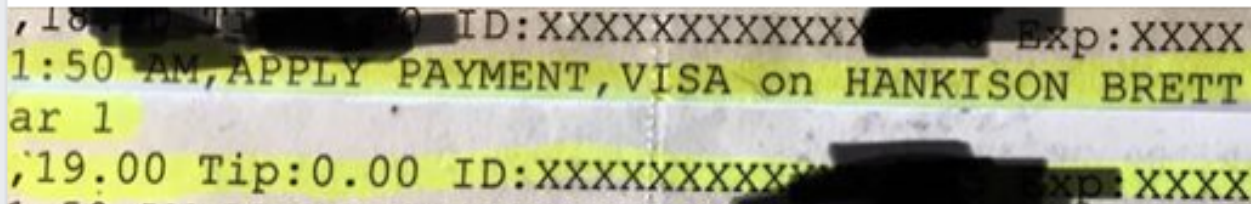

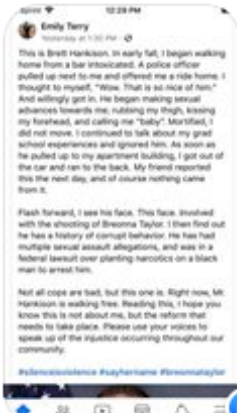

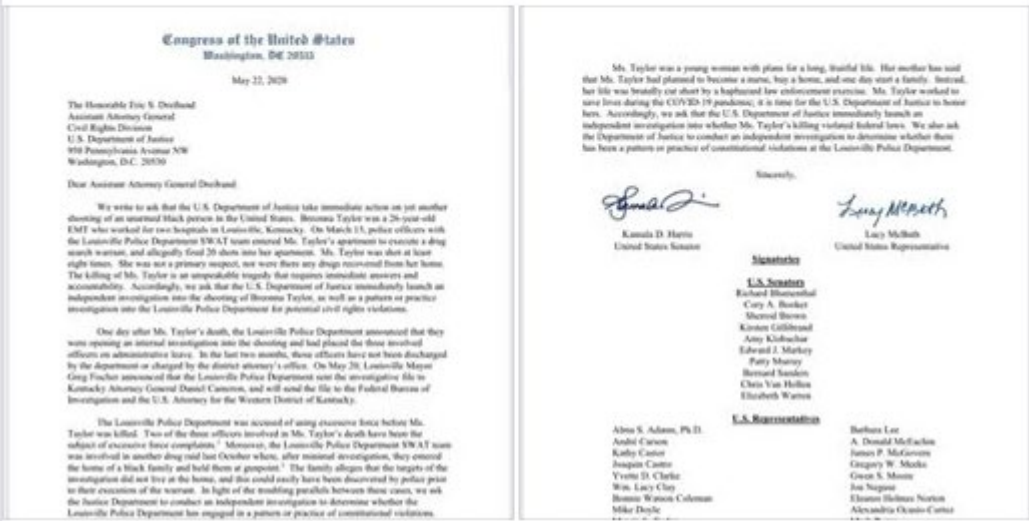

Dear Assistant Attorney General Dreiband:

We write to ask that the U.S. Department of Justice take immediate action on yet another shooting of an unarmed black person in the United States. Breonna Taylor was a 26-year-old EMT who worked for two hospitals in Louisville, Kentucky. On March 13, police officers with the Louisville Police Department SWAT team entered Ms. Taylor's apartment to execute a drug search warrant, and allegedly fired 20 shots into her apartment. Ms. Taylor was shot at least eight times. She was not a primary suspect, nor were there any drugs recovered from her home. The killing of Ms. Taylor is an unspeakable tragedy that requires immediate answers and accountability. Accordingly, we ask that the U.S. Department of Justice immediately launch an independent investigation into the shooting of Breonna Taylor, as well as a pattern or practice investigation into the Louisville Police Department for potential civil rights violations.

One day after Ms. Taylor's death, the Louisville Police Department announced that they were opening an internal investigation into the shooting and had placed the three involved officers on administrative leave. In the last two months, those officers have not been discharged by the department or charged by the district attorney's office. On May 20, Louisville Mayor Greg Fischer announced that the Louisville Police Department sent the investigative file to Kentucky Attorney General Daniel Cameron, and will send the file to the Federal Bureau of Investigation and the U.S. Attorney for the Western District of Kentucky.

The Louisville Police Department was accused of using excessive force before Ms. Taylor was killed. Two of the three officers involved in Ms. Taylor's death have been the subject of excessive force complaints.<sup>1</sup> Moreover, the Louisville Police Department SWAT team was involved in another drug raid last October where, after minimal investigation, they entered the home of a black family and held them at gunpoint.<sup>2</sup> The family alleges that the targets of the investigation did not live at the home, and this could easily have been discovered by police prior to their execution of the warrant. In light of the troubling parallels between these cases, we ask the Justice Department to conduct an independent investigation to determine whether the Louisville Police Department has engaged in a pattern or practice of constitutional violations.

In 2015, a UL doctoral student shadowed Impd narcotics detectives. Observed 73 search warrants executed. Wrote a dissertation on his observations. It's mind blowing. And the department obviously ignored it. Narcotics detectives NEVER knock and announce. Not a single time. They ram and THEN announce. They do not knock. Ever. And this is on knock and announce warrants. They make the warrants as vague as possible because they know the judges will sign them anyway. They wait until the end of the shift to conduct them because they want the overtime pay. They are supposed to serve them within a couple hours of being executed. But we know from Breonna Taylor that it was 12 hours. They refuse to engage in the "knock and talk" practice, which literally entails what it says. Knock. Let resident come to door. And talk to them and see whether they will simply consent to a search. They are supposed to have ten people present for the warrant, including a patrol officer who would have body cam and whose role is to turn on his blue lights upon entry to let the resident and neighbors know that it's not a break in. They don't want to wait for SWAT, so they just don't complete the SWAT matrix. If they don't like the person, the place gets trashed. If they have a target they want, they just keep getting warrants and going after them to mess with them.

And now, Breonna Taylor is dead.

Overhaul the administration of this police department now.
