DEFENDANTS' REPLY TO PLAINTIFF'S RESPONSE TO THEIR OBJECTION TO THE SUPPLEMENTAL EXHIBITS AND DECLARATION OF MARCUS TURNINI

Defendants Alex Jones, Infowars, LLC, Free Speech Systems, LLC and Kit Daniels (collectively, the "Defendants"), hereby file this Reply to Plaintiff's Response to Their Objection to the Supplemental Exhibits and Declaration of Marcus Turnini, and show the Court as follows:

1. Defendants hereby reurge their timing objection to the Court's consideration of supplemental evidence filed after the conclusion of the August 2, 2018 hearing. Without waiver of the same, to the extent that the Court considers supplemental evidence, Defendants submit the following.

2. Plaintiff has failed to meet its evidentiary burden to provide clear and specific evidence that defendants Alex Jones or Infowars, LLC published the allegedly defamatory statement about Plaintiff or engaged in any other act or omission to support Plaintiff's legal actions against those entities. By way of further support for this assertion, Defendants hereby submit the attached publicly available "WHOIS" report confirming that defendant Free Speech Systems, LLC ("Free Speech") is the sole registrant and administrator for the website located at <u>www.inforwars.com</u> (the "Website"). *See <u>Exhibit 1</u>*. This exhibit can be found at https://whois.icann.org/en/lookup?name=www.infowars.com, and the Court can take judicial

notice of the same. This evidence further confirms that the domain name for the Website was registered in 1999. In short, this evidence demonstrates that Free Speech (and only Free Speech -- not Alex Jones or InfoWars, LLC) is the "publisher" of the Website upon which the allegedly defamatory statement was published.

PRAYER FOR RELIEF

With this submission of this Reply, Defendants agree that the record is complete and their Motion is ripe for adjudication. As such, the Court should sustain Defendants' objection to the admissibility of the Declaration, strike it from the record, and grant Defendants such other and further relief to which they may be justly entitled.
