DEFENDANTS' OBJECTION TO PLAINTIFF'S AUGUST 2, 2018 NOTICE OF FILING SUPPLEMENTAL EXHIBIT AND AFFIDAVIT OF MARCUS TURNINI

Defendants Alex Jones ("Jones"), Infowars, LLC ("InfoWars"), Free Speech Systems, LLC ("Free Speech") and Kit Daniels ("Daniels") (collectively, the "Defendants"), hereby file this Objection to Plaintiff's August 2, 2018 Notice of Filing Supplemental Exhibit, and Affidavit of Marcus Turnini and show the Court the following in support:

1. On August 2, 2018, immediately before the Court's hearing on the Defendants' Motion to Dismiss brought under Section 27.001 *et. seq.* of the Texas Civil Practice & Remedies Code (the "TCPA"), Plaintiff filed its first Notice of Filing Supplemental Exhibit. In so doing, Plaintiff has attempted to submit as a Supplemental Exhibit E an affidavit from his law firm's paralegal, purporting to identify an "archived" version of the web address https://www.infowars.com/terms-of-service.

2. The paralegal Mr. Marcus Turnini does not claim to be an expert nor otherwise explain the operation by which the Plaintiff has established by "clear and specific" evidence that the content attached to his affidavit is the same as that which existed at any point in the past other than August 1, 2018, the date he allegedly visited the website.

3. Nevertheless, even were Mr. Turnini qualified to opine that the documents attached to his Affidavit show a true and correct copy of the contents of a separate website at some specific date in the past, the supposed versions of "terms of service" are not "clear and specific" evidence that the publication of the Challenged Image by Mr. Daniels on the website Infowars.com (which is indisputably owned and operated by Free Speech Systems, LLC) may be ascribed to either Defendant Alex Jones or Defendant Infowars, LLC.

4. For example, the definition of the term "Website" in the Terms of Service attached to the affidavit (pgs. 5 of 25 and 4 of 21 of the service terms) specifically refer to a different website other than <u>www.infowars.com</u>. They refer to "planet.infowars.com," which is not an operational web address. In addition, a banner appears when launching the <u>www.infowars.com</u> website with a link to a "Privacy Policy." That "Privacy Policy" expressly states that the "data controller" for the infowars.com site is Free Speech Systems LLC. A copy of the Privacy Policy is attached hereto as **Exhibit 1** (and the Court can take judicial notice of the same). Lastly, the Texas Secretary of State records show that <u>www.infowars.com</u> is an assumed name of Free Speech Systems, LLC. Attached as **Exhibit 2** is a hard copy print out from the Texas Secretary of State website confirming this assumed name (and the Court can take judicial notice of the same).

5. As such, despite the Plaintiff's eleventh hour filing, there is still no "clear and specific" evidence that defendants Infowars LLC or Alex Jones, individually, published the Challenged Image or engaged in any other alleged wrongdoing in connection with Plaintiff's legal actions.
