### 背景

- 1.1 因應各政策局與政府部門對各類社會事項的統計數據的需求增加,政府統計處於1999 年開始進行一系列的主題性住戶統計調查。政府統計處將各政策局及政府部門就搜集所需社會事項的統計數據而提議進行的專題訪問結集,組成不同的主題性住戶統計調查,並外判予私營市場調查公司進行。
- 1.2 每一輪的主題性住戶統計調查均是獨立及涵蓋全港的統計調查,並且委託私營市場調查公司進行。政府統計處在該些統計調查中擔任協調及管理的角色,並負責監察承辦商的工作,以確保他們的服務素質能夠符合要求的標準。

### 本報告書所包括的專題

- 1.3 政府統計處在 2015 年 5 月至 9 月期間 進行了一輪主題性住戶統計調查,主要目的是 估算全港樓齡達 25 年或以上(即於 1990 年 12 月 31 日或該日之前興建)的私人住用/綜合用 途樓宇(不包括村屋)內的分間樓宇單位及居於 其中的住戶的總數,並搜集這類分間樓宇單位 的住屋狀況資料。
- 1.4 是項統計調查所估算的居於分間樓字單位住戶的總數已刊載於《長遠房屋策略 2015 年周年進度報告》內。本報告書載列有關統計調查的詳細結果,包括分間樓字單位的住屋狀況和居於其中的住戶及人士的特徵。
- 1.5 類似的有關香港分間樓宇單位的住屋 狀況的主題性住戶統計調查曾於2014年6月至 11 月期間進行<sup>1</sup>。2014 年的統計調查亦涵蓋全

### **Background**

- 1.1 To meet the growing demand for statistical data on selected social issues by policy bureaux and government departments, the Census and Statistics Department (C&SD) has been conducting a series of Thematic Household Survey (THS) since 1999. Enquiries for collecting the required statistical data on social topics proposed by individual bureaux / departments are packaged together to form different rounds of THS and contracted out to private research firms.
- 1.2 Each round of THS is an independent, territory-wide survey commissioned to a private research firm. C&SD plays a co-ordination and management role in the THS and is responsible for monitoring the work of the contractor to ensure that the required standards of quality of their services are met.

### Topic included in this report

- 1.3 A round of THS was conducted during May to September 2015, the major objective of which was to estimate the total number of sub-divided units (SDUs) in private domestic / composite buildings (excluding village houses) aged 25 and above (i.e. built on or before 31 December 1990) in Hong Kong and the total number of households living in these SDUs. Information related to the housing conditions of these SDUs was also collected in the survey.
- 1.4 The estimated total number of households living in SDUs found in the survey was already published in the *Long Term Housing Strategy Annual Progress Report 2015*. This report presents detailed findings of the survey, including housing conditions of SDUs and characteristics of households and persons living therein.
- 1.5 Similar survey related to the housing conditions of SDUs in Hong Kong was conducted during June to November 2014 in the THS series<sup>1</sup>. The 2014 survey also covered

港樓齡 25 年及以上(即於 1989 年 12 月 31 日或 該日之前興建)的私人住用/綜合用途樓宇(不 包括村屋)。換言之,2014年的統計調查在涵蓋 樓宇的範圍方面,跟 2015 年進行的統計調查有 些微差異,即主要沒有包括在1990年興建的樓 宇,但包括了在2015年拆卸的樓字。2015年的 統計調查涵蓋約 664 300 個屋宇單位,而 2014 年的統計調查涵蓋約637300個屋字單位。數據 使用者在比較兩項統計調查的結果時,需加以 留意。尤其是由於目標樓宇的涵蓋範圍有異, 直接比較兩項統計調查估算的分間樓宇單位數 目存在上述局限。另一方面,就了解分間樓字 單位普遍程度的轉變而言,透過參考兩項指 標,即有分間樓宇單位的屋宇單位佔所有屋宇 單位數目的百分比及平均每個屋宇單位分間成 分間樓字單位的數目,會更為適切。

### 統計調查方法簡述

- 1.6 這一輪主題性住戶統計調查分為兩個階段:
- (i) 第一階段涵蓋全港樓齡 25 年及以上(即於 1990年12月31日或該日之前興建)的私人住用/綜合用途樓宇(不包括村屋)內的所有屋宇單位。

統計員到訪獲抽選的 2 134 幢樓宇,透過 觀察單位的門鐘、電錶及信箱,並比較大 廈內不同樓層的屋宇單位數目和位置,以 協助識別單位是否有分間樓宇單位。統計 員亦詢問單位的鄰居及保安員,以了解樓 宇結構及懷疑有分間樓宇單位的屋宇單 位。統計員透過到訪獲抽選樓宇的所有單 位及訪問盡可能多的住戶後,再根據多方 搜集得來的資料,方可識別有分間樓宇單 位的屋宇單位。 private domestic / composite buildings (excluding village houses) aged 25 and above (i.e. built on or before 31 December 1989) in Hong Kong. In other words, the buildings covered in the 2014 survey differed slightly from that conducted in 2015. The differences are mainly seen in the exclusion of the buildings built in 1990 and the inclusion of the buildings demolished in 2015 in the 2014 survey. The 2015 survey covered some 664 300 quarters, whereas the 2014 survey covered some 637 300 quarters. Care should be taken in comparing the findings between the two surveys. In particular, direct comparison on the number of SDUs estimated from the two surveys is subject to the above limitation arising from the difference in the coverage of the target buildings. On the other hand, it should be more relevant to understand the changes in the prevalence of SDUs by making reference to two indicators, namely, the percentage of quarters with SDUs among all quarters and the average number of SDUs per unit of quarters having SDUs.

### Brief description of survey method

- 1.6 This round of THS was divided into 2 stages:
- (i) In stage 1, all quarters in private domestic / composite buildings (excluding village houses) aged 25 and above (i.e. built on or before 31 December 1990) in Hong Kong were covered.

Enumerators paid visits to 2 134 sampled buildings to identify quarters with SDUs by observing the door bells, electricity meters and mail boxes, and comparing the number and location of quarters on different floors of the buildings. They also asked neighbours and security guards understand the structures of buildings and the quarters suspected to have SDUs. Through visiting all quarters in the sampled buildings and interviewing as many households living therein as possible, enumerators could then base on information from various sources to identify those quarters with SDUs.

(ii) 第二階段涵蓋所有居於分間樓宇單位的所有人士(不包括旅客)。

在該 2 134 幢獲抽選的樓宇中,約一半(即 1 096 幢)經隨機抽選被納入第二階段的涵蓋範圍。在這個目標樓宇的子樣本中,統計員會從經第一階段識別為有分間樓宇單位的每個屋宇單位隨機抽選一個住戶參與第二階段的訪問。在第二階段,共有 1 534 個居於分間樓宇單位的住戶被抽選進行訪問。統計員到訪這些住戶,並向戶主或其中一名清楚分間樓宇單位的住屋狀況及住戶成員資料的 18 歲或以上的住戶成員進行面談訪問,以搜集所需的資料。

- 1.7 是項統計調查的第二階段成功訪問了 約1000個居於分間樓宇單位的住戶,回應率為 65%。
- 1.8 有關統計調查的調查方法詳情,請參閱本報告書的<u>附錄 1</u>。

### 概念及定義

- 1.9 是項統計調查涉及的主要名詞採用了 以下的定義:
- 「屋宇單位」是指在住宅、工業、商業和其 他類型的樓宇內供居住或其他用途並且有 間隔牆圍封的空間。一個屋宇單位必需符合 以下兩個條件:
  - i. 屋内互通,即住戶不必經過公共走廊、 梯台或樓梯,便能來往該屋宇單位內的 各個房間;及
  - ii. 屋外直達,即住戶不必經過其他屋宇單位便能直接走出街道、公共走廊或梯台。

(ii) In stage 2, all persons (excluding tourists) living in SDUs were covered.

Almost half (i.e. 1096 buildings) of the 2 134 sampled buildings were randomly selected to be covered in stage 2. For each unit of quarters identified to have SDUs in stage 1 in this sub-sample of target buildings, one of the households living in these SDUs was randomly selected for enumeration in stage 2. Altogether 1 534 households living in SDUs were sampled for enumeration in stage 2. Enumerators paid visits to these households to collect the required information by conducting face-to-face interview with the head of household or one of the household members aged 18 or over who knew about the housing conditions of the SDUs and particulars of the household members.

- 1.7 In stage 2 of the survey, some 1 000 households living in SDUs were successfully enumerated, constituting a response rate of 65%.
- 1.8 More detailed descriptions of the methodology of the survey are given in Appendix 1.

### **Concepts and definitions**

- 1.9 The definitions of the key terms used in the survey are given below:
- "Quarters" refers to the space enclosed by walls in a residential, industrial, commercial and other types of buildings for living or other purposes. A unit of quarters must fulfil the following two conditions:
  - i. being internally connected so that the occupants can move between rooms without going outside through a public corridor, landing or staircase; and
  - ii. being externally accessible such that it has direct access to the street, a corridor or landing without going through someone else's quarters.

### 數字進位

1.10 由於進位關係,統計圖表內個別項目加 起來的總和可能與總計略有出入。統計圖表內 有關百分比分布的數字是根據未經進位的實際 數字計算。

- "Sub-divided units" (SDUs) are formed by the sub-division of individual quarters into two or more units for rental purposes to more than one household. SDUs are generally classified into the following two types:
  - i. SDUs with observable physical partitions. For these SDUs, concrete or wooden walls (observable partitions) are usually used to sub-divide the quarters into two or more small units. They are usually installed with independent toilets and / or cooking areas; and
  - ii. SDUs without observable physical partitions. These SDUs take the form of simple wooden cubicles and facilities within the quarters such as kitchen and toilet have to be shared among the tenants.

More detailed explanations of the definition of SDUs are given in Chapter 3.

### **Rounding of figures**

1.10 Owing to rounding, there may be a slight discrepancy between the sum of individual items and the total as shown in charts and tables. It should also be noted that actual figures without rounding are used in compiling the percentage shares in charts and tables.

### 第 2 部分 Part 2

### 主要觀察 - 與 2014 年統計調查結果比較

以下陳述 2015 年與 2014 年統計調查主要結果 的變化:

### 分間樓宇單位的普遍程度大致維持不變

- 根據第1章第1.5段所述,就了解分間樓宇單位普遍程度的轉變而言,透過參考兩項指標,即有分間樓宇單位的屋宇單位佔所有屋宇單位數目的百分比及平均每個屋宇單位分間成分間樓宇單位的數目,會更為適切。
- 2015年有分間樓宇單位的屋宇單位佔所有屋 宇單位數目的百分比為 3.8%, 而 2014 年的 數字為 3.9%。
- 2014 年及 2015 年平均每個屋字單位分間成分間樓字單位的數目均為 3.5 個。

### 居於分間樓宇單位住戶的每月租金中位數 及住戶每月收入中位數有所上升

- 在居於分間樓字單位的住戶中,每月租金中位數從2014年的3,800元增加到2015年的4,200元,增幅為10.5%。而住戶每月收入中位數從2014年的11,800元增加到2015年的12,500元,增幅為6.1%。租金與收入比率中位數亦由2014年的30.8%上升至2015年的32.3%。
- 惟須注意的是有部分住戶拒絕提供住戶每月 收入的資料(有關比例分別為 2015 年的 27.6%及 2014 年的 13.4%),與收入有關的數 字須小心闡釋。

### Key observations as compared to 2014 round of the survey

Changes in key findings of the 2015 round of the survey as compared to the 2014 round are given below:

### Prevalence of SDUs remaining broadly the same

- As mentioned in paragraph 1.5 in Chapter 1, it would be more relevant to understand the changes in the prevalence of SDUs by making reference to two indicators, namely, the percentage of quarters with SDUs among all quarters and the average number of SDUs per unit of quarters having SDUs.
- The percentage of quarters with SDUs among all quarters was 3.8% in 2015, compared to 3.9% in 2014.
- The average number of SDUs per unit of quarters having SDUs was 3.5 in both 2014 and 2015.

# Increase in median monthly rental payment and median household income of households living in SDUs

- Among households living in SDUs, the median monthly rental payment increased by 10.5%, from \$3,800 in 2014 to \$4,200 in 2015, while the median household income increased by 6.1% from \$11,800 in 2014 to \$12,500 in 2015. The median rent to income ratio also increased from 30.8% in 2014 to 32.3% in 2015.
- It should however be noted that there were households which refused to provide information on monthly household income (with respective proportions being 27.6% and 13.4% in 2015 and 2014). Relevant figures related to income should be interpreted with care.

### 居於分間樓宇單位人士<sup>^^</sup>的年齡分布有所 變化

• 2014 年及 2015 年居於分間樓宇單位人士的 年齡分布有所不同。在居於分間樓宇單位的 人士中,年齡為 25 - 44 歲人士的百分比由 2014 年的 38.6%上升至 2015 年的 44.0%,變 化尤為顯著。至於其他年齡組別,有關比例 的變化相對較細。上述年齡分布的變化可能 與居於分間樓宇單位住戶的流動性有關。

### Change in the age distribution of persons hiving in SDUs

• The age distribution of persons living in SDUs differed somewhat between 2014 and 2015. A more notable change is that among persons living in SDUs, the percentage of those aged 25 - 44 increased from 38.6% in 2014 to 44.0% in 2015. As for other age groups, the changes were comparatively small. The above changes in the age distribution may be attributable to the mobility of households living in SDUs.

### **Definition of sub-divided units**

### 屋宇單位的定義

- 3.1 「屋宇單位」是指在住宅、工業、商業和其他類型的樓宇內供居住或其他用途並且有間隔牆圍封的空間。一個屋宇單位必需符合以下兩個條件:
- (i) 屋内互通,即住戶不必經過公共走廊、梯台或樓梯,便能來往該屋宇單位內的各個房間;及
- (ii) 屋外直達,即住戶不必經過其他屋宇單位 便能直接走出街道、公共走廊或梯台。

### 分間樓宇單位的定義

- 3.2 「分間樓宇單位」普遍指住用屋宇單位被分間成兩個或以上較小單位作出租用途。普遍來說,單位原先的非結構間隔牆會被拆除,並加設新的間隔牆;裝置新的廁所及廚房;和改動或加設內部排水渠。分間樓宇單位一般可分為以下兩類:
- (i) 有可見間隔牆的分間樓宇單位。這類分間 樓宇單位通常以混凝土或木板作可見間隔 牆,將屋宇單位分間成兩個或以上較小的 單位,並通常設有獨立廁所及/或煮食地 方。這類分間樓宇單位可分為3類型(見 以下段落詳述的類型1.1,1.2及1.3);及
- (ii) 没有可見間隔牆的分間樓宇單位。這類的 分間樓宇單位(類型 2)通常為結構簡單 的木製板間房,租戶需要與其他租戶共用 屋宇單位內的設施如廚房及廁所等。

### **Definition of quarters**

- 3.1 "Quarters" refers to the space enclosed by walls in a residential, industrial, commercial and other types of buildings for living or other purposes. A unit of quarters must fulfil the following two conditions:
- (i) being internally connected so that the occupants can move between rooms without going outside through a public corridor, landing or staircase; and
- (ii) being externally accessible such that it has direct access to the street, a corridor or landing without going through someone else's quarters.

#### **Definition of sub-divided units**

- 3.2 "Sub-divided units" (SDUs) commonly refer to cases where domestic quarters are sub-divided into two or more smaller units for rental purposes. Generally speaking, the original non-structural partition walls are removed while new ones are erected; new toilets and kitchens are installed; and internal drains are added or altered. SDUs are generally classified into the following two types:
- (i) SDUs with observable physical partitions. For these SDUs, concrete or wooden walls (observable partitions) are usually used to sub-divide the quarters into two or more small units. They are usually installed with independent toilets and / or cooking areas. These SDUs can be classified into three types (see Types 1.1, 1.2 and 1.3 as described in the following paragraphs); and
- (ii) SDUs without observable physical partitions. These SDUs (Type 2) take the form of simple wooden cubicles and facilities within the quarters such as kitchen and toilet have to be shared among the tenants.

### 類型1.1 樓宇走廊主要用作進出街道或 樓梯用途

3.3 這類分間樓宇單位通常以可見間隔牆 (混凝土或木板),將屋宇單位分間成兩個或 以上較小的單位,而興建在屋宇單位內的走廊 主要用作進出街道或樓梯用途,即住戶不須經 過其他分間樓宇單位便可從其分間樓宇單位直 接走到街道、公共走廊或樓梯。該類分間樓宇 單位通常設有獨立廁所及/或煮食地方。圖 1 所示為這類型分間樓宇單位的最常見例子。


### Type 1.1 The corridors built inside primarily for access to streets or staircases

3.3 In these SDUs, observable physical partitions (concrete or wooden) are usually used to sub-divide the quarters into two or more smaller units with the corridors built inside these quarters primarily for access to streets or staircases, i.e. one can go from the quarters directly to streets, public corridors or staircases without passing through another quarters. Such SDUs are usually installed with independent toilets and / or cooking areas. Typical SDUs of this type are shown in Diagram 1.

類型1.2 新建的分間樓字單位

3.4 有些分間樓宇單位是以改變原有樓宇的結構而成。如圖 2 所示,在三樓一個屋宇單位的結構牆上有新建的門口,但在同一樓宇的四樓,同樣位置的屋宇單位卻沒有同樣的門口。

Type 1.2 The "newly built" SDUs

3.4 Some SDUs are created by reconstructing the original structures. An example is illustrated in Diagram 2 which shows that an additional opening on structural wall has been created for the quarters on 3/F whereas such opening does not exist for the quarters immediately above it on 4/F.

圖 2分間樓字單位的例子(二)Diagram 2Example (2) of sub-divided units










類型1.3 類型1.1 和1.2 的混合體


3.5 有些分間樓字單位是類型 1.1 和類型 1.2 的混合體。這種分間樓字單位是由改變原有屋字單位的結構而成,在原有結構牆上加建新的門口,並使用可見間隔牆(混凝土或木板)將屋字單位分隔成兩個或以上的較小單位,而興建在屋字單位內的走廊主要用作進出街道或樓梯用途。這種分間樓字單位並不普遍。圖 3 顯示這類型的分間樓字單位的平面圖。

Type 1.3 Combination of types 1.1 and 1.2

3.5 Some SDUs are found to be a combination of types 1.1 and 1.2 mentioned above. These **SDUs** are created reconstructing the original structures of the quarters in which an additional opening on structural wall has been created and observable physical partitions (concrete or wooden) are also used to sub-divide the quarters into two or more smaller units with the corridors built inside these quarters primarily for access to streets or staircases. These SDUs are not common. Diagram 3 shows the layout of this type of SDUs.

### 類型2 一屋多戶

3.6 有些分間樓宇單位沒有獨立廁所和/或煮食地方。租戶或分租戶要與其他租戶共用屋宇單位內的廁所或其他設施(包括煮食地方)。這些分間樓宇單位又稱為板間房或床位寓所。板間房一般結構簡單,亦常見於舊樓中以木板間隔的屋宇單位。有些板間房的木板間隔和天花板之間,留有空間作空氣流通之用,但有些板間房的木板間隔則直達天花板。床位寓所,俗稱「籠屋」,是作個人住宿的地方。

3.7 統計員在造訪居於板間房和床位寓所的住戶時,即使進入了屋宇單位內並向住戶進行了訪問,一般都未能確定分間樓宇單位內是否有新的間隔。圖 4 所示的是最常見的例子,有三位租戶居住在屋宇單位內,並共用客廳、廁所和煮食的地方。

Type 2 Multi-households

- 3.6 For some SDUs, there independent toilets and / or cooking areas. The tenants or sub-tenants have to share the toilets and other facilities including cooking areas with other tenants within the quarters. These types of SDUs are known as cubicle apartments or bedspace apartments. They are generally cubicles made of simple structure and commonly found in quarters of old buildings which are sub-divided by wooden partitions. cubicles have openings at the top of the wooden partitions for ventilation purpose but there are some cubicles which have partitions reaching the ceiling without any opening. Bedspace apartments, commonly known as "caged homes", are used as sleeping accommodation for individuals.
- 3.7 For cubicle apartments and bedspace apartments, it was uncertain whether there was any new physical partition inside the quarters even after the enumerator had entered the quarters and conducted interviews with the households concerned. A typical example is illustrated in Diagram 4 which shows that three tenants are living in the quarters and sharing facilities in the living room, toilet and cooking area.

3.8 值得注意的是如圖 5 所示,有些業主 會將屋宇單位的客廳改建成房間或擴大現有的 房間出租,只剩下走廊作進出目的。租戶需要 共用廁所和煮食地方。 3.8 It is worth noting that some landlords may reconstruct a quarters in such a manner that the living room is used as another room or expansion of existing room(s) for renting out, leaving only the corridors for access purpose, as illustrated in Diagram 5. The tenants have to share the toilet and cooking area.

3.9 如以上兩個例子所說明,分間樓宇單 位會以不同方式分間。板間房如圖 4 所示可能 改建成圖 5 所示,使有關屋宇單位內形成主要 作進出街道或樓梯之用的走廊。 3.9 As illustrated in the two examples above, the quarters may be sub-divided in different manners. A cubicle apartment in Diagram 4 may be subsequently re-constructed in such a way that corridors are formed inside the quarters concerned, which are primarily used for access to streets or staircases, as shown in Diagram 5.

### 分間樓宇單位的住屋狀況

### Housing conditions of sub-divided units

- 4.1 在統計時,全港樓齡25年及以上的私 人住用/綜合用途樓宇(不包括村屋)內約有 25 200 個屋宇單位有分間樓宇單位,佔這些樓 宇中所有屋宇單位的 3.8%。位於這些屋宇單位 的分間樓字單位總數估計約有88800個。平均 每個有關屋宇單位分間成 3.5 個分間樓宇單 位。在統計時,這些分間樓字單位合共為約 87 600 住戶及 199 900 名人十\*提供居所。 (表 4.1 及 4.2)
- 4.2 按地區分析,約51900個分間樓宇單 位(58.4%)位於九龍,19 100 個(21.5%)位於新界 及 17 800 個(20.0%)位於香港島。 (圖 4.1 及表 4.1)
- 4.3 按是否有可見間隔牆分析,約 83 000 個分間樓宇單位(93.5%)有可見間隔牆,而餘下 的 5 800 個(6.5%)則沒有可見間隔牆(例如有公 共空間的房間、閣樓及床位)。 (表 4.3)

### 單位面積

4.4 在該 87 600 個居於分間樓字單位的住 戶中,65.2%住戶居住的單位面積為7至少於 13 平方米。其次為 13 至少於 20 平方米 (16.9%)、7平方米以下(13.4%)及20平方米或以 上(4.4%)。單位面積中位數為 10.3 平方米(或 110.7 平方呎)。 (圖 4.2 及表 4.4)

- 4.1 There were some 25 200 quarters with sub-divided units (SDUs) in private domestic / composite buildings (excluding village houses) aged 25 and above in Hong Kong at the time of enumeration, accounting for 3.8% of all quarters in these buildings. The total number of SDUs in these guarters was estimated to be some 88 800. On average, each unit of quarters with SDUs was sub-divided into 3.5 SDUs. At the time of enumeration, these SDUs accommodated some 87 600 households and 199 900 persons\* altogether. (Tables 4.1 and 4.2)
- 4.2 Analysed by region, some 51 900 (58.4%) SDUs were located in Kowloon, 19 100 (21.5%) in the New Territories and 17 800 (20.0%) on Hong Kong Island. (Chart 4.1 and Table 4.1)
- 4.3 Analysed by whether there observable physical partition, some 83 000 (93.5%) SDUs were with observable physical partition, while the remaining 5 800 (6.5%) were without observable physical partition (e.g. rooms with common areas, cocklofts and bedspaces). (Table 4.3)

#### Area of the units

Of those 87 600 households living in SDUs, 65.2% of them were living in units with area of 7 to less than 13 square metres. This was followed by units with area of 13 to less than 20 square metres (16.9%), below 7 square metres (13.4%), and 20 square metres or above (4.4%). The median area of the units was 10.3 square metres (or 110.7 square feet). (Chart 4.2 and Table 4.4)

### 平均人均面積

4.5 分間樓字單位的平均人均面積隨著住戶人數的增加而下降。一人住戶的平均人均面積為 8.5 平方米,而二人住戶為 6.1 平方米。平均人均面積由三人住戶的 3.7 平方米進一步下降至四人及以上住戶的 3.0 平方米。所有居於分間樓字單位的人士的平均人均面積為 5.8 平方米(或 62.4 平方呎),而人均面積中位數為 4.5 平方米(或 48.0 平方呎)。 (表 4.5)

### 每月租金

4.6 撇除單位由僱主提供/免租的住戶,有86000個居於分間樓字單位並需繳交租金,當中32.5%的住戶繳付的每月租金為4,000元至4,999元(包括管理費、差餉和地租)。另有22.8%的住戶每月繳交的租金為3,000元至3,999元,16.2%為5,000元至5,999元及14.4%為6,000元或以上。每月租金中位數為4,200元。(表4.6)

#### 單位內的設施

4.7 按單位內的設施分析,在該 87 600 個居於分間樓字單位的住戶中,其單位設有獨立電錶、食水供應或獨立廁所的住戶數目的比例分別為 96.2%、93.6%及 91.1%。另有 87.7%住戶的單位內設有可向屋字單位外開啟的窗戶及63.1%設有獨立廚房/煮食地方。 (表 4.7)

### 對單位居住環境的意見

4.8 在該 87 600 個居於分間樓宇單位的住戶中,43.8%認為單位居住環境一般,38.1%不滿意/非常不滿意及 18.1%非常滿意/滿意。(表 4.8)

#### Average area per capita

4.5 The average area of SDUs per capita tended to decrease with household size. The average area per capita for 1-person households was 8.5 square metres and that for 2-person households was 6.1 square metres. The figure further decreased from 3.7 square metres for 3-person households to 3.0 square metres for 4-person and above households. The average area per capita for all persons living in SDUs was 5.8 square metres (or 62.4 square feet) while the median area per capita was 4.5 square metres (or 48.0 square feet). (Table 4.5)

#### Monthly rental payment

4.6 Excluding households whose units were provided by employers / rent-free, there were 86 000 households living in SDUs which had to pay rent. 32.5% of them paid \$4,000 - \$4,999 per month (including management fees, rates and Government rent). Another 22.8% of those households paid an amount of \$3,000 - \$3,999 per month, 16.2% paid \$5,000 - \$5,999 and 14.4% paid \$6,000 or above. The median monthly rental payment was \$4,200. (Table 4.6)

#### Facility in the units


4.7 Analysed by facility in the units, the proportions of those 87 600 households living in SDUs which had independent electricity meter, fresh water supply or independent toilet in their units were 96.2%, 93.6% and 91.1% respectively. Another 87.7% of the households had windows which could be opened and were outside the quarters when opened and 63.1% had independent kitchen / cooking area within the units. (Table 4.7)

### View on living environment of the units

4.8 Of those 87 600 households living in SDUs, 43.8% considered the living environment of the units as average, 38.1% were dissatisfied / very dissatisfied and 18.1% were very satisfied / satisfied. (Table 4.8)



### 居於分間樓宇單位住戶的特徵

### Characteristics of households living in sub-divided units

5.1 在統計時,全港樓齡 25 年及以上的私人住用/綜合用途樓宇(不包括村屋)內約有87 600 個居於分間樓宇單位的住戶。

### 住戶人數

5.2 該 87 600 個居於分間樓宇單位的住戶 以小型住戶為主。31.5%為一人住戶,29.3%為 二人住戶及 23.9%為三人住戶。另有 15.4%為四 人及以上住戶。住戶人數中位數為 2.0 人。 (圖 5.1 及表 5.1)

### 住戶每月收入

5.3 在該 87 600 個居於分間樓字單位的住戶中,21.7%住戶每月收入為 10,000 元以下,25.7%為 10,000 元至 14,999 元,及 25.0%為 15,000 元及以上。住戶每月收入中位數為 12,500元。須注意,由於拒絕提供住戶每月收入資料的住戶百分比不低(27.6%),上述數字僅供粗略參考。 (表 5.2)

### 租金與收入比率中位數

5.4 撇除單位由僱主提供/免租和沒有收入及拒絕提供住戶每月收入資料的住戶,居於分間樓字單位住戶的租金與收入比率中位數為32.3%。按住戶人數分析,一人住戶的比率中位數最高(35.3%),四人及以上住戶則最低(29.1%)。 (表 5.3)

### 統計前3年內有否搬屋/搬屋次數

5.5 在該 87 600 個居於分間樓宇單位的住戶中,48.3%在統計前 3 年內曾搬屋。在該些曾搬屋的住戶中,67.9%搬屋次數為 1 次,18.5%為 2 次及 9.4%為 3 次及以上。另外,40.0%在統計前 3 年內沒有搬屋,11.7%表示來港後即入住有關的分間樓宇單位。 (表 5.4)

5.1 There were some 87 600 households living in sub-divided units (SDUs) in private domestic / composite buildings (excluding village houses) aged 25 and above in Hong Kong at the time of enumeration.

#### Household size

5.2 Small households predominated the 87 600 households living in SDUs. 31.5% were 1-person households, 29.3% were 2-person households and 23.9% were 3-person households. Another 15.4% were 4-person and above households. The median household size was 2.0 persons. (Chart 5.1 and Table 5.1)

### Monthly household income

5.3 Among those 87 600 households living in SDUs, 21.7% had monthly household income of below \$10,000, 25.7% of \$10,000 - \$14,999 and 25.0% of \$15,000 and above. The median monthly household income was \$12,500. It should be noted that as the proportion of households which refused to provide information on monthly household income was not low (27.6%), the figures mentioned above are for crude reference only. (Table 5.2)

#### Median rent to income ratio

5.4 Excluding households whose units were provided by employers / rent-free, households without income and households which refused to provide information on monthly household income, the median rent to income ratio for households living in SDUs was 32.3%. Analysed by household size, the median ratio was the highest for 1-person households (35.3%) and the lowest for 4-person and above households (29.1%). (Table 5.3)

Whether had moved house in the past 3 years before enumeration / number of times

5.5 Of those 87 600 households living in SDUs, 48.3% had moved house in the past 3 years before enumeration; and 67.9% of which had moved once, 18.5% twice and 9.4% thrice and above. 40.0% had not moved house in the past 3 years before enumeration, while 11.7% indicated that they had moved into the SDUs concerned upon arrival in Hong Kong. (Table 5.4)

5.6 在該 87 600 個居於分間樓字單位的住戶中,46.8%曾經申請公共租住房屋。當中,大部分住戶(88.8%)的申請進度皆為「仍在輪候」,而只有小部分住戶「不符合申請資格」(6.7%)。(表 5.5)

### 居於單位的原因

5.7 在該 87 600 個居於分間樓字單位的住戶中, 61.6%提及「租金比較可以負擔(與租住整個私人屋字單位作比較)」為在統計時居住在該單位的原因。另有 36.3%提及「方便上班/上學」為居住在該單位的原因。其他提及的原因包括「經濟困難」(22.6%)、「父母/親人的居所太擠迫」(5.7%)及「家庭問題」(5.1%)。(表 5.6)


5.6 Of those 87 600 households living in SDUs, 46.8% had applied for public rental housing. The majority (88.8%) of their application status of the households concerned was "still waiting", while a small proportion of the households were "ineligible" (6.7%). (Table 5.5)

#### Reason for living in the units

5.7 Among those 87 600 households living in SDUs, 61.6% cited "more affordable rent (as compared with that of a whole unit of private quarters)" as the reason for living in the units at the time of enumeration. Another 36.3% cited "convenient to go to work / school" as the reason. Other cited reasons included "financial difficulties" (22.6%), "lack of space to live with parents / relatives" (5.7%) and "family problems" (5.1%). (Table 5.6)

# Characteristics of persons living in sub-divided units

6.1 在統計時,全港約有199900名人士(包括約1600名外籍家庭傭工及短期留港人士)居於樓齡25年及以上的私人住用/綜合用途樓宇(不包括村屋)內的分間樓宇單位。以下分析不包括外籍家庭傭工及短期留港人士。

#### 年齡及性別

- 6.2 按年齡組別分析,在該 198 300 名(不包括外籍家庭傭工及短期留港人士)居於分間樓宇單位的人士當中,28.0%為 25 歲以下,44.0%為 25-44 歲及 20.9% 為 45-64 歲。65歲及以上人士則佔 7.1%。 (圖 6.1 及表 6.1)
- 6.3 按性別分析,49.3%居於分間樓字單位的人士為男性,50.7%為女性。 (表 6.1)
- 6.4 再按年齡及性別分析,在小童(即 15 歲以下)及年齡較長的人士(即 45 歲及以上)中, 男性明顯較女性為多。另一方面,在青中年人 士(即 25 - 44 歲)中,女性則明顯較男性為多。 (圖 6.1 及表 6.1)

#### 教育程度

6.5 在該 198 300 名居於分間樓字單位的 人士中,60.3%具中學教育程度。另外 31.6%具 小學及以下教育程度,只有 8.1%具專上教育程 度。 (表 6.2)

#### 婚姻狀況

6.6 在該 198 300 名居於分間樓字單位的 人士中,51.5%為已婚,40.3%為從未結婚及 8.2%為離婚/分居/喪偶人士。 (表 6.3) 6.1 There were some 199 900 persons (including some 1 600 foreign domestic helpers and persons having short stay in Hong Kong) living in sub-divided units (SDUs) in private domestic / composite buildings (excluding village houses) aged 25 and above in Hong Kong at the time of enumeration. The following analyses do not include foreign domestic helpers and persons having short stay in Hong Kong.

#### Age and sex

- Analysed by age group, 28.0% of those 198 300 persons (excluding foreign domestic helpers and persons having short stay in Hong Kong) living in SDUs were of age below 25, 44.0% aged 25 44, 20.9% aged 45 64, while those aged 65 and over accounted for 7.1%. (Chart 6.1 and Table 6.1)
- 6.3 Analysed by sex, 49.3% of those persons living in SDUs were males while 50.7% were females. (Table 6.1)
- 6.4 Further analysed by age and sex, among the children (i.e. those aged below 15) and older persons (i.e. those aged 45 and above), there were notably more males than females. On the other hand, among the young to middle-aged persons (i.e. those aged 25 44), there were notably more females than males. (Chart 6.1 and Table 6.1)

#### Educational attainment

6.5 Of those 198 300 persons living in SDUs, 60.3% had attained secondary education. Another 31.6% had attained primary education and below, while only 8.1% had attained post-secondary education. (Table 6.2)

#### Marital status

6.6 Of those 198 300 persons living in SDUs, 51.5% were married, 40.3% were never married and 8.2% were divorced / separated / widowed. (Table 6.3)



# **Appendix 1 : Survey methodology**

# 統計調查的涵蓋範圍及樣本設計

- 1. 這一輪主題性住戶統計調查分為兩個 階段:
- (i) 第一階段涵蓋全港樓齡 25 年及以上(即於 1990年12月31日或該日之前興建)的私人 住用/綜合用途樓宇(不包括村屋)內的所 有屋宇單位。
- (ii) 第二階段涵蓋所有居於分間樓宇單位的所 有人士(不包括旅客)。
- 2. 是項統計調查涵蓋以分層隨機抽樣的 2 134 幢目標樓宇,分層因素為樓齡、應課差餉 租值和地理特徵。統計員會在第一階段造訪隨 機抽選樓宇內的所有屋宇單位,以識別有分間 樓宇單位的屋宇單位。在該 2 134 幢獲抽選的樓 宇中,約一半(即 1 096 幢)經隨機抽選被納入 第二階段的涵蓋範圍。在這個目標樓宇的子樣 本中,統計員會從經第一階段識別為有分間樓 宇單位的每個屋宇單位,隨機抽選一個住戶參 與第二階段的訪問。
- 3. 是項統計調查採用比率推估法,按樓 齡、應課差餉租值和地理特徵劃分的樓字/屋 宇單位數目的估計數字,估算有分間樓宇單位 的屋宇單位數目和分間樓宇單位的數目。

# 統計調查問卷

- 4. 每一輪的主題性住戶統計調查均採用獨立的問卷。就本報告書所包括的專題而言,統計調查採用了兩份問卷,即「屋宇單位問卷」和「分間樓宇單位住戶問卷」,分別用於第一和第二階段。這樣做既能適切地運用資源,而又能避免對居於受訪樓宇的住戶造成不必要的不便。
- 5. 「屋宇單位問卷」只涵蓋一些基本問題,包括屋宇單位類型、分間樓宇單位類型、 單位內設施及住戶數目。

# Survey coverage and sample design

- 1. This round of Thematic Household Survey (THS) was divided into 2 stages:
- (i) In stage 1, all quarters in private domestic / composite buildings (excluding village houses) aged 25 and above (i.e. built on or before 31 December 1990) in Hong Kong were covered.
- (ii) In stage 2, all persons (excluding tourists) living in sub-divided units (SDUs) were covered.
- 2. The survey covered a stratified random sample of 2 134 target buildings, with the stratification factors being building age, rateable value and spatial characteristics. All quarters in those randomly selected buildings were visited in stage 1 to identify quarters with SDUs. Almost half (i.e. 1 096 buildings) of the 2 134 sampled buildings were randomly selected to be covered in stage 2. For each unit of quarters identified to have SDUs in stage 1 in this sub-sample of target buildings, one of the households living in these SDUs was randomly selected for enumeration in stage 2.
- 3. The ratio estimation method was adopted to derive estimates of the number of quarters with SDUs and number of SDUs, using independent estimates on the number of buildings / quarters by building age, rateable value and spatial characteristics.

# Survey questionnaire

- 4. Independent questionnaire was adopted for each round of the THS. Regarding the topic covered in this report, in order to optimise the utilisation of resources and to avoid causing unnecessary inconvenience to residents living in the sampled buildings, two sets of questionnaires, namely the "Quarters Questionnaire" and the "SDU Household Questionnaire" were used respectively in stages 1 and 2 of the survey.
- 5. The "Quarters Questionnaire" covered some basic information such as types of quarters, types of SDUs, facilities and number of households.

- 6. 「分間樓宇單位住戶問卷」用作面談 訪問,對象為戶主或其中一名清楚分間樓宇單 位的住屋狀況及住戶成員資料的 18 歲或以上的 住戶成員。搜集的資料包括住戶人數、單位面 積、租金、住戶及住戶成員的社會經濟特徵、 以及住戶對分間樓宇單位居住環境意見等。
- 7. 圖甲陳示進行是項統計調查的流程。
- The "SDU Household Questionnaire" was used in the face-to-face interview with the head of household or one of the household members aged 18 or over who knew about the housing conditions of the SDUs and particulars of the household members. Information collected included the household size, unit area, rental payment, socio-economic characteristics of the households and household members, households' perceived view on the living environment of the SDUs, etc.
- 7. The flow of conducting the survey is shown in Diagram A.

# 第一階段:在所有目標樓宇,識別有分間樓宇 單位的屋宇單位

- (i) 在這個目標樓宇的子樣本中,統計員會從 經第一階段識別為有分間樓宇單位的每個 屋宇單位,隨機抽選一個住戶參與第二階 段的統計調查。
- (ii) 統計員會利用「分間樓字單位住戶問卷」 搜集有關住戶的資料。

# Stage 1: Identifying quarters with SDUs in all target buildings

- (i) Enumerators would identify SDUs by observing the door bells, electricity meters and mail boxes, and comparing the number and location of quarters on different floors of the buildings. Enumerators would also ask neighbours and security guards to understand the structure of buildings and the quarters suspected to have SDUs.
- (ii) Enumerators would use the "Quarters Questionnaire" to collect information of quarters (e.g. with / without SDUs) with households concerned to verify the existence of SDUs.
- (iii) If the quarters were identified to have SDUs, the types and number of SDUs would be recorded.

# Stage 2: Interviewing randomly selected SDU households in a sub-sample of the target buildings


- (i) For each unit of quarters identified to have SDUs in stage 1 in this sub-sample of target buildings, one of the households living in these SDUs was randomly selected to participate in stage 2 of the survey.
- (ii) Enumerators would use the "SDU Household Questionnaire" to collect information of SDU households.

# 訪問結果

- 8. 是項統計調查的外勤工作於 2015 年 5 月至 9 月期間進行。在統計調查的第一階段,在獲抽選的 2 134 幢樓宇中,有 240 幢樓宇拒絕統計員進入或已拆卸。在餘下的 1 894 幢樓宇中(內有約 57 400 個屋宇單位),有 950 幢樓宇(內有約 26 100 個屋宇單位)識別為有分間樓宇單位,並在 2 718 個屋宇單位內有 9 577 個在統計時識別為有人居住的分間樓宇單位。
- 9. 從第一階段識別為有人居住的 9 577 個分間樓宇單位中,確知共有 9 577 個住戶。然後,在統計調查的第二階段,統計員隨機抽選了 1 534 個住戶參與面談訪問。統計員成功訪問了 1 002 個住戶,回應率為 65%。有關的訪問結果概列如下:

#### **Enumeration experience**

- 8. Fieldwork of the survey was conducted during May to September 2015. In stage 1 of the survey, 240 buildings out of 2 134 sampled buildings denied access to enumerators or were demolished. Of the remaining 1 894 buildings (comprising some 57 400 quarters), 950 buildings (comprising some 26 100 quarters) were identified to have SDUs. At the time of enumeration, 9 577 SDUs in 2 718 quarters were identified as being occupied.
- 9. A total of 9 577 households were found living in the 9 577 SDUs identified in stage 1. Then, in stage 2 of the Survey, 1534 households were randomly selected to participate in the face-to-face interviews. 1 002 households were successfully enumerated, constituting a response rate of 65%. The enumeration experience is summarised below:

- 11. For comparing the precision of the estimates of various variables in this report, the *coefficient of variation* (CV) can be used. CV is obtained by expressing the *standard error* (SE) as a percentage of the estimate to which it refers. In turn, the SE is computed according to a formula which is established on the basis of statistical theory. Generally speaking, the SE is related to the variability of the elements in the population, the size of the sample and the sample design adopted for the survey.
