## **PART 1: SUBMISSION REQUIREMENTS**

### 1.1 Submission of Entry

- Submissions will be collected by the organisers through the online **Entry Form.**
- Please select **only one category** that you feel is best suited with your innovation and nature of the company.
- There's no payment required for the entry submission.

All entries must be submitted by the stated deadline and in the following 2 formats:

Video	<ul> <li>An MP4 video file or a video link which describes the purpose and Unique Selling Point of the innovation.</li> </ul>
Document	<ul> <li>Please include in PDF, all the information required as stated in the entry form to further elaborate on the innovation.</li> </ul>







### **PART 2: JUDGING**

### 2.1 Judging Phases

Phase 1	<ul> <li>After the submission closing date, Malaysiakini and Digital News Asia will shortlist finalists in each category.</li> </ul>
Phase 2	<ul> <li>A presentation by finalists to the category panel judges will be done online.</li> <li>Category winners will be announced at the ceremony in December 2021.</li> </ul>

### 3.1 Finalists' Presentations


- Finalists will be required to present their innovation to the respective category judging panel, followed by a Q&A session.

### **Innovator of The Year**


This award recognises a **person** who has **developed a breakthrough innovation** that has the potential to improve lives and serve as an inspiration to those working in the technopreneurship industry.

This award recognises a **Federal Level & State Level Government Agency** that has shown transformation and strong collaboration with the industry to strengthen the **technology innovation and transformation initiatives** to the Startup & SMEs.

This award recognises a **startup**, founded by visionary entrepreneurs with **innovative products or services** that aim to disrupt the industry **with an annual revenue of up to RM 1 million**.

This award recognises a **company** that is producing or providing **innovative products or services** that aim to disrupt the industry **with an annual revenue of RM 1 million – RM 10 million**.

### **Startup**

This award recognises a **startup** in operation for **below 18 months** that has shown excellent resilience, productivity, and **promising scalability with an annual revenue of up to RM 1 million**.

### **Growth Company**

This award recognises a **company** that has shown excellent resilience, productivity and **promising scalability with an annual revenue of**RM 1 million – RM 10 million.

### **Best Pivot**

### Startup

This award recognises a **startup** that has shown **tremendous pivot strategy** during the pandemic **with an annual revenue of up to RM 1 million**.

### **Growth Company**

This award recognises a **company** that has shown **tremendous pivot strategy** during the pandemic **with an annual revenue of RM 1 million – RM 10 million**.
