RESOLUTION NO. 2005- 329

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ACCEPTING A WARRANTY DEED FROM THE SCHOOL BOARD OF ST. JOHNS COUNTY, FLORIDA FOR THE FORMER HASTINGS ELEMENTARY SCHOOL SITE INCLUDING APPROXIMATELY 42 ACRES.

RECITALS

WHEREAS, the former Hastings Elementary School was closed at the end of the 2004-2005 school year with the opening of the new South Woods Elementary School; and

WHEREAS, the School Board of St. Johns County, has designated the former school site to be surplus and has agreed to convey same, for no consideration, to the Board of County Commissioners of St. Johns County; and

WHEREAS, continued growth in St. Johns County increases the demand for space to continue County government operations and to provide services directly to the community; and

WHEREAS, the School Board of St. Johns County has agreed to transfer ownership of the former school site to St. Johns County, including three parcels (PIN 037200-0000, 040170-0000, and 039400-0000) consisting of approximately 42 acres, by Warranty Deed attached hereto as Exhibit "A", incorporated by reference and made a part hereof; and

WHEREAS, it is in the best interest of the County to acquire this property for future County use and for the benefit of the community.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

- **Section 1.** The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.
- Section 2. The Board of County Commissioners hereby approves the terms herein and agrees that the former school site will be used for government, public and/or community services only. If the aforementioned uses cease to exist, the property will revert back to the School Board of St. Johns County.
- Section 3. The Clerk is hereby instructed to record the original Warranty Deed in the official records of St. Johns County, Florida.




