1. Introduction

Welcome to the PolkaFantasy website, owned and operated by QuantumMeta d/b/a PolkaFantasy ("PolkaFantasy," "we," "us" or "our"). These Terms of Use (these "Terms") govern your access to and use of the PolkaFantasy website; including without limitation the creation, purchase, sale, exchange, or modification of certain digital NFTs; our online and/or mobile services, and software provided on or in connection with those services (collectively, the "Service").

This Service also allows you to sell and purchase NFTs (as defined below). MetaMask is an electronic wallet, which allows you to purchase, store, and engage in transactions using our supported cryptocurrency. Before putting up your unique digital NFT for Auction or putting in an offer to purchase a unique digital NFT from another user, we will ask you to download a supported electronic wallet extension, and connect and unlock your digital wallets with that extension. Once you submit an order to sell or purchase a unique digital NFT, your order is passed on to the applicable extension, which completes the transaction on your behalf.

"NFTs" refers to unique non-fungible tokens, implemented on our supported blockchains using smart contracts.

ALL TRANSACTIONS INITIATED THROUGH OUR SERVICE ARE FACILITATED AND RUN BY THIRD-PARTY ELECTRONIC WALLET EXTENSIONS, AND BY USING OUR SERVICES YOU AGREE THAT YOU ARE GOVERNED BY THE TERMS OF SERVICE AND PRIVACY POLICY FOR THE APPLICABLE EXTENSIONS. FOR METAMASK, THOSE TERMS ARE AVAILABLE AT (https://metamask.io/terms.html) AND (https://metamask.io/privacy.html) POLKAFANTASY IS A PLATFORM. WE ARE NOT A BROKER, FINANCIAL INSTITUTION, OR CREDITOR.
