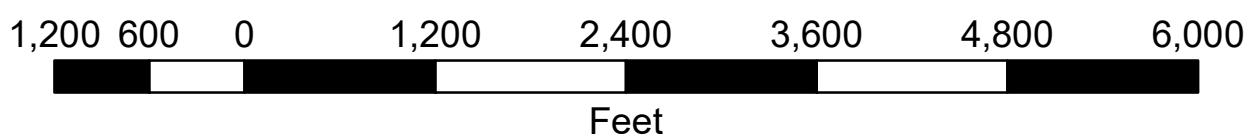


Zoning District Map

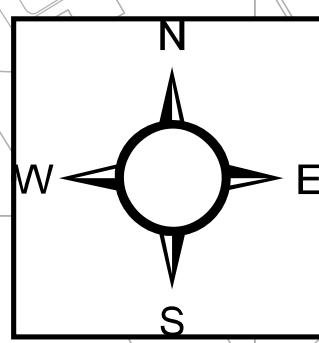
