

**North Sunflower Academy
Educational Contract
2023-24 School Year**

This contract is made and entered into this _____ day of _____, 2023-2024 by and between _____ hereinafter called the parents, guardians, or persons in loco parentis, and North Sunflower Educational Foundation, Inc., hereinafter called The Corporation.

Witnesseth: For and in consideration of the sum of _____ dollars, due and payable as set forth in this contract. North Sunflower Academy does hereby agree to provide education under a fully accredited curriculum in accordance with the rules and regulations as promulgated by its Board of Directors to the child or children listed in the grade level for which said child or children are enrolled for the 2023/2024 school year.

I (we) understand that the registration fee is not deducted from the total tuition, nor is it refundable unless I (we) move from the area. I (we) understand that should a tuition check be returned for insufficient funds, I (we), as a parent or guardian, will be informed by the school administration, and if the financial account is not made current within one (1) week following notification, all children in my family will be dismissed immediately from school and be allowed to return only when the current account is paid in full. I (we) understand that in the event any check is returned for insufficient funds, I (we) will be charged a \$30 returned check fee.

The undersigned understands and fully agree that upon acceptance of this contract by the North Sunflower Academy Board of Directors, I (we) shall become fully and unconditionally obligated to fulfill all terms and conditions hereof, that I (we) will be fully responsible for making all payments required hereunder for the full school year and that no portion of such charges so paid or outstanding will be refunded or cancelled notwithstanding the subsequent absence, withdrawal, suspension, or dismissal from North Sunflower Academy of the below named student or students.

The undersigned understands that a fundraising assessment of \$400 is required to be met for the school year. Parents, guardians, or persons in loco parentis agree to either pay this assessment in full or, to participate in fundraising efforts sponsored by the school or its associated organizations. If the assessment is not fully satisfied through participation in sanctioned fundraisers, then parents, guardians, or persons in loco parentis agree to pay the remaining balance due by April 30, 2024. The Board of Directors will determine the percentage of money raised per fundraiser to be applied to the assessment or school associated organizations at the beginning of the school year and notification will be given. It is the responsibility of the parents, guardians, or persons in loco parentis to contact the school administration in case notifications are not received by mail, email, or sent home with the child/children. It is also the responsibility of the parents, guardians, or persons in loco parentis to contact the school administration as to the fundraisers in which the family wishes to participate.

Persons enrolling said child or children as the parents, guardians, or persons in loco parentis hereby give their consent that the child or children enrolled hereunder will be subject to all rules and regulations of the corporation as promulgated by the Board of Directors. It is specifically understood by the persons enrolling the child or children hereunder that the rules and regulations of the corporation provide for, among other things, corporal punishment for disciplinary reasons, and a random drug testing policy for all students to detect and prevent illegal drug use. Said parents, guardians, or persons in loco parentis hereby consent and agree that said child or children enrolled hereunder may be corporally punished by the Administration under appropriate circumstances without notice to them and will be administered random drug tests.

This contract is essential in order that the corporation may secure and maintain the necessary faculty and physical facilities for the education of the children, which the parents, guardians, or persons in loco parentis wish to enroll in its schools for the 2023-2024 session. I (we) understand that in signing this Enrollment Contract, I (we) agree to accept the rules and regulations of the school as stated in the current handbook and the rule concerning fees as referred above. Furthermore, I (we) agree to the policy of the school that no student will be permitted to take examinations nor will grades and transcripts be released until an account is paid in full.

The undersigned covenant agrees to hold North Sunflower Academy harmless for any loss, harm, or damage claimed to arise out of exercise of any of North Sunflower Academy's rights under this contract.

Miss Code #97-37-13: Parental Responsibility for weapons possession: A parent may be guilty of a misdemeanor and fined up to \$1000 and/or 6 months in county jail for knowingly allowing a child (under 18) to have, own, or carry a concealed weapon.

Payable: Tuition payments may be paid in full, by semester, or in twelve (12) monthly payments from July through June. The twelve payments shall be post-dated checks. The July and August checks must be turned in to the office at the time of final Registration before July 31.
