
Charles Silverstein, Ph.D., author of A Family Matter, plans to be in


FAFOG News Items: Our appeal for temporary housing has resulted in one response for which we are grateful. Also, we have had a donation toward the expense of getting the News Letter out.

See you March 16th and April 13th. Bring a friend; bring your son or daughter but come; we need each of you.





Next meeting: Sunday, June 8, 2:30 p.m. @ MCCR, 1919 Decatur. There will be a panel discussion on "Understanding Special Needs of Our Gay Sons and Lesbian Daughters." The panel will include a social worker, a minister and a business man. We have a commitment from Rev. Charles Larsen, pastor of the Metropolitan Community Church of the Resurrection and also one from Lee Harrington who is the acting president of the Houston Gay Political Caucus. One thing which we learned from attending a program at one of our local Presbyterian churches was that young gay men, especially, are often reluctant to attend church with a lover because of the fact that they are fearful of the poor welcome which they might receive. We feel sure that this is a fear of parents for their loved ones also; in that regard our meeting on the 8th should be helpful in answering many of your questions of a religious nature. We also feel that parents are interested in knowing what to expect should one's co-workers, supervisors, etc. find out that someone is gay; and how should we, as parents, handle a situation which might be fraught with personal problems of all kinds. This panel will be of great help.

FAFOG News Items: Annella has accepted an invitation to take part on a panel about Alternative Life Styles as part of a June 18th Texas Extension Service Conference @ Texas A.& M. University at College Station.

According to information in the May 29th issue of the Montrose Star many national corporations now include in their non-discrimination policies lesbians and gay men. Among these 120 plus such are Exxon, IBM, Bank of America, Proctor & Gamble Co., Adolph Coors Co. and American Airlines. The United States Supreme Court will soon rule on the constitutionality of an Oklahoma statute which authorizes the firing of teachers who promote gay rights or who discuss homosexuality in a positive light. The Oklahoma law was promoted by Anita Bryant (former Miss Oklahoma) and was patterned after the so called "Briggs Initiative" which was defeated by California voters in 1978.

Parents Flag filed a friend-of-the-Court brief in the case arguing that the homophobic law violates the First Amendment because it: (1) discourages teachers from reprimanding students who harass or assault lesbian or gay students (2) interferes with freedom of religion because it can be used to fire teacher who stand up for gay rights in religious debates; and (3) infringes on the rights of teachers to engage in labor negotiations because, under the law, teachers could be dismissed for attempting to secure a sexual orientation non-discrimination clause in a union contract.

The Court heard oral argument in January and a decision is expected in June. Los Angeles attorneys, Thomas F. Coleman and Jay M. Kohorn represented Parents Flag in the case.

California Attorney General John Van de Kamp joined with New York Attorney General Robert Abrams on a brief which urged the Supreme Court to invalidate the statute. LETTERS AND NEWSLETTERS: Sacramento: reports that the local Lambda Community Fund is advancing money to fund a law suit against Falwell for remarks during a July 1984 broadcast of "Look Who's Talking".

San Francisco: reproduces, from The Advocate, an interview with Adele Sta President of the Federation of Parents and Friends of Lesbians and Gays... Also reports that The Office of Technological Assessment, an independent analytical arm of Congress, has criticized President Reagan and Secretary of Health and Human Services Margaret Heckler for not appropriating enough funds to fight the AIDS crisis..."

Colorado-Denver: reproduces, in full, a letter sent by one of the parents to a local newspaper on the occasion of the suicide of a gay person... Reports that attendance at the December meeting numbered almost 200. The February meeting which marked the 5th anniversary had an attendance of almost 130.

Illinois-Chicago: reports that the voting strength of 17,000,000 lesbians and gays is greater than the total voting power of Hispanics, Jews and farmers combined. Also states that communication with elected representatives, thru the mails can be decisive in influencing an official's vote.

Louisiana-Baton Rouge: brand new and eager to grow - a newsletter each month, and geared for action calling on parents to express appreciation to the sponsors of the TV airing of "Consenting Adult." 
FAFOG News Items: Annella participated on a panel with members of Alternative (a College Station group) as part of the Texas Agricultural Extension Service State Staff Conference. The panel was on "Alternative Lifestyles" as part of the section The Impact Of Change.

During Gay Pride Week Thelma Hansel made a presentation during the Day of Remembrance Service at the First Unitarian Church. She pointed out the need for support by families for their gay children and for each other. Annella accepted an invitation from Gay Parents to ride with them on their float in the parade on the final day of the week. It was a tremendously exciting experience.

We are all saddened by the death of Fred Paez, Sec. of the Houston Gay Political Caucus. His death at the hands of a Houston police officer leaves us with many doubts. Those of us who knew him as the caring person he was extend our sympathy to the Gay Community where he was an advocate of law and order.

Does it alarm you who are parents, and you who are friends, to know that there are such biased persons in this town that they would actually threaten some of our young men with knives and firearms? An incident has been reported to us which occurred in the southwest part of Houston (miles from the Montrose area) on the night of July 3rd when an ugly group of men decided to try to "get rid of" these young men who were in their apartment minding their business. Perhaps we, as parents, could address this at our meeting on the 13th. Remember, it could happen to one of our loved ones; surely there is something we can do.

In response to an invitation from the Univ. of Puerto Rico, School of Social Work, the Nat'l. Federation participated in a special seminar for more than 70 representatives from every major educational institution and social agency of the Island.

The seminar's main theme was "improving the P.R. social structure by working with Hispanic families in their homes"..... "Combatting physical, spiritual and emotional poverty through professional assistance and support....."

The presentation and "discovery" of PFG outreach programs provided an entirely new dimension of supportive services for families. Exceeding interest was generated through discussion and our display of PFG resource materials. Specific requests were made for PFG resource materials to be translated into spanish for their general use and distribution. It was further suggested that Federal Funds be requested from the Dept. of Health & Human Resources to enable and provide the translation and distribution of PFG resource materials.

PFG/CHICO, Calif......has a very long "out-reach".....serving parents from Paradise, Oroville, Yuba City, Susanville, Corning and Modesto!....a 75mile radius.

The last of August, 1980, Harlen Adams, facilitator of the Chico group, addressed the Rev. Jerry Falwell in a letter: "Maybe I need some help, for I find it impossible to understand how you can preach the gospel of love and yet be so vitriolic toward one of America's largest minorities, the homosexuals. What would YOU do with twenty million human beings whose orientation does not happen to be the same as yours?"....."I have always thought that the church was not a country club for saints, but a hospital for sinners."

note: this letter exceeded Chico's 75 mile radius and arrived in Washington, D.C. at Falwell hqtrs. We can't help but wonder if and how Rev. Falwell responded.....

Please Harlan, let us know!

PFG/HOUSTON, Texas.....invited representatives from Dignity, Integrity, Lutherans Concerned and the Houston Jewish Group to their December meeting.....giving parents and others the opportunity to learn and know how gay people maintain ties with their religious beliefs and backgrounds.

The Texas Gay Conference, VIII will be held in Houston during the 1981 Labor Day week-end. Parent groups from Houston, New York, Calif. & Florida have been invited to participate.

In Nov. 1980, representatives of the Houston support group were invited by the Univ. of Houston, Continuing Education Ctr. to participate in a workshop for mental health practitioners to help them better understand and work with clients who might be gay or lesbian.

UPF/PHOENIX.....the United Parents & Friends support group starts their "Happy New Year Resolutions with the following: "It's that time when we reflect on the old year & get it together for the new one. Time to thank those parents & friends who, five or ten years ago, learned their son or daughter was Gay, established an organization and were there....when we needed help."

UPF/PHOENIX, continued.....

the first meeting of 1981 should be interesting.....three special guests from the "gay community" will share their concerns & experiences with parents. The son of one parent, who was recently discharged from the Navy, will provide an insight on Gays in the military.....and the inconsistent manner in which charges of homosexual involvement are handled.

PFG/CAMP HILL, Pa. comments in their newsletter....."our meetings are more meaningful when gay men and women also attend"....

Representatives from the Camp Hill support group were invited to "rap" with approximately 100 college students (and faculty) in early November at Susquehanna University.

A follow up letter reads; "please convey our thanks to.....for their sharing in experiences of themselves with our students and faculty at Susquehanna. Even though not everyone changed their feelings about gayness, they were very appreciative and commented positively....."

PFG/BOSTON, Mass. of recent months, PFG/Boston has expanded their resources and contacts for referrals, etc. Of particular are three private agencies who provide support for troubled gay youths: BRIDGE OVER TROUBLE WATERS, COMMUNITY FOR GAY YOUTH, and the MASSACHUSETTS ADOLESCENT & FAMILY SERVICES.

As guest speaker at a PFG meeting, Ed Roche, (social worker, MAFS) spoke of the "special problems" that face gay youth on Boston's city streets. He stressed that very few support groups--either state or private--exist to serve gays with family or personal problems. When gays are referred to an agency for help....their sexual orientation is either denied, suppressed, or an active effort is made to alter their sexual identity. Gay youths are not welcomed in group homes because "it is feared that homosexuality is infectious".....

Mr. Roche made known the fact that his agency is searching for prospective foster parents or singles who can emotionally support and counsel gay children.

Annella took part in a KPFT program on Oct. 14th--the anniversary of the Gay Rights March on Washington.


Due to circumstance beyond our control this is our first Newsletter and meeting since July. With the help of each one you we will remain active; we need your support and look forward to seeing you the 14th.

Now to bring you up-to-date on what went on in October. Freda and Ann were asked to give a presentation about Family and Friends of Gays both days of the Texas Gay-Lesbian Conference at the University of Houston. Frank manned our information booth there.

Ann, Freda and Frank attended an October 28 presentation, at Bering Methodist Church, given by Dr. Robert O'Brien of Montrose Clinic who discussed the role of the Clinic in the Houston Gay Community. The presentation was well done and very informative. We appreciated his talk.

We now, as some of you know, have a library of good books for our members to check out for the price of the book. This price is a must so if a book is not returned we have the money to replace it. The books may be kept from the meeting one month UNTIL THE NEXT MONTH'S MEETING which is one month. Your money will be returned when you bring the book or tape back, meaning that it doesn't cost you anything to read the book. We also have the tapes of the International meeting of Parents and Friends of Gays which was held this year in Los Angeles. They are good, and as soon as we make a copy of each of them, they will be available in our library also. They are very informative.

Frank and Freda attended an election party at Kindred Spirits, a woman's club, to watch the returns and to celebrate with the Gay Community. Debra Danburg came by and it was nice to meet her. It was a happy and late evening.

Ann, Freda and Frank have been invited to participate in a Parents night at Kindred Spirits where the Gay Community will bring their parents. Marion Coleman has made up some beautiful brochures of Familys and Friends of Gays and we will share Family and Friends of Gays with the parents there.

We have also been invited to speak to the Rice University Gay group and the Lutheran Gay group this month.

As you see, there is a lot of activity for Family and Friends of Gays to be involved in. If you love your gay children, relatives and friends you are missing out on a very important part of their lives - and yours too, if you don't involve yourself with them and us.
