with those rights.

My name is Dr. Franklin E. Kameny. I live in Washington, D. C. I appear before you, with pride, as a homosexual American citizen. If, throughout my remarks, and in your later deliberations, you will keep constantly in mind the second and third words of that phrase-American citizen -instead. merely, of the first word--homoproblems at all with implementing



largest minority group in our country after the Blacks; a community which is now entering the political arena openly, vigorously, and enthusiastically, both as voters and as candidates being voted for.

I could easily devote several times my alloted quarter-hour to a full and detailed recital of those our grievances which our government at all levels should be considering. I will not try. Even an adequate treatment of our abuses at the hands of our Federal government alone would take far more time than I have, even were I to limit that, in turn, to the indignities visited upon us just by the Executive Branch. Attached to copies of my remarks, which you have received, and which we shall try to place in the hands of all members of the full Platform Committee, is a proposed Platform Plank, the provisions of which will

indicate to you some of the abuses which we feel should be attended to and which properly come within Federal purview in one way or another, directly or indirectly, formally or informally. We point out, however, that the situation is not merely one in which we need or can utilize governmental assistance and protection of our rights; it is one in which government at all levels, but particularly at top and bottom--the Executive Branch of the Federal Government, and municipal governments and police departments -- are our relentless, remorseless, merciless, ferocious, and all-toooften enthusiastic adversaries and persecutors. It is a situation in which our community justifiably feels that our governments have declared and are waging a war against us. No group of American citizens should ever have to say that; it is a disgrace to our

country and everything for which it stands, that we DO have to

There is no rational basis, for example, for denying Federal Civil Service employment, which rarely has any connection with secret information, to homosexuals, as such; the interest of no one except the enemies of our country can possibly be considered to be served by throwing some 2500 persons annually onto the human trash help, by rendering them perm-nanently unemployable or underemployable, through less-than-fully-honorable discharges from the armed services because of homosexuality; there is no pos-sible excuse for diversion of police manpower and court resources badly needed elsewhere--or even if they were not needed elsewhere -to the discriminatory enforcement of sundry municipal ordin-ances and state laws in order to hound and harrass harmless homosexuals who are merely trying to achieve a personal life no different from that accepted as a matter of course for heterosexuals, and to achieve it in ways no different from those utilized by heterosexuals.

We wish to be productive citizens. We are faced with a pattern of pervasive and well-nigh-universal invidious discrimination which prevents us from being so. In general, anyone known to be homosexual is fired or not hired. It is as simple as that, despite the fact that one's out-of-working -hours personal life -- homosexual, heterosexual, bisexual, or asexual -- obviously has not rational relationship to job competence, performance, or eligibility. Not only does our government not lift a finger to assist us, but is is the chief creator, administrator, bulwark, and buttress of the judice and bigotry which underlie that discrimination. Not only does government not attempt to dispel the prejudice and the pervasive pattern of discrimination against us -- our government is the most active conspirator in the perpetration, perpetuation, and reinforcement of those attitudes and patterns.

Our country proudly tells the world that we have no secondclass citizens. Yet, by long standing, persistent, pernicious governmental policy at all levels, homosexual American citizens are forcibly relegated to a situation in which we consider ourselves fortunate when we manage to elevate ourselves as high as secondclass citizenship.

Why should the Republican Party include us and our concerns in its Platform? There are two broad classes of reasons. First: Basic humanitarian considerations and considerations of fundamental Americanism--really closely related to each other: and Second: Considerations of practical, pragma-tic politics--that is: VOTES. I shall address myself to each in order

I stated above, and I repeat, that we are homosexual American citizens; we are that, and we are also homosexual human beings. If you look at our proposed plat-form plank and ask why ANY group of American citizens or of human beings, in this country should have to be placed in a situation in which it is necessary to ask for anything listed there, perhaps you will gain some insight into the depth of and the

reality of our grievances and the pressing need for remedy, and perhaps you will begin to under 11 stand our anger, our resentment, our impatience, and our growing militancy.

Our country's birth certificate. the Declaration of Independence, grants to us -- ALL of us -- the grants to us--ALL of us--the inalienable right--Inalienable--inalienable right -- inalienable-to the pursuit of happiness. That is really what America is all about. To guarantee that right to all Americans is one of the major functions of our government. That right is one of the unique glories of our country. And, of course, that right is one of the major f8nctions of our government. That right is one of the unique glories of our country. And, of course, that right is meaningful only if it refers to the happinesses chosen by each individual citizen for himself, not merely those happinesses granted him by his government or allowed him by society. But when we, as homosexuals, wish to pursue our happinesses--interfering with no one else in the pursuit of their happinesses -- we are hounded, harrassed, and presented with often-insuperable obstacles at every turn. And not only do we get no redress from our various governments, but they are the most rabid zealots of all in doing the hounding, harrassing, and placing of obstacles, with a singular rarely equalled elseferocity

Our society takes pride in its pluralism. But you had better But you had better pluralism. realize just what puralism means and where it leads. It means not only that the enjoyment of no right, privilege, prerogative, be-nefit, advantage, or eligibility of citizenship can properly be made contingent upon popularity, but also that when a group of citizens are unpopular -- ANY group of citizens, and no matter how unpopular the government has a duty and an obligation not only to protect those citizens in the enjoyment of all the benefits and prerogatives of their citizenship, but a duty and an obligation as well, to work vigorously and effectively to dispel the existing prejudice, bigotry and discrimination which prevent that enjoyment, from whatever direction they may come. In 1960, during the administration of President Eisenhower, the President's Commission on National Goals, in its Report, put it well when they said: "One role of government is to stimulate changes of attitude

The government and our political parties have played that role admirably in regard to our other minorities. We expect them to commence to do so with regard to this last major, heretofore neg-lected minority group; our homosexual American citizens.

In a pluralistic society, every minority group can properly say--and we do say--that for us as homosexual American citizens, this is OUR country, and it is OUR government, and he is OUR President, and they are OUR poli-tical parties--and this is OUR Republican Party, for us as homosexuals quite as much as for you as heterosexuals. That places an inescapable obligation upon you, as an American political party. We ask--we insist--that you shoulder your obligation, and do so NOW

And so we have come here to ask for no special favors or dispensations, for no crumbs from your table, for no condescending, patronizing, demeaning, degrading and dehumanizing compassion or pity. We are asking for--and ever more of my people would say that we are quite properly demanding--that which is OURS, by right to begin with, and which we should have been enjoying all along, not fighting to obtain. We ask for no more than other citizens, but we will settle for not one whit less--nor need we settle for less, as long as America represents all that it claims to represent. Nor can you give us less, consistent with the Americanism for which you claim to stand. We are an impatient minority; we are an in-creasingly angry minority. Your Party and its spokesmen at the very highest levels have claimed that the Republican Party, the Administration, our government, and our whole system are sponsive to the citizenry. Here is the test; we are waiting to if you will make good that

In summary, homosexual men and women really want nothing more than or different from what everyone else wants -- and what in our society and culture everyone is brought up to expect as a matter of course--their basic rights and equality; their human dignity; acceptance of them and judgement of them upon their own personal merits and by criteria relevant to the basis of judgment; the active and affirmative assistance of their government in the achievement, implementation, and enjoyment of their rights and in the eliminat-ion if institutionalized and societal discrimination -- and the right to love whom they wish how they wish -- all while being true to themselves as the homosexuals that they have an absolute moral right to become, to be, and to remain. We do not have these things. We have a right to have them. We are going have them. Our votes will go to those most likely to give them

And that brings me to the stuff and substance of politics: votes.

Some 10% of the voting population of this country is homosexual. That 10% cuts equally across every possible segment and subdivision of society and population: race, religion, gender, ethnic origin, age, occupation, geographical resocio-economic status. educational level, affluence -- and political party affiliation.

Thus, since our country is divided more or less equally between the two major political parties, it is likely that our gay citizens are also equally divided, although no census of gay political party membership has been taken that I know But an oppressed minority tends to give priority to their oppression and its alleviation. As things stand at this moment, the Democratic Party and its candidates have made provision for us-perhaps not quite as much as we might wish--but they have come through. And so, for the moment, likely that they have the majority of our 15 million votes in their pocket. If the Republican Party comes through equally, they will get back some half of these votes -- no small number. If they do better than the Democrats, they may well get more than half those

And the Republican Party can do this, at this time, at no possible to themselves, only gain. The Democratic Party was fearful lest those Democrats who might it offensive to cast their votes for the candidate of a party supporting rights for homosexuals, might defect and vote Republican. Nevertheless, they did include us. Therefore the Republican Party need have no corresponding fear, because a defection from the Republican ranks for this reason would gain these bigots nothing, since they would now have no place to which to defect. In any case, however, the argument is specious for either party, since there are enough of us so that every vote lost through supporting us will be offset by several gained.

I point out, additionally, that personal freedom, individuality, the right to one's life-style, the right to be different and not to conform, which are the basis of Americanism, are of particular importance to our younger voters of all political persuasions. This issue of homosexuality is the ultimate test of sincerity and dedication on those sensitive questions of personal freedom. With astute and considered treatment, much political capital can be made of support given us.

Let me say, finally, that while we feel strongly about adoption of the detailed platform plank which we have proposed here, or some closely-approximate variant upon it, and we are working through every possible means to have adopted, if you should choose to incorporate our concerns into your platform through more vague and ambiguous language, I urge that in doing so, you take pains, by one means or another, to make it publicly, formally, and officially clear, for the record, through some sort of equivalent to a "legis-lative record" as it were, that homosexual American citizens are, in fact, explicitly included in the Republican Party platform. The Democratic Party has done this.

Severe limitations of time have necessarily forced this to be a somewhat superficial and simplistic presentation. I have left a few minutes, and will welcome quest-ions, comment, dialog and discussion for as long as you may wish. I will be pleased to discuss these matters with any of the Subcommittee members who may wish, more informally later on today. We look forward to seeing a gay rights plank in the platform of the Republican Party.

HOMOSEXUAL RIGHTS

A Plank proposed by The National Coalition of Gay Organizations to Committee on Resolutions the (Platform) for inclusion in the 1972 Platform of the Republican National Party to be adopted at the Republican National Convention.

Sexual Orientation

Millions of gay women and men in this country are subject to serve social, economic, and legal oppression because of their sexual orientation. We affirm the right of all perwons to define and extheir own sensibility, empress otionality, and sexuality, and to choose their own lifestyle, as long as they do not infringe upon the rights of others.

Republican administration will:

Urge repeal of all laws, federal and state, regarding voluntary sex acts involving consenting persons in private, laws regulating attire, and laws used as a shield for police harassment.

Enact civil rights legislation which will prohibit discrimination because of sexual orientation in emplayment, housing, public accommodations, and public services. Eliminate sexual orientation or preference as a criterion for emplayment by all public and governmental agencies, in work under federal contract, for service in the United States armed services, and for licensing in government regulated occupations and profess-

Eliminate sexual orientation as a criterion for obtaining or retaining loans, insurance, and bonding. Eliminate sexual orientation as a criterion for immigration to the United States.

Upgrade to honorable all less-than -fully-honorable military dis-charges previously issued solely because of sexual relations between consenting persons or because of allegations relating to sexual orientation.

Seek release of all persons incarcerated in prisons and mental institutions for victimless sex

H.E.L.P. President

Larry Townsend

Tells Press

Los Angeles, Calif: On Sunday, August 20th, just before 6:00 PM, approximately 15 officers of the LAPD Wilshire Division raided a H.E.L.P., Inc. benefit, being held at the Black Pie Tavern, 2440 So. La Cinega Blvd., Los Angeles. This was a gathering of some 300 to 350 people, all of whom had come to the location for the specific purpose of assisting H.E.L.P., the second largest homophile service organization in the United States. in launching its fund-raising campaign for the opening of its new Community Center, located at 7221 Santa Monica Blvd., West Holly-wood. I would further emphasize that this was a private gathering, with a \$2.00 donation being requested at the door. Everyone who entered the premises were fully aware of the nature of the organization they were supporting. Although most of the people were outside, in one of two patios all during bright, daylight hours - the gathering itself was not visible from the street. In other words, the police were not "protecting" anyone from inadvertantly having to observe us.

H.E.L.P., Inc. - H.E.L.P. being an acroynm for: Homophile Effort for Legal Protection - has been in existence for almost four years, and is a non-profit, tax-exempt corporation under California State law. We have always been noted of the "conservative" one organizations within the Gay movement. We are a membership group, with almost 800 individual members, most of whom come from the professional, and semiprofessional and working, middle class strata of society. We also class strata of society. We also operate a Tavern & Guild Association, with approximately 60 business members. It has always been H.E.L.P.'s position to co-operate with the police and other regulatory authorities, and to insist that our member establishments adhere to the laws and other rules laid down by these

But in this instance, our "Establishment" orientation didn't seem to make any difference. Nor did it matter that our gathering was being closely scrutinized by our own internal monitors, to assure that no actions took place which could be construed as violations. They still arrested 21 of our people on trumped-up charges of Lewd Conduct!

Why did it happen? Why did they decide to attack H.E.L.P.? The answers are all too obvious. First, we were engaged in registering voters and had three voter registrars on the premises. During the course of the otherwise random selection of arrest victims, several of the officers were heard to ask: "Where is the guy who was sitting at that table?" - gesturing toward the voter registration table. Secondly, we are convinced that the officers involved in plott-

ing this outrage were seeking to prevent H.E.L.P. from opening its new Community Center, which would allow us to dramatically expand our services. And make no mistake about it. This entire assault was carefully planned in advance.

By the officers' own admissions, several of their number had been on the grounds for close to two hours before the raid. The violations they allegedly observed were supposed to have taken place over that extended period of time. Had the police been concerned with preventing these alleged "cri-mes", they had only to have arrested the person or persons involved, and it would certainly have stopped any further activity. Had they really been interested in "crime prevention", they could have identified themselves to one of the H.E.L.P. offercers, all of whom were wearing name tags to identify themselves, and asked us to "tighten the reins." But they chose not to do this because: 1) There were no violations taking place, and 2) They wanted to make a mass arrest in the hope of destroying the organization. Upon entering the premises, the leader of the uniformed raiding party stated: "There is going to be a mass arrest," after which we were ordered to stand against the patio wall. Except for the selection of myself and our Tavern Guild Director, and the unsuccessful hunt for the voter registars, the arrests were on an arbitrary "you, you and ' basis. At the end of the raid. officer was heard to tell another: "We have room for two more," at which point the policemen inside obliged by selecting two more victims.

Now, this is not the first instance of police harrassment of our bars, nor can it be termed an isolated incident. It simply happens to be the largest raid in the history of California - and, naturally, in an election year. In the majority of cases where "Lewd Conduct" arrests take place in or near our bars, the circumstances are no more valid than they were at the Black Pipe. All a person has to do is to appear to be homosexual. and he is an open target for the Los Angeles vice squad. Some of these arrests involve physical mistreatment by the arresting officers...beatings, shoving the arrestees against lamp posts or car doors, and other terrorist tactics. Later, in court, the officers will get on the stand and lie about it, claiming that the man resisted arrest or attacked the officers. There are innumerable instances where the police malpractices have been so gross that the average citizen refuses to believe it could happen. That's one of the tragedys of the whole situation! It is difficult for any of us who had any of us who have been brought up to respect the law and the men in police uniforms, to equate this type of behavior with the lessons we were taught at home or in school. The cards are generally so stacked against these defendants that they are forced to give up



without a fight - to cop a plea, pay a fine, and ever after go through life with a criminal charge on the record. But this time, we're not going to lie down and take it!

Of the 21 people arrested on

these Lewd Conduct charges, 100% have agreed to plead not guilty and to fight their cases as far as they can go. In doing this, all of us stand in basically the same position as the non-violent civil rights demonstrators who have been arrested while trying to force an unresponsive, disinterested government to pay some attention to their legitimate minority needs. The one major difference in this situation is that the notarity has been thrust upon us. We did not seek to become "examples" or "test cases" or martyrs to any cause. At this point, however, we are angry enough over this affront to our rights as American citizens and to our intrinsic human dignity that we simply are not going to let them get away with it!

We already have the support of many, many people, both heterosexual and homosexual, with more pledges coming in every day... churchmen; county, city and state officials; political club people; professionals such as attorneys, doctors, psychologists . . . all of these have expressed concern, anger and indignation. We presently have fourteen (14) of the finest trial lawyers in Los Angeles working on these cases. No legal stone will be left unturned, and all of H.E.L.P.'s considerable resources are being mustered in our effort to re-introduce the provisions of the American Constitution into the administration of Los Angeles Police Chief Ed Davis.


Montrose Gaze on the Move

Montrose Gaze began in June, 1972, with three people who had an idea: to form a community center geared to Houston's homosexual population. The idea was to provide basic services such as legal council, parent education groups, recreational facilities, switchboard, counciling, and other much needed services not readily available to our community. Since we have been building memberships, working on our incorporation, holding fundraising events and collecting needed quipiment. We are holding off on renting a building until we become incorporated and have sufficient funds to guarantee we are not just a "one night stand". The incorporation is the least of our problems.

On August 20, Slugs, a bar in Montrose area, lent us their facilities to hold a Gay benefit dance. The dance was a success, almost 600 people attended and we took in almost \$700.00. This money swelled our bank account to \$800, our membership grew to thirty. We were excited and wanted to open our doors immediately. But with the realization of rent, telephones, legal fees, deposits, and much more, within no time we would not have been able to maintain our facilities and provide these much needed services. Although \$800, sounds like a large amount, it is just a drop in the bucket, so on September 24, we will have another dance at Slugs. Tickets will be \$1. in advance, \$1.50 at the door.

Although money is always needed, people are our prime concern. Having a functional community center is also important. Without the gay community, all we will ever be is a building. Come and join us, everyone has equal say in all matters.

BOSTON GAY MEN BATTLE POLICE HARASSMENT

BOSTON -- "The Block," one of the most popular cruising areas in New England, has been the focus of increased police harassment in recent weeks, but the gay community is fighting back.

Dozens of arrests of men walking on the sidewalks in this area have occurred in July and August. The common procedure is for plainclothesmen, working in pairs in unmarked cars, to make arrests for "disorderly conduct."

Charles Bevitt, a member of boston's Gay Male Liberation (GML), is one of several gay men who are fighting back by refusing to plead guilty. The most common procedure has been for the arrested persons to plead guildy, paying a small fine, or, in some cases, merely having the arrest noted on police records.

Bevitt appeared in Municipal Court on July 24, the morning after his arrest, and pleaded not guilty (as did two co-defendants arrested on The Block). Judge Elijah Adlow denied a motion for a two-week continuance and proceeded to try Bevitt and the others on the spot.

A plainclothesman testifying against Bevitt noted that this area -the block bounded by Common-weath Avenue and Arlington, Berkeley and Marlborough Streets -is known as "Queen's Row."

Bevitt told The Advocate Liberation News Service that "Adlow's attitude throughout the trial was offensively flippant with such tacky comments as 'They don't call it Queen's Row after Queen Elizabeth, you know!'

Judge Adlow gave the courtroom spectators (including several gay brothers who came to show solid-arity) a brief speech about the status of The Block, noting that under ordinary circumstances walking on the street late at night does not constitute "disorderly conduct," but that since this neighborhood is "notorious" gathering place for homosexuals,

it is permissible to consider mere presence there as grounds for such arrests.


The judge pointed out that the neighborhood, located at the edge of the Boston Public Garden, was once "one of the finest in the city," and that the police have an obligation to protect the public and the homosexuals. He said that the clean-up of The Block was for the homosexuals' "own good," since gangs of ruffians might frequent the area to do violence to these

"unfortunate people."
Peering down at Bevitt, who is tall and slender, Judge Adlow said, "I don't know whether you are a homosexual or not -- for all I know you are a prize-fighter." He then found Bevitt and the others guilty and fined them each five dollars. All three filed appeals.

In a leaflet prepared by Bevitt and other GML members, Bevitt

"I contend that my conduct (being a homosexual in a 'notorious area') is not disorderly; we intend to appeal this case into Superior Court with a jury trial. Our defense will be that I was on the block, as a homosexual and have as much right as anyone to be on the street. (The streets belong to the people!) A verdict of not guilty will hopefully set a pre-cedent which will stop such ar-rests. Failing in the Superior Court, we intend to continue to the State Supreme Court and have the disorderly statute thrown out as unconstitutional. It's been done before with the old puritan law about 'being abroad at night'; we'll do it again. Dare to fight, dare to win!''

Another leaflet distributed by the Homophile Union of Boston (HUB) warned pedestrians on The Block about the current wave of police harassment. HUB also suggested a plea of "not guilty," pointing out that "if enough cases are appealed and overturned, it is more than likely that the number of arrests for 'disorderly' and the like will be drastically diminished."

PISCES: The most pschic of all



EGYPTIANS: THE PROPERTY OF

Dr. Paul Brand of Leipzig University once wrote that the oldest record of homosexuality "dates back more than 4500 years, and is to be found in an Egyptian papyrus which proves that it was at that time widespread in Egypt (and) was presumed to exist amongst the gods as a matter of course." This would be centuries before Moses. Herodotus also attest to ancient gaydom in Egypt.

Those papyri also contain some other things of interest, and one example is given above in the illustration. It is those papyri and those Egyptian heiroglyphs that gave us one of the earliest pictographs of the pahllus.

As can be seen, its form has changed little into modern times. It has moved from the walls of temples to the walls of johns, or so it appears, but with little change in meaning. This needs clarification.


Egyptian glyphs were often used literally, the glyph carrying its meaning by itself. Thus the phallus glyph conveyed the idea of "masc-uline" or "beget" or "copulate". -This is still the general meaning which appears in the john.

On the walls of temples and in papyri, however, the phallus mostly appeared in combination with other symbols rather than alone. The meanings were meanings generally figurative, so it was not such usage that moves to the john. It was seldom there to begin with.

The copy of the glymph shown in the illustration is the way that the word "true" or "righteous" was written in the Papyrus of Ani and other papyri. A variant form of it meant "testimony". The im-plication of a rather high level of meaning is clear.

Such a conclusion is even more apparent in the most common glyph involving the phallus. It is used in the pictograph meaning "in the presence of" or "in front of", and is always followed by the name of a high diety or an allusion to





one. I t is always linked to reverence or holiness.

There must be a moral here somewhere, and it is probably this: sex, like its symbolism, can be fixated on the literal or the base, sex, like its symbolism, can be ionally incesturous.

IF GAY PEOPLE WOULD USE THEIR CENTS, FREEDOM WOULD BE OURS!

Twenty years ago 0 N E (america's first gay publication) suggested a plan that would unite gays and at the same time put an end to discrimination and hatred. The PENNY A DAY plan was quite simple and would work like this.

There are between 15 and 20 million gay adults in America. If everyone of us put aside just one penny a day and donated it to a giant GAY FREEDOM FUND we'd have better than SIX MILLION DOLLARS A YEAR to work with. Think of it. For a mere \$3.65 a year, freedom could be ours. Imagine what we could do with that kind of money!!!

- 1. We could keep a battery of nation's best lawyers to fight police harassment and military, government and public discrimination. We could appeal unfair decisions and fight for our rights all the way to the Supreme Court, if necessary. We would win, but quick!
- 2. We could employ professional lobbyists to influence state and national legislation on our behalf. Big industries do it -- all the time. Why can't we?

Oh, there are those who will

say one can't end hatred by striking down old laws and replacing them with fair ones. Of course this is true, as we have learned from our black brothers and sisters-they win court decisions, but are still on the bottom fung of our social and economic ladder. But law and order WITH JUSTICE would be a giant leap forward for all mankind, not just gays. To win total freedom we would have to do more. We would have to educate the public.

- 3. We could employ capable women and men to work full time for the gay movement. Speakers could appear at churches, clubs, city councels, schools and colleges to give talks informing the public that we are neither child molesters, nor are we always great musicians or highly paid hair dressers. Mostly we are just ordinary men and women--very much like those sitting in the audience.
- 4. We need, and could afford quality publications, with well-written articles and fine photography on many subjects--not just those di-rected to the gay public. In that way straights would be happy to read our publications. (As it is now, who reads ONE, the NUNTIUS /OUR COMMUNITY, or the AD-VOCATE but gays?) Here we have

a situation where gay speaks to gays. We need to address our-selves to ALL Americans.

5. Every city NEEDS a gay community center--something like the YMCA. A place where gay men and women (straights would be welcome too) can swim, workout, study, dance, watch movies or tv, or just sit and talk. A place where people could get to know people.

On Sixty million bucks a year we could have all this and more. Twenty years ago, the PENNY A DAY plan never got off the ground. People said, "the nation isn't ready for that yet." That's what people told the committee for Dallas's first GAY PRICE CORRECTION

for Dallas's first GAY PRIDE PARADE. "Dallas isn't ready." Crap! The only time Dallas will ever be ready for a gay parade is to HAVE a gay parade. We proved this to be true.

Is the nation ready for gay freedom? I think so. Shall we get off our butts and work? Or shall we wait twenty years more?

HAPPENING

Early this summer, this writer was invited to speak to a group of freshmen students at SMU. The class and I spent a great deal of time discussing homosexuality, its causes, happiness, and police entrapment. The students were polite, interested, open minded,

and asked all kinds of questions. Several weeks later I chanced to meet one of the young men downtown, and we talked for a few minutes. He told me he was 18, popular with both male and female friends, and was considered a "regular guy." He had had sex with girls a number of occasions and although he enjoyed it, he wondered if he wasn't "just trying to prove something" to himself. He felt he might be homosexual because he was very fond of his male friends. He had had one homosexual relationship with a guy he didn't much like, but felt he would have enjoyed it more had it been with someone he really cared for. This writer doesn't consider

himself any more qualified to advise people than any other person, untrained in counseling. But since he did confide in me, and since he was expecting comment, I did the best I could. I told him that at the age of 18 it wasn't unusual to still have strong feelings for male friends. That 37% of the adult male population had had at lease one homosexual experience to the point of orgasm, but only a few of these ever became exclusively homosexual. And if he enjoyed female relationships, why bother to label himself either homosexual or heterosexual. Why not just enjoy sex as it came to him?

Theologians Start Another Movement

Theologians come and go and in their coming and going often leave behind spiritual and moral chaso. It is characteristic of the liberal mind that such chaos constitutes no barrier to fame -- nor to a ready following, when the same theologian comes up with another bright idea.

Remember Anglican Bishop John A. T. Robinson? His book, Honest to God, was the preface to the whole "God is dead" movement and was almost universally hailed in official Presbyterian circles.

The former bishop, now promoted to dean of Trinity College, Cambridge, has done it again. As the invited guest speaker for the British Methodist Conference, he said the current sex revolution should be celebrated by lowering the legal age of consent to 14. He also said he thought the age of consent for homosexual relations should be lowered to the same age (from 21 to 14).

Initial reaction, as was the case when Honest to God first appeared, appeared largely negative. Methodist Conference President Harry O. Morton defended the dean's right to express his opinion,

but said he "frankly doubted" that his 13-year-old daughter would be ready to make mature decisions concerning her sex life in another year.

Mr. Morton qualified his opposition by saying. "I welcome any speech that helps us in this matter to get away from sham and hypocrisy and which puts the real questions." He added that "as a Church leader" he did not want to do anything "to cast doubts on" the Church's ability to discuss the issue to its advantage.

An official of the Boy's Brigade, youth group claiming 160,000 members in England, said he felt sure his organization definitely "would condemn sex at the age of 14."

We'ss try to keep up with the debate as it proceeds. Sooner or later the course, it will cross the Atlantic and wind up in a PCUS General Assembly resolution. After all, won't the Church's

stitution, marijuana possession, obscenity, and sex acts between consenting adults; the other titled 'single person's bill of rights', which included repeal of tax'laws prejudicial to single persons and elimination of discrimination against singles in housing, hiring, insurance, and credit (these resolutions were passed by the Law Students House of Delegates and will be presented to the full A.B.A. House of Delegates in February).

Other speakers were present: Dr. Barnett, visiting professor at Hastings Law School spoke of ways in which the sex laws could be attacked on constitutional grounds. Tim Starnes, a student bar president, talked about a law student research project for S.I.R. which

will result in a Form Book of Motions and Pleadings that will be made available to lawyers representing gay persons charged with violation of the sex laws. It is expected that this form book will result in better defense for these defendants for less cost and will prepare cases for constitutional challenge. Marshall Jacobson, Vice Governor of the 9th Circuit of the A.B.A. Law Student Divis-ion, gave some details of the constitutional challenge. Marshall presentation that would be made to the Law Students Division House of Delegates on the two resolutions introduced by he and Tom Coleman. Jim Foster, Political Director of S.I.R., elaborated on the work of the law student re-

GAY RESOLUTION AT A.B.A. CONVENTION

(SIR) S.F., Cal. - The following resolution was presented to the resolutions committee of the A. B.A. on Tuesday, August 15 at 1:30 by the combined efforts of The Society For Individual Rights and Gay Activist Alliance/ New York:

"Resolved, that the legislatures of the several states are urged repeal all laws which classify as criminal conduct any form of sexual conduct between consenting adults, saving only those portions necessary to protect minors and to protect public decency."

Speaking for the resolution were William Thom, A.B.A. delegate GAA/NY attorney; Richard Hongisto, Sheriff of S.F. County; and Donald Lunde, M.D.; Professor at Stanford Medical School, Dept. of Psychiatry. Extensive media coverage was obtained by advance press releases, including two T.V. station's camera crews.

For the first time in the memory of its chairman, the Resolutions Committee was unable to make a recommendation to the Assembly. The committee was split evenly on the resolution. Of the 13 other resolutions before the committee, one was recommended, three were requested to be referred to committees, and the rest were reported out with a "don't pass". Several committee members revealed that the presentation and the fact that a high elected official would testify for it were instrumental in changing their vote from no to yes.

On August 16, the resolution was brought before the Assembly and a motion to refer to another section was made. After a spirited debate, the vote to refer to the Criminal Law Section was passed 140 to

Delegate Thom said after the vote that he considered their efforts had resulted in a partial victory. Predictions made before the convention were that the resolution would be given a "don't pass" by the Resolutions Committee and that it would be killed by the Assembly. He felt that, in addition to the 85 that voted not to refer, many of the 140 were in favor of the resolution but felt it should be studied by a section specializing in criminal law to approve the wording. Thom is confident that the Criminal Law meeting in Cleveland in February of 1973 with a "do pass". Also, he is informed of similar resolutions from the Young Lawyers Section, presented to the House of Delegates. He expressed confidence that the House of Delegates would commit the A.B.A. to support of Sex Law Reform in the

Later in the afternoon of August 15, Tom Coleman of Gay Law Students Association held a committee meeting at the Law Students Convention at the Jack Tarr Hotel. He outlined plans for the submission of two resolutions to the Law Students House of Delegates: one calling for the elimination of laws prohibiting pro-





search project and spoke about efforts with the legislature for sex law reform by the California Committee for Sex Law Reform. He expressed hope that the Whitman-Radcliffe Foundation would be able to fund the work of the law students


GAY CRUISING AREAS: Responses to a SEXIST SOCIETY

I am writing in response to an article called "Midnight Son" by Tim E. Lane (published in issue one of ABRAXAS and MOCKING-BIRD earlier this spring.)

Page 18

I found "Midnight Son", concerning Houston's Montrose gay cruising circuit, very interesting. You reported that situation accurately from your observations. Although possibly not intentional, the thrust of the article is extremely anti-gay.



Underground publications have been consistently favorable with gay reportage. Allen Young's article in the same issue of ABRA-XAS-is a fine example. Meanwhile the establishment media has been rather consistently anti-gay. How ever that situation has begun to improve somewhat recently.

Nevertheless, in fairness, the existence of the phonomena you observed must be explained.

We in the gay movement are aware of the unfortunate dehumanizing gathering places that are for many of us the only means of coming together. Basically our choice has been the oppressive, segerated gay bars or the streets. American society has forced us to live only one way, in shame of our so called "unnatural desires". Gay crusing areas exist as a result of continuing unreasonable intolerance of gays by the majority of straight society. Such segeraged bars and cruising areas are a natural response to a sexist society, like ours.

In recent years the gay movement has begun to attack the lies and myths perpetuated for so long. Some basic thruths being promoted by the movement: Heterosexuality is not an inherited trait. It is a learned response as is homosexuality. Heterosexuality has no natural superority in human sexual activity. It is as natural to relate to the same sex as to the opposite but social conditioning serves to reinforce the rigid sexual stereotype of straight society. Homosexuality is not limited to a very small minority of the population (although only a small number live an exclusive homosexual lifestyle). Scientific findings indicate that there are many millions of homosexuals in America (probably 10% of the total population). Thirty Seven percent of the total male population has at least one homosexual experience during his lifetime. These scientific findings and many others were first documented by Alfred Kinsey and his associates twenty four years ago (Sexual Behavior in the Human Male 1948). More recently other recognized sex research authorities such as Masters and Johnson have supported these positions. Movement folks are all familiar with Wilhelm Reich's truly revolutionary sexual political party of Germany in the thirties. Abolition of laws against abortion and homosexuality was one of Sex-

Only when the truth is fully realized and accepted will we be able to relate as openly, fully and naturally as do heterosexuals. Necessary for our complete liberation, beyond repeal of the antihomosexual statutes, is the neces-sity to bring about a level of consciousness concerning sexism. Briefly (for my purposes here) sexism may be defined as discrimination against certain persons because of their sex or sexual orientation. The following analogy may be drawn: Sexism is to gays and women what racism is to blacks. Laws (or abolition of them) do not correct such prejudices. How do we deal with sexism and racism in this society? Any reasoned discussion would require many written pages. Nevertheless, we are all victims of a puritinical, sexist, racist, male dominated (chauvinistic) society.

(chauvinistic) society.

So much for today's 'Gay is Good' lecture.

To return to your article, I feel that you conveyed the impression of enjoyment enticing "the queers" while cycling on the circuit that night. You speak of peering into one of the cruising cars, leoking into the faces of the cars, looking into the faces of the occupants where you found "the weak, frightened depravity expected". "Poor lost sould", you say, "let the hurt begin." So you cycle off.

Let me cite a few day to day realities that gay people must live with: Fear of entrapment by plainclothes cops; physical attacks (both occur frequently in Houston); serious penlities incorporated in anti homosexual state and municipal laws; fear of discovery which can lead to blackmail, loss of employment, ostracization by family and "friends"; etc.

All things considered, you will certainly agree that living as such can make for a bit of schizophereria.

Kinsey said that there is that component of gayness in all people. Some use it exclusively, some not at all and many are somewhere between the two. But to some degree that gay component is in everyone.

Due to social conditioning mentioned above resulting in the "fear" that one may be gay, one may never know the extent of that gay component in them. My suggestion: "Try it, you'll





In August 1971, somewhere in Buenos Aires, a group of homosexuals of both sexes decided to form the Homosexual Liberation Front. The movement recognizes as its antecedents the analogous homosexual organizations in Europe and the United States, maintaining fraternal relations with some of these, as well as the Argentine publication Nuestro Mundo, which was first published in September, 1969.

Mundo, which was first published in September, 1969.

The source of political inspiration of the Front is its integration with the movements for national and social liberation which function in Argentina. And its

function in Argentina. And its goal is to get these movements to incorporate in their program and strategy the demands of the sexual revolution, without which the liberation of mankind will be incomplete. We understand that our objective entails a complex and difficult endeavor.

We believe that eroticism is a fundamental instrument of freedom. The creation of a New Man requires that the flesh be unalienated and unrepressed, as Daniel Guerin once said. We affirm that it is the unavoidable duty of the revolutionary movement to teach, and cultivate, joyfully and healthfully, the art that is free love. A profound social revolution is not possible without the liquidation of the moral standards of a class society.

We understand that in a repressive society and a world structured on the basis of the oppression of one class by another, of one sex by the other, or some states by others, the abolition of anto-homosexual taboos would be an illusory victory.

The anti-homosexual society is a society which is anti-sexual and anti-erotic, forcing its people in the name of morality to experience with guilt most of the pleasures which human beings pursue in order to realize their tendency to be happy. The liberation of the homosexual is, then, profoundly linked to the process of liberation which will end other forms of oppression, ending the misery, ang-

uish and defiguation experienced by human beings because of the current economic structure and cultural superstructure.

cultural superstructure.

The Homosexual Liberation
Front is determined to put an
end to the silence and the falsehood which surround the subject of
homosexuality. We will strive to
put an end to the marginality in
which we live, a marginality to
which society condemns us, a marginality which we impose on ourselves through self-censorship.
We will strive to end the distance,
the lack of communication and the
contempt with which we are usually

contempt with which we are usually treated, noting that this situation seriously distorts an aspect of human relations -- between those who are oppressed and those who are the oppressors -- and this brings harm to both.

We must have a dialogue to do away with the prejudice, ignorance and fear that the ruling classes have built over the ages. Male and female, masculine and feminine -these categories can no longer be dogmatically accepted in order to satisfy the exploiters of the day. And the dialogue will not be fruitful without ideological equality, that is, without removing the infamous stain which marks the homosexual. It must be understood that the homosexual has the right to live out his other eroticism as seems best to him or her. It is evident that the official morality has its origins in, and has converted itself in the philosophical formula of, a socio-economic institution monogomous matrimony, which was instituted so that private property could be maintained and transmitted in accordance cordance with normal, un-challengeable lines. It is essential that we clear up the myths about sex that have arisen in the name of the conservation of private property, since these myths imply the objectification and alienation of

The Homosexual Liberation Front seeks to regularly communicate its objectives and principles of the movement, and urges homosexuals of both sexes to or-

ganize groups in which to discuss and spread the goals of the movement. Homosexual liberation is part of the sexual revolution which must exist with the social revolution that is sweeping the contemporary world. This is the fundamental contribution, along with the growth of consciousness, which the Front hopes to give to the current process of our society.

The movement has adopted a pink triangle as its emblem. This symbol was used in Nazi concentration camps to distinguish the homosexual prisoners. It has been chosen since it constitutes a synthesis of the ideals sought: human liberation against a society which is classist, authoritarian and repressive

and repressive.

What is at issue is the right of each individual to live without fear, to have freedom of choice,

to be able to control his or her own body, labor and knowledge. (Translation by Allen Young)




