# GAYS BOYCOTT

On or about May 1, 1973 Chuck Berger and Billy Walker went down to the special features division of

to the special features division of the Houston Chronicle and applied for an ad. The copy read:
"Montrose Gaze Community Center serving the gay community 504 Fairview, 528-9069 - open common the control of the contro

Miss Vera Coffin, head of special features division took a personal check for payment of the ad and stated "it (the ad) will be in this coming Sundays edition of Zest, in the Houston Chronicle."

The ad did not appear the following Sunday, nor the following Sunday hor the following Sunday. After three weeks of inquiry as to why the ad was not appearing Mr. Walker tried of the reply the Chronicle was giving; i.e., "the ad was lost in composing", and we misplaced it and it will be in next Sundays edition," Mr. Walker asked to speak to higher authority and was told ultimately (after three

of being put off by the Chronicle management) that the ad would not be put in the paper. The chronicle management refused to give a reason for not printing

the copy.

Mr. Walker called the president of the Chronicle, Mr. D. Johnson, and explained the previous three weeks of business dealings with the Chronicle. The president of the Chronicle then recommended that Mr. Walker take his issue to the Chronicle's advertising director Chronicle's advertising director Mr. Jack Johnson.

Mr. Walker talked to Jack John-son who said, "I have never seen the ad or its contents, but I leave the final decision to my department heads (Vera Coffin - special features) and the decision has been made to refuse to print the ad."

Mr. Walker at this time informed Mr. Johnson that the Houston Gay Political Coalition was beginning a boycot of the Chronicle and was

encouraging all gay subscribers and gay businesses to cancel their respective contracts with the Chronicle. "That, if the Chronicle could not accept money and print an ad for the gay organizations, then it shouldn't expect to make money from gay business owners and gay subscribers."

Mr. Walker, after talking to the advertising director of the Chronicle, called the mayor, radio stations and TV networks and both major newspapers and related the business transaction with the paper and informed the media that there was a boycott in effect. encouraging all gay subscribers

was a boycott in effect.

Mr. Walker then contacted the special feature department of the Houston Post and proceeded to place the same ad in that newspaper -- the ad was accepted and much praise goes to that paper for for not continuing the oppressive position that the Houston Chronicle has taken against the Homosexual Community.

Tests for VD do not take much time and do not cause a great deal of discomfort. In most instances, VD is easily cured. However, "do it yourself" cures or drugstore remedies do not work. Syphilis and gonorrhea can be completely cured if treated early by a doctor. People who think they have been exposed to VD or have questionable symptoms should discuss it with their personal physician or visit their local health department. The City of Houston Department of Public Health operates three VD clinics where anyone, regardless of age, can receive free treatment. They are located at:

# SUSPECT ARRESTED IN GAY BAR FIRE

In the past three years arson hit four gay bars in Beaumont, Texas. The Golden Eye, The Other Place (which was burned in two different locations) and the latest was the Off Main in April this year.

The Off Main suffered mostly smoke damage and was reopened the same week of the fire.

An arson-indictment resulting from an April 13 fire at Off Main Bar, 201 Liberty was true billed by Jefferson County Grand Jury.

Named in the arson indictment in connection with this fire was Thomas Howard Gore, 20, of Port

Neches, now in custody in Miami, Florida. Mr. Gore has attempted to do female impersonations in Houston and Beaumont.

Houston and Beaumont.

The April 13 blaze broke out in a small room under a stairway to apartments in the building in which the Off Main is situated according to police.

Authorities investigating the fire reported that the club owner and witnesses at the scene told them that the fire may have been deliberately set. Fire marshals said evidence at the scene pointed to used rags, paper and sticks to start the blaze.

#### GAY ACTIVISTS CONFRONT

#### HOUSTON CITY COUNCIL

The Gay Coalition appeared before the Houston City Council on

The Gay Coalition appeared before the Houston City Council on two separate occasions May 23 and May 30, 1973 presenting the city fathers with several demands, one of which was to declare June 24 -- June 30 as Houston Gay Pride Week. Walker, Berger and Osborne each spoke before the council. Walker and Osborne appeared before City Council a second time on May 30. The Houston Cit Council and Mayor Louie Welch ond time on May 30. The Houston Cit Council and Mayor Louie Welch refused to act on the Gay Coalition's demands for an official Gay Pride Week in Houston; for an end to job discrimination in city hiring practices; for an end to police harassment of gay people; for a citizen papel to review charfor a citizen panel to review char-ges of police harrassment; and for the city's Human Relations Council to recognize the gay minority in Houston and to include them in its activities.

Houston and to include them in its activities.

At the Gay Coalition's second appearance before City Council, Mayor Welch walked out of the Chamber Room, ostensibly to greet some visiting Japanese mayors who happened to be touring City Hall at the time. Walker remarked into the microphone that Mayor Welch ought at least to have the courtesy to listen to the Gay courtesy to listen to the Gay Political Coalition's demands.

Walker then challenged individual city councilmen to speak up on the gay issues he and Osborne hadpresented to them. Councilman Frank Mann responded by shouting, "You're abnormal. You need to see a psychiatrist instead of city council." Bob Osborne replied that he could recommend a doctor to cure Mann's homophobia. Osborne pointed out that approximately 300,000 homosexual men and women live in Houston and again asked City Council to men and women live in Houston and again asked City Council to act on the list of five demands

presented by the Houston Gay presented by the Houston Gay Political Coalition.

Political Coalition.

After the groups second city council visit, Walker was contacted by a US congressman from Houston, who complimented the group for taking a stand. Walker was interviewed by Linda Lovell of KPFT-FM (Pacifica) radio. Wire services carried Councilman Mann's remarks to Billy Walker. Houston's two newspapers and several radio and television stations carried reports of the City Council's reaction to the Houston Gay Political Coalition.

Billy Walker has stated that he feels that the City Council appearances by the gay group have helped awaken the Houston Gay Community. He also hopes that Gay Pride Week will promote unity among Houston gays and that it will encourage them to stand up and fight for their rights.

In a related action, Walker contacted The Houston Chronicle about running a small advertisement concerning The Montrose Gaze Community Center, the place where the Houston Gay Coalition holds its mostings

holds its meetings.

The Mont4ose Gaze had voted to spend eighteen dollars to run a small advertisement for one issue of the Sunday Houston Chronicle. of the Sunday Houston Chronicle. The newspaper accepted the group's money, but the ad failed to appear in the paper on the following Sunday. Billy Walker called the paper to inquire why the ad had not been run. He was told it was an oversight by the paper and that the ad would be run the next Sunday. The next Sunday came, and still no ad appeared. Walker called again and got the same reled again and got the same re-

After the ad failed to appear for the third Sunday in a row, Walker called and was told that The Houston Chronicle's management had refused to run the advertise-ment for the gay community center. The paper gave Walker no reason for its refusal to run the ad. He was told, "Your copy and your check will be mailed to you and

you can cram it up you."
Walker promised the paper that
some recourse of action will be
taken against it. He suggests that Houston gays cancel their Chronicle subscriptions and their business advertisements in the Chronicle.

# MOTHER OF DALLAS The Emergence of a Gay Culture?

Gays need their own music. Neg roes working on river levees, breaking rocks in prison chaingangs, picking endless rows of cotton had their songs. Without these songs could they have made it? Jews, subject to hate and abuse for centuries had their folk songs to help keep them united. The to help keep them united. The poor Irish and Sweedes labored in the hot Texas sun to build the state's first railroads, and their work songs helped them. Hobos, hopping freight trains during the

hopping freight trains during the depression had nothing, but their music. All oppressed people have had their own special music --except one. Why not Gays?

Many of the world's greates composers were gay. These men wrote from the deepest emotions of their hearts. Then they gave their music to a straight world that neither understood nor cared. But our music need not be a

But our music need not be a mighty symphony. Better it be a simple melody. A melody that can bring us together. Something that comes from one heart and touches another. Such a song has now been written, STONEWALL NATION.

Stonewall was the name of a tiny, insignificant bar the police raided that historic night in June, 1969. After years and years of police harassment, gay people finally could take no more. They barricaded the police in the barand that was the gay shot heard round the world. It touched off a riot involving hundreds. Lord Lambton, until very recently the Air Force Minister, has been caught out consorting with a group of prostitutes over a long period of time. Lord Jellicoe, the govern-ment leader in the House of Lords has resigned after having been identified as another of the governidentified as another of the government leaders deeply involved with the doxies. More revelations seem imminent, and again the persons involved are all dedicated heterosexuals.

Pick up any of our local Houston Dallas newspapers and read or Dallas newspapers and read the police reportpages and you will find an incredible fact: The overwhelming majority of all the crimes reported are being committed by the same sort of person: heterosexuals.

One wonders if these animals are fit to roam the streets! Obviously there is something about their nature which precludes their living among civilized men and women

among civilized men and women without some kind of restraint. And yet they presume to dictate to the homosexual minority their morals and ethics! Traipsing through wonderland with Alice would be a more reasonable role for them to play in society at the rate they're

But possibly this is too simple for the sexually fear-ridden to understand? It would seem so. However, it is certain that eventually the state of Texas will join with other human societies and remove the psychiatrist from the courtroom and the courtroom from citizens' bedrooms in the area of human sexuality. These people, elected by you -- the voters of the State of Texas, hold you in such total contempt that hold you in such total contempt that they did not even bother, for the most part to answer the questionnaire. Indeed, the vast majority didn/t bother to return it, even though a stamped return envelope was enclosed. This is a stiuation which goes far beyond the issue of homosexual rights. It should be the concern of every thinking citizen in this state. For these men to totally and contemptuously ignore our legitimate questions, is a sitour legitimate questions, is a sit-uation beyond belief. It it their right and duty to vote in the legislature as their conscience directs, if they have one, which

at this point I believe we have good reason to question. It was also their right to answer the questionnaire either in the affirmative or the negative. But to not answer at all or to totally ignore it was a gross breach of the trust the people have placed in them. We on our part did everything possible to protect their rights. The questionnaires were completely anonymous, so we have no way of knowing who did and who did not answer, or if they did answer, how. For them to have held the rights of homosexuals in contempt by replying in the negative tempt by replying in the negative would be a thing that others could would be a thing that others could perhaps ignore. But to show this kind of contempt for the voting public is a gross negligence of their duties. Simply because they do not agree with a position, mine or yours, does not give them the right to ignore it. I sincerely hope the next time the citizens of

Nine States: Illinois, Colorado, Oregon, Connecticut, Florida, Hawaii, District of Columbia, Deleware and Ohio have officially recognized this principle and have

Deleware and Ohio have officially recognized this principle and have abandoned the illegitimate, pointless and profitless regulation of private sexual behavior among consenting adults, and as a result, their crime rate IS LOWER, not HIGHER. Such laws against victimless acts are, at best, unenforceable and, at worst, subject to the most arbitrary application. They undermine respect for the law in general because they make felons or miscreants of people whose only offense is their participation of alternative in their enjoyment of conjugal relations or a harmless difference in their choice of part difference in their choice of part

The overwhelming majority of citizens affected by these laws are in all respects responsible and productive members of their com-munity. Those who pursue a different lifestyle often do so more

because of the persecutory laws and social prejudices than because they are inherently promiscuous or "digenerate." The argument that these laws protect society is baseless. How can an act performed IN PRIVATE by CONSENTING ADULTS harm society?

The current law makes oral or anal intercourse a felony whether performed by persons of the same or different sexes, whether the couple is married or not. Clearly absurd. The proposed revision makes homosexual conduct a Class C misdemeanor punishable by fine of \$200.00. It is less severe, but no less absurd. It still turns the State into a peeping Tom, exhibit-

of \$200.00. It is less severe, but no less absurd. It still turns the State into a peeping Tom, exhibiting a perverse prurient interest in the private conduct of its citizens. It reflects a self-righteous moral bigotry unworthy of the respect for person required of a free society.



In this country, money is blood, and the arrests of Gay persons at \$100.00 a head is nothing less than genocide.

More and moreGay people are joining the movement for political



## A LETTER IN GAY LOVE A GAY CULTURE?

Dear Gay persons and friends:

On March 4, 1973, I went with two friends, Don McFall and Mike Martinez, to The Matador, a Gay bar in Birmingham, Alabama. After we were seated, I played some songs on the juke box and returned to my chair, in which, at this time, a dear friend named Nora Kennedy was sitting. I leaned toward her and touched her shoulder in greeting. She called my name, toward her and touched her shoulder in greeting. She called my name,
put her arms around me, and began
crying as she asked if I were mad
at her as we had been out of contact with each other, and went on to
describe personal traumatic experiences she had undergone since
we had last met. My response
was to embrase her in return and
to kiss her libs when she inwas to embrase her in return and to kiss her lips when she indicated that this act on my part was desired. During this exchange, I knelt beside her chair and rocked her in my arms. As she became more calm, I got up and sat on the edge of her chair. We then went to the dance floor and danced to slow rhythmed music and rewent to the dance floor and danced to slow rhythmed music and returned to our table at which time she explained that she had to meet some other friends who were expecting her. About 15 minutes later, an Officer of the Vice Squad came to my table, showed me his badge, and told me to come outside with him. As we walked down the street, he informed me that I was under arrest, and in answer to my inquiry as to the charge, he replied, "Disorderly Conduct". Nora was sitting in the police car, and as he opened the door, saying, "Now ya'll finish what you were doing inside." Nora was crying again and hysterical with fear and

again and hysterical with fear and panic -- reciting passages from the Bible and pleading with the Vice Officer for a show of mercy and human compassion. Her reaction was that of a person whose head is in a guillotine, which, indeed, it was. The Vice Officer responded with "Shut up, bitch" and other derogatory remarks.

Our trial was held on March 14, 1973. The Vice Officer testified that in this dimly lit Gay bar, he could see clearly that each of us was caressing the other's genital areas and breasts and that he could see both our "crotches" (sic) from where he was sitting, even though my back was toward him. Nora, myself, and the two witnesses present at the trial testified that no "sexual" touching occurred during this encounter, and for my part this omission was due to the fact that Nora did not indicate to me that such an action was needed in the immedidid not indicate to me that such an action was needed in the immediate situation. Despite the fact that the Vice Officer, whose name is Orville Jerome Webster, contra-dicted himself in his testimony as regards to our position in space in relation to him and his later saying that his view of us was of our respective fronts, the judge found us guilty, fining us \$100.00 each. We are presently on Appeal bond

What would a representative of the Establishment consider to be "wrong" in our actions on this occasion?

One of the numerous reasons that Gay persons are considered to be "outlaws" by the heterosexual power structure is that we hold

true to experience reality rather than taught reality, and this be-comes significantly a threat to the comes significantly a threat to the Establishment when the experience reality that we act on is in opposition to taught reality. We are taught to limit our overt behavior to that which is simplistically "reasonable" to the outside observer, and, under this norm rule, the outside observer is allowed to judge us only on the basis of what is apparent to him and subject to the limitations of his interpretational understanding. In this case ional understanding. In this case I comforted another woman rather than reprimanding her for showing human feeling in the presence of others, and without regard to how it might look to a person who would fail to attribute intelligence and interpersonal caring to our relationship

Secondly, due to my conviction that sex role expectations place severe limits on our human and humane growth potential, and particularly on that of women, I dress in such a way as to appear niether in such a way as to appear niether distinctively male nor distinctively female. This might be correctly acknowledged as a threat to the hierarchical power structure in which the male power group benefits from the subjugation of the female group, including those males who identify with women. This sex roleless appearance might also indicate to a representative of the Establishment that I am, quite assuredly, Lesbian, offering my self to women rather than to men, and allowing my behavior to be influenced exclusively by the needs of women rather ly by the needs of women rather than those of men.

Who was victimized by our actions? The Gay bars in Birmingham, Alabama, are the only community centers we have, and we use them primarily for communal sharing of experineces and communications headquarters. Although we have been exposed to and have been to some extent corrupted by requirements of conduct found in "straight" bars as we feel that this rigidity is the result of guilt arising from the exploitation and oppression of the Female Principle in women and men taht prevades hetero-sexual behavior. No Gay person is in the least disturbed by the show of affection and caring and MUTUAL eroticism between/among persons. Furthermore, we feel deeply that ANY relationship involving mutual tenderness and caring should, now more than ever in these trying times for all humanity, be respected and supported by the community, whether this community be a group of friends, a township, or the international community called the world. Every once in a while, and almost exclusively among Gay persons, love and the human feeling of one person for another, that is, the feeling of warmth which happens spontaneously, of itself, and which therefore cannot be made to happen or socially determined or used for any purpose beyond itself, wins over the power structure geographs. socially determined or used for any purpose beyond itself, wins over the power structure concocted of money, prestige, and security which dictates relationships by inbreeding and perpetuating fear and insecurity in the disadvantaged group, and to the extent that tenderness and human intercon-

# Nights gets back to basics, but it's a good movie, too

Nights in Black Leather, a new male film being released by Jaguar Productions, defies all the progressive steps taken by gay films in the past year. Its story is wispy to the point of non-existence, at least 95 per cent of the 108-minute running time is devoted to sex, and these interludes are absolutely endines.

What is even more remarkable, in light of the foregoing, Nights in Black Leather turns out to be a very engrossing and entertaining film. Its success is due to the star and the cameraman-director. Nights in Black Leather is what is known in the movie industry as a star vehicle, a story designed to showcase the talents and attributes of the main actor. Barbra Streisand's movies are the most prominent example that comes to mind.

Star vehicles are also pretty risky business, unless built around a person with so much physical presence that an audience's attention can be diverted from what usually turns out to be production deficiencies and scripting inadequacies surrounding the venture. Nights in Black Leather has everything riding on the anticipated popularity of its star, Peter Burian, and in this case, the risk could be termed minimal.

Burian is a dark-blonde, blueeyed beauty that would make even the dead rise again, with the kind of body you have to start making plans for when you're about 12. His ass could be nominated for a Golden Globes Award. The clothes (or perhaps more appropriately, costumes) he wears in the picture leave nothing to the imagination. He must have sprayed them on. Audiences will not have much call to use their imaginations, however, for Burian wears little or nothing throughout the picture.

But even monumental beauty can lose its luster if badly photographed, so Peter Burian was fortunate to have a cameraman

whose lens practically caresses each and every pore of his body. Photographer Ignatio Rutkowski has taken the ingredients of a standard fuck film and lifted them to the level of visual art.

His work shows a strong influence of European films, particularly those shot by Henri Decae and Claude Renoir. With muted colors and judicious use of highlights in appropriate places, there are sequences in Nights in Black Leather that are a veritable symphony of pictorial splendor. He even lights his scenes in ways that disregard probability of success, capturing shots of exquisite beauty that many wouldn't dare attempt.

Rutkowski's background is in still photography. Prior to filming Nights in Black Leather, he had made only on 15-minute short subject. But, like Gordon Parks, who also tackled his first movie with tenets of portrait lensing, Rutkowski takes chances in applying the same principles to the motion picture form and makes them work, with brilliant results.

The story in Nights in Black Leather, which can be noted and immediately forgotten, is of a German boy writing to his homeland friends, describing sexual adventures he had in San Francisco. These episodes include a jack-off phone call, a casual street pickup, an S&M encounter, a drag party, and an afternoon he spent with two lovers he met at a gym. These sequences are bridged with introductory voice-over narration that teeters on the brink of outrageous floridity, like something remembered from a 1950 gay novel. Ignatio Rutkowski wrote the narration, read by the star, Peter Burian.

Burian obviously still has difficulty in mentally translating his thoughts into fluid English because of the relatively short time he has lived in the U.S. This is evidenced in both the improvised dialog and narration. It's not a drawback to enjoying the film because of his ingratiating handling of the problem. If anything, it creates more empathy with his audience.

more empathy with his audience.

If we were to single out special highlights of Nights, they would include the blatantly erotic phone call, the artistic sensuality of a scene in the woods, which takes place in a hut with transparent walls, and the accurate subtlety of the S&M scene.

(Burian is apparently into this, playing it at the proper depth.

Because of Burian's arian looks and background, the S&M sequence could have fallen heir to a residue of sinister implications, but both he and Rutkowski have taken care to divorce the preceedings from the "Master Race" theory.

They confront the problem point blank in the preceding narration, describing one of Burian's tricks who was into Nazi uniforms and swastikas, and Burian didn't have the heart to deflate by revealing that he had voted Socialist in the last German election.

As the S&M scene is constructed, it does bring a time of German militancy to the viewer's mind, so perhaps the filmmakers were wise to bring it up themselves and dispose of it so they could get on with the story.

Included in the cast are Rick Jedin, Al Joffrey, Tom Webb, and Jim Salem—all handsome and well-built young men. They complement, rather then counterpoint Peter Burian, making Nights a visual triumph for audiences with a fundamental interest in sex and bodies.

This is probably as good a time as any to introduce an inter-related subject, especially as it applies to Nights in Black Leather and several other films I have reviewed lately.

Recently I was accused by a producer of male films of taking these movies too seriously, that they weren't meant to be judged in devastating detail. His statement was occasioned by, as you may have guessed, the decidedly mixed review his latest effort had received.

I think the allegation is well founded. It is true, I have reviewed gay films in some detail, but I disagree with the contention they were taken too seriously. When the lights go up after a screening, it isn't much fun having to affect a wan smile because what I have just seen might as well have had a shell with Coast Federal Savings superimposed over it.

If these were movies of someone's summer vacation, inflicted on you without charge in their living room, it would be tactful to say how enjoyable they were. It's altogether another matter when the films are shown to the public, whose patronage is solicited on the basis of product quality and who have to pay a steep price for the privilege of seeing them.

Reviews of films are strictly one person's opinion, replete with his preferences, prejudices, and laced with his experience as a moviegoer. There will be as many differing opinions as there are reviewers. Charles Champlin, movie critic for the L.A. Times, put the whole subject of reviewing in the proper perspective recently by stating: "A critic can't lead audiences to movies they don't care to see or keep them away from those they do. But he can, if he's lucky, help them to know what they're going to see and, if he's very lucky, sometimes persuade them to take chances."

It is primarily because of the high admission price charged for gay movies that I have reviewed them in

such detail. I believe that the prospective audience should be made completely aware of the commodity they are buying, so they can evaluate for themselves whether it is worth the money to be spent. The films are judged by those that preceded them in the particular genre; naturally some will be better and some will not, but again, that will be only one opinion.

The producers 'seriously' intend that the movies return a profit to justify the investment, so audiences should also be allowed to 'seriously' select the one they want to see, and this selective process will (or should) be on the basis of quality. That is why we will continue to take the films 'too seriously', if only as a service to our readers.

In the instant case of Nights in Black Leather, audiences can be entertained without any involvement and will have gotten their money's worth, but the fact remains that it is a superficial movie. The surfaces are visually glossy, beautiful, ornate, and it's all designed to divert attention from the emptiness underneath. Perhaps that's why I'm furious with myself for liking it so much for what it does achieve, instead of disliking it from an awareness of the film it could have been.

Both Peter Burian and Ignatio Rutkowski have a talent for making good movies, but they have used only a fraction of it in their current effort. Two artists with the capability wo working in marble are instead sculpting with papier mache. We hope their next project exercises all their obvious talents, not just a small portion.



Cheerfulness, an engaging and friendly smile an easy going personality, smile an easy going personality, and a wonderful sense of humor -- all belie untold agonies.

Ms. Mayes is suffering from what the medical profession calls

Gender Dysphoria syndrome. She is a transexual. There are several different forms of gender dys-phoria syndreme, ranging from Homosexuality to the extremely rare case of transexuality. There is the homosexual who dresses in the clothes of the opposite sex (drag queens) to reassure his own sexuality and masculinity, and we next find the tranvestite who by definition is not homosexual and does however dress in the clothes of the opposite sex. On the exof the opposite sex. On the extreme end of the scale of gender problems we will find Ms. Mayes, she is a transsexual, that is, her mind is totally female while her body is that of a normal biological

The happiest period of Toni's life has been the past 18 months, living and working as a woman in preparation for sex reassignment

"By the time I was five years olf, I KNEW I was a girl," Toni related during the first of a series of nine interviews

Toni vividly remembers the first time little Richard Anthony Mayes Houston, Texas was subjected "I remember one unusual. experience when I was about five years old and I had slipped into the bathroom and put on my sisters clothes. I had done this before because I had been told not to wear hear clothes and I had found that I had to hide to do it. My sister had to use the bathroom on this person of the property of the prope occasion so I quickly took off her clothes except for her panties and put mine back on. By the end of the day I had forgotten them and when my mother put me to bed she found them on me. She spanked me for that and the next day she put my sisters red frilly Sunday best dress on me and sent me out play with the "other boys." a was trying to shame me but instead I rather enjoyed it thus discouraging her following this line of punishment any further.

Instability marred Toni's child-od - parents often divorced, mother often married (eight times at last count), a year spent in an orphanage, living with various relatives in different parts of the country, and all the time the child felt like and knew he was a girl, and was forced to live as a boy. Normally, I wound up playing

Toni found it very difficult to find friends in other children because of her problem. At the time when little girls don't like little boys Toni was the same way. As a girl she didn't like boys either. and because she looked like a boy

and because she looked like a boy
the little girls didn't like her.
There were occasional bright
spots. During the "Bat Man Era"
Toni couldplay with a purse, saying
it was the masked mans utility
bag and wear a cape and pretend
it was a ball gown. When Toni was
eight years old her mother put her
and her two sisters in a orphans and her two sisters in a orphans home in Denver, Colorado. Toni was separated from her sisters because of her male body. Girls were on one side of the home and the boys on the other, this confused Toni because at eight she still could not accept being male and didn't understand why she was separated from her sisters.

"I think my relatives thought there was a difference in me be-cause after about a year in the home my grandfather came to Den ver and moved us children to Christy, Texas and my Corpus Christy, Texas and my sisters lived with my grandparents while I lived with my aunt and uncle and their son. My uncle was in the Navy and his son was about my age. I think they felt I would realize I was a 'boy' if I was in that kind of environment. We spent the summer there and I really enjoyed it. I found a close friend the neighbor girl next door and we played such games as jump-rope, jacks, house and other typically 'girls' games.'' At other times when no one else was home Toni could enact the childs idea of a housewife.

Toni also remembers risking ridicule to change into a skirt and blouse in a grade school restroom to join the girls in the gym for a game of basketball. Why? "I was crying out for someone to realize I was a girl! No matter what I

did nobody understood."

Another phase of Toni's life involved hiding some of his sisters clothes under his mattress and then dressing in them at night when everyone else was asleep. "I was about ten or eleven at the time, and I was living with my fathers brother and sister-in-law and their six children in Sheldon, Texas. I couldn't dress during the day because there were too many people around so I had to wait until after everyone was asleep. I was still living with them when I was twelve and my cousin was just beginning to wear a bra and I began adding that to my wardrobe at night. The bra didn't fit properly so I had to adjust it every night and after about two weeks my aunt had a word or two with me about it. She never actually said she thought I was the one who was changing the adjustments on the bra but I decided not to readjust it after that.

Despite the inner turmois Toni did well in school, skipping a term in the fourth grade and another in the fifth. But Toni failed the seventh grade. (Toni, as with most true transsexuals, has a very high I.Q. . Her I.Q. is 125 on the Welcher Adult Intelligence Scale where 19.9% is above ad-

Seventh grade was perhaps one of the most traumatic times of my life. With puberty came my voice change and along with it came other undesired changes. I really realized I had problems. Like the rest of the girls I wanted to date guys. I also realized this wasn't addepted. I was expected to be like the 'other guys' and date girls. I knew I wasn't a boy and the idea of dating girls was foreign to me. I just wasn't interested in girls. The girls didn't want to date me-either because I wasn't the 'Ideal Guy.'' A compromise was reached eventually when Toni met a girl who liked to skate. ''We were skating partners and ours was a platonic relationship."

Another disappointment came that same year when Toni tried to get on the school cheerleading team. "I wanted to be a cheer-leader more than anything in the world. She school didn't have any and they cheerleaders wouldn't make any exceptions. So, I wound up running trackinstead."

(Toni today regrets those ath-letic pursuits, for they developed her arms and legs so that she now doesn't appear as feminine as she would like.) Other diversions were swimming, ceramics and breeding blue-tailed guppies. "I found that if I had a great many tings to keep me busy I

other tings to keep me busy I didn't have to date."

At age 14 Toni was two weeks into the eighth grade and still hadn't adjusted to having a male body. She ran away with a cousin to California. "Why was I born with this deformity? It was a fate worse than death - a living hell. I had not friends and I had long since learned I couldn't tell anyone how I felt." When Toni reached California she had a nex experience which for a short while perience which for a short while she thought offered a solution to her problem. "My cousin and I met two homosexuals and we spent the night with them. My cousin was repulsed by their aggresivness and he left the next day. I said to myself, 'Perhaps this is what my problem is. Maybe I am gay. I decided to give it a try and I learned the first night that I wasn't I was still being treated as a male and my male genitalia was the object of most importance in any sex relationship with gay men. I hated my male genitalia and I was as upset with that kind of sex as my cousin was. I decided to continue and experiment with it

because it at least offered a solution to my situation. My cousin had called my mother and told her the type of enviornment I was in and she called the authorities and she called the authorities and had me sent back to Houston. I spent about two weeks with the two men and by that time I was sure I

was not gay."
"After that I ran away twice again, once to Tennessee and once to Florida. I went hungry a lot and I often ate well too so it pretty well evened out. I learned to fend for myself. I also learned a lot about life and people.

Toni was unhappy and unadjusted to the male role. She couldn't make friends and finally decided to try and adjust to being the man her body dictated she be.

She had an uncle (the one she spent the summer with in Corpus Christi with) who had retired from the Navy. Her family said that joining the navy was the best thing she could do. "The Navy will make a man out of you," they said. So at fifteen she tried to enlist with her mother signing the papers. Somehow the Navy found out she was only fifteen and wouldn't let her join. "I was disappointed and ran away again. I went from place to place taking odd jobs like dish-washing and sweeping floors to stay alive. I even worked one summer for the City of Houston as a basket boy at the Mason Park Swimming Pool, When I was old enough to enter the service at seventeen I enlisted.

During boot camp Toni excelled burng boot camp form excelled in all courses, and was on the swim team. Her company earned six athletic flags (awards) mostly due to her ability to swim. 'I enjoyed boot camp for the challenge, but I hated it for other reasons. Like having to shower with seventy-five guys. . I found it very embarrasing even though I was physically no different than they physically no different than they


Toni fell in love for the first an lowa sailor and they became good friends. The man never suspected the relationship was anything but the traditional "buddy type." Toni decided to go home with him on leave and when they left him on leave and when they left camp she had her first heterosexual experience.

The sailor had written home to his girl and had her line up a date for Toni. "We went to a show the first night there and I fell asleep, I didn't want to try anything. I really only wanted to be with my buddy. He was upset about my going to sleep and spent several hours telling me off. The next night I spent the night with the girl and ad sex with her to satisfy my

After boot camp Toni was a signed to sea duty. Toni "couldn't take being aboard ship with 3500 men", and went absent without leave, returning to Iowa to stay with the girl she had met and dated during boot leave there. This girl later became Toni's first wife. Although they infrequently ha Although they infrequently ha intercourse, they had a daughter two years and one month after they married. (Toni has said the child will never see her father again.) "I loved my daughter very much, more than I have ever loved anyone in my life. I would like to be her mother, of course I know that could never be, I don't be-lieve I ever really lover her mother as a husband perhaps should, but then, that to me, would have been homosexual. "The common law marriage ended in divorce after four years. During this period the Navy caught up with Toni. While in the brig at Great Lakes Ill-inois Toni discovered a way to get out of the Navy . . . permanently. In response to a question on an evaluation form "do you have any homosexual tendencies?", Toni replied, "I don't know but I like replied, "I don't know but I like men." The result was an undesir-able discharge for her. Toni wishes she hadn't done that now however because she now thinks the navy was a good experience for her and she would like to return to the service after she has her sex changed and get an honorable dis-

Deciding "I hadn't tried as hard as I could to be what society thought I should be" Toni enrolled in a college in Iowa studying elec trical engineering and computer sciences as well as participating actively in student government and campus organizations. She was president of her class, social editor of the yearbook, Iowa State advisor for Vocational Clubs of America, President and organizor for the schools bowling league, and captain of her team she also and captain of her team, she also organized a scholarship program to be maintained by the electrical engineering class for future students who needed a helping hand to to school. "I went to school full time and worked part and full time jobs. It was hard to do but my wife also worked and that made it easier. I never had a hard time going to sleep at night during those years."

Toni was a licensed radio operator at the time and the need to be herself never ceased. At night when her wife would go to bed Toni would tell her she was going to stay up to try to contact other radio operators on the radio, and Toni would then dress up and be herself for a few hours. She often wouldn't even go to bed, but would stay up until time to go to school.

During this period Toni came across an article in a magazine written by psychiatrists which told of Transsexualism. Until this time she had never know that someone with her problem could actually change their physical sex. "I had thought I was cursed with the male body for the rest of my life, a woman in a mans body." "When I read the story I knew I had to have the operation to change my sex. I knew that this surgery would let me be me for the first time let me be me for the first time in my life."

Toni began searching libraries for more information on the subject, she didn't sleep well, was argumentive, nervous, continually upset, she lost her friends rapidly, and was misserable for her wife to live with. She left Iowa and came back to Houston to learn more of the surgery. When she got here she began looking for a doctor who would help her to get the hormones she needed to start the change. "My all consuming goal was to get that operation, I lost two jobs and everything else I had ever had while trying to get started."

She finally found a doctor, a psychologist, who had had a trans-sexual patient before and thought she had finally succeeded in get-ting started. After several tests the doctor pronounced Toni a woman. Toni told her wife of the problem and then separated from her. Her wife moved back to Iowa and Toni began to live as a woman. Then more problems began to spring up. The doctor she had spring up. The doctor she had found couldn't find other doctors who were willing to help with prescribing the hormones and doing the surgery. Toni almost had a nervous breakdown. After six months her doctor sent her to Texas Research Institute Of Mental Sciences (TR-IMS) at the Houston Medical Center and they tested and evaluated her again there. They after another and they tested and evaluated her again there. They, after another six months, decided she was a true transsexual but TRIMS would not give her the hormones either. Of the probably twelve medical centers and universities that do the operation (sex-reassignment surgery) in the United States all reserved.

gery) in the United States all require that the patient live in the gender role of choice for at least one full year prior to surgery and

during that time take hormones Toni had done enough study on the subject by this time to be thoroughly at ease in conversations with medical doctors and psychiatrists concerning the technical aspects and treatment procedure for t and treatment procedure for trans-sexuals. Knowing the requirements for surgery and not being able to get the necessary hormoneal therapy to begin almost caused Toni to again have a nervous break-down. She finally convinced her psychiatrist to give her the female hormones she needed the first week

hormones she needed the first week in December of 1971.

December 1, 1971 is officially the day Toni began her life as a woman, "As far as I am concerned Richard Anthony Mayes no longer exists, there are those of the police department here in Houston who would disagree with me but then they don't or won't or can't understand the problem."

stand the problem."
A quarter of the American population experiences gender dysph-oria syndrome - confusion about sexual identity - either personally or through close association with

or through close association with someone else.

That startling estimate comes from Patrick Gandy, chief of Stanford University's Gender Identity Program. The term, he explained, encompasses the transsexual, the transvestite and the homosexual, asch once considered distinct from

transvestite and the homosexual, each once considered distinct from the other. Recent studies have shown, however, that there really is very little difference among them as far as gender identity is concernec, Gandy said.

Since Stanford opened its Gender Identity Program in 1967, about 60 persons, mostly men, have undergone sex - reassignment surgery, Gandy said. All the operations are done at Chope Community Hospital, which is a county hospital in San Mateo County, California, and are performed by or under the supervision of Dr. Donald Laub, chief of the Division of Plastic and Reconstructive Rehabilitative and Reconstructive Rehabilitative Surgery at Standord. The surgery is done at a county hospital to help keep down expenses for the transsexual. The surgery costs between -

\$2800 and \$3500, Gandy said. The male to femaleconversion requires five to seven days hospitalization.

The female to male operation is done in two steps each requiring a few days hospitalization.

Candidates for surgery are required to live in the gender of their choice for a full year preceding the operation. That is, a male who plans to become a female what december when the step of their choice for a full year preceding the operation. That is, a male who plans to become a female what december when the step of male must dress, work and otherwise live as a woman. "This is to satisfy the patient that it is the gender of his choice," Gandy said. "Nobody realizes how difficult it

Nobody realizes now difficult to to pass oneself off as a member of the opposite sex." Toni had to learn feminine manerisms, to walk and sit like a woman, to camouflage a bass voice.

Hormones brought about bodily


