

## TROUBLE IN DALLAS!

TROUBLE AT THE KING OF CLUBS AND THE CANDY STORE

A test case relating to false statements on club membership cards submitted by Texas Liquor Control Board agents will be brought in Austin by the officers of the King of Clubs and The Candy Store in Dallas. The hearing date is pending.

On October 15, two Liquor Control Board agents entered The Candy Store, 3014 Throckmorton, after having answered "no" to the question "Are you a member of any law enforcement agency?" on the membership application. On October 16, they entered the King of Clubs, 2116 N. Field, on the same basis.

No arrests were made in either club. Several days later, officers of the club were informed by the TLCB that two of its agents had been admitted to the clubs in violation of the 3-day waiting period required by Texas law. According to this widely ignored statute, a guest must wait 3 days and be voted on by the club's membership before being admitted as a new member. During that 3-day waiting period, he may enter the club as a guest to inspect the club's facilities, but he must not purchase any drinks unless he has bought a \$2 card -- sold by the State of Texas-entitling him to this privilege during those 3 days.

ing as a U. S. Navy Medical Corpsman, the student was convenced that his preparation was essentially the same as that of his peers in the course.

In reply to these allegations and apparent discrimination, the student promised to present his case in court if his enrollment in the course were terminated. Two counselors at El Centro, Mrs. Dunn and Mr. Hutchinson, supported the student's position. The young homosexual pointed out that at this point, he had already completed four weeks of the course and had incurred approximately \$150 of expenses in books and fees necessary for the course.

The student promptly consulted the Dallas office of the American Civil Liberties Union, where he was assured that he "had a good case." Aware of his intention to contact the ACLU, the El Centro program officials apparently reconsidered their course of action.

On Monday, September 27, the next class day after the alleged discrimination incident, the student was informed that he would be permitted to continue in the course. However, he was told, "You like to cause trouble, don't you?" Since the incident, the student has reportedly suffered no discrimination in connection with El Centro.

during those 3 days.

The TICE filed on the clubs claiming they were open saloons and noting that the 3-day-waiting-period statute had been violated. Although the owners admit that the clubs technically erred in not selling the TLCB agents the \$2 cards, he contends that their false statements on the membership questionnaires outweighs any error committed by his personnel.

As a consequence of this situation, the TLCB ordered the Candy Store closed for a week during early October with the week being used as an opportunity for redecorating the club.

The officials of the clubs were offered a waiver by the local TLCB for a 30 day closing but upon advise of club attorneys refused to sign the waiver and had the hearing transfered to Austin.

The policy of the clubs has been changed to require that a guest be invited by a member and that the guest buy the \$2 card entitling him to purchase drinks during the 3-day waiting period.

#### GAY NURSING STUDENT FIGHTS BACK

A young gay nursing student, requesting that his name be withheld by OUR COMMUNITY, reveals that he experienced discrimination at the hands of Dallas educators in late September 1971.

Enrolled in the A.D. (Associate Degree) Nursing Program at Dallas County Junior College's El Centro campus, the student made no secret of his homosexuality. In early September he urged his associates in the program to view "The Other World," a TV documentary on homosexuality in Dallas broadcast by Channel 13 on September 6.

On Friday, September 24, Mrs. Parsons, Chief investigator of El Centro's Medical Education program, gave the admittedly gay student a choice of dropping the course or taking a grade of "F." Although she gave his allegedly "inadequate background" as the reason for dismissal, she also charged that he had "tried to force homosexuality on other people." Inasmuch as his background included train-

#### POLICE TAKE FOUR FROM STUDIO 9

Plainclothes Dallas policemen arrested four men in the T-room of Studio 9, 4817 Bryan, Dallas' only gay movie theatre, on October 21. Two men were arrested, charged with sodomy, and later released, with charges pending. Two others, who may have been watching the act, were charged with disorderly conduct.

Other patrons were asked to show their ID but were not arrested. The owners of Studio 9 emphasize that this should not be considered a "raid" or police harassment since only the four persons directly involved, plus the doorman, were arrested.

On the basis of the best information available to us, OUR COMMUNITY has concluded that Studio 9 is not a dangerous place to visit for those interested in watching the flicks. However, gays who enjoy T-room sex should be cautioned that they can be arrested in any T-room for such acts.

The plainclothesmen had filled out club applications stating they were not members of a law enforcement agency.

### POLICE ENCOUNTER AT THE DETOUR

Nine persons were arrested at the Detour, 3113-A Live Oak, in an encounter with Dallas police Thursday, October 21. Three minors were arrested for being on the premises of a bar serving alcoholic beverages, although they had not been served by any Detour employees, according to the owners.

Six persons were also arrested when they complained of police harassment and were charged with disorderly conduct. This group included 5 blacks and 1 white.

The encounter occurred as a consequence of an anonymous complaint. The police charged that the Detour was operating billiard tables without a license, operating a dance floor without a license, and serving minors. The owners contend that their operating the billiard tables and the dance floor resulted from innocent errors.

## **EDITORIAL**:

WANTED: A METROPOLITAN TAVERN GUILD

Some of you may be familiar with an outstanding gay organization in Los Angeles called the Tavern Guild Association. As a division of H.E.L.P. (Homophile Effort for Legal Protection), Inc., the TGA stands as a symbol of mutual cooperation between the member establishments.

OUR COMMUNITY has come to realize that such an organization is precisely what gay Dallas-Ft. Worth needs now. The gay clubs and bars of this area are ill-served by petty rivalries and crippling dissension. Rather, gay businessmen need to capitalize on the modicum of unity and cooperation which exists in this community.

We recognize that gay people are a minority, often even a divided minority, within a straight society. In recognition of that minority status, we assert that what is good for the gay community as a whole is likely to benefit each gay businessman and consumer in his individual situation. There are, of course, some noteable exceptions, but we would suggest that whenever possible, the interests of any individual bar/club owner or of any gay consumer ought to be tempered with consideration for the general welfare, the good of the entire local gay society.

In light of this realization, OUR COMMUNITY proposes the establishment of A Dallas-Ft. Worth Metropolitan Tavern Guild, to be initiated by OUR COMMUNITY. The reason for this newspaper's aggressiveness in this connection should be obvious after a moment's reflection. No individual gay club owner or other businessman could establish and operate such an organization without immediate cries of "four" from his competition. Understandably there is a healthy (sometimes even excessive) degree of rivalry between gay businessmen. To channel this competitive spirit along significantly more worth while lines is one of the principal purposes of the pro-

while lines is one of the principal purposes of the proposed Metropolitan Tavern Guild.

In essence the proposal for the operation of the MTG is that a regularly monthly meeting of interested Dallas-Ft. Worth club/bar owners, club/bar managers, and other gay businessmen (as appropriate) be held, with the meeting site rotating from one club to another on a regular basis. This is, for a given monthly meeting, the owner of Club X would invite his colleagues in the MTG to an informal meeting, probably with a free light lunch and drinks served. OUR COMMUNITY could be called upon to handle the details of notifying full membership of MTG as to the time and place, as well as a hint of what the meeting's agenda might include.

In addition to the distinct possibility of improving relations between various segments of the gay community in Dallas-Ft. Worth, such meetings should enable all concerned parties to stay abreast of their colleagues ideas, current problems, and thoughts about the future. Moreover, the MTG could serve as a kind of gay Better Business Bureau or Chamber of Commerce and might well handle comments and complaints of gay consumers who patronize their establishments.

For those of you who may consider this proposal somewhat unrealistic, we regard this as something more than a pipedream. In recent days, several gay business people have concurred in our assessment of the need for such an organization here. We're taking this opportunity to "run it up the flagpole and see who salutes," and we look for your comments-no matter who you are in the near future.

Having purchased the former Gallery One, they presumed that Gallery One's licenses for billiards, which was due to expire December 31, 1971, had also been purchased. They were unaware that such a license does not carry over when ownership changes hands and must be renewed to have legal validity. They also assumed that a letter from the Dallas Police Department acknowledging the owners as "dance hall supervisors" constituted a dance permit.

According to the owners, approximately "150 guests" had their ID checked by police and were then told to leave the Detour. The owners point out that this should not be regarded as a "raid" since only the minors, the bartender, and the party of six were arrested. On balance, the police were well-behaved and not belligerent in any way. One need not be afraid to go to the Detour because the bar has had no trouble with the police since the October 21 encounter.

It was Oscar Wilde who popularized the theory of W. H." being Willie Host-ler, a boy actor in the King's Company. The text of the sonnets themselves shows, however, that "The onlie begetter" is a young nobleman, about age 18-20.

For many years, Henry Wriothesley, Earl of Southampton, enjoyed primary candidacy. He was patron of Shakespeare, who wrote a dedication to him in the play Lucrece: "The love I dedicate to your lordship is without end...."

More facts have become known in recent years about the Earl, and some elements of his life do not fit the context of the sonnets. There is also the problem of reversal of initials.

Another likely person is William Herbert, third Earl of Pembroke, to whom the editors of the first folio edition of the plays dedicated the volume.

In an excellent book in 1964 Leslie Hotson put forth new and convincing evidence of the famous young nobleman William Hatcliffe of Lincolnshire.
The known facts of the life of Hatcliffe relate much more closely to the sonnets than the facts concerning Southampton.

That scholars recognize Shakespeare's feelings is clear. John Wilson refers to "this youth to whom Shakespeare paid tribute with the finest love-poems in the world..." Another authority speaks of "the tortured affection for a young nobleman" and of "the fervor of language with which he speaks of his feelings".

Those interested in the sonnets will find 18-32, 50-61, 66-68, and 100-108 to be the most revealing and satisfying.







SPA LHEATRE SODOMY LAW TO BE TESTED BY SUPREME COURT

In the first such case involving only homosexuals, four gay men have asked a federal judge to declare the District of Columbia statute against sodomy unenforceable against private acts between consenting adults.

American Civil Liberties Union lawyers contend that the police interpretation of the sodomy law "subjects plaintiffs to the continuing threat that their homes may be entered by police at all hours, and that their privacy may be interrupted by searches for evidence."

The Washington case differs significantly from two other cases challenging sodomy laws, one in Texas and the other in California, in that the Washington plaintiffs are all homosexuals. In contrasts, the other two cases have included heterosexual plaintiffs as well.



According to Mattachine Society of Washington's president, Frank Kameny, The Texas and California

cases, by including heterosexuals for the purpose of challenging the laws as overly broad, leave open the possibility that state legislatures would rewrite the laws to more specifically ban homosexual acts.

This is precisely what happened in Texas in the aftermath of the noted Buchanan case, in which lawyers for a man charged with sodomy in public restrooms moved to challenge the law as unconstitutional and brought in a heterosexual couple as co-plaintiffs.

In that case, the federal court found the state's law unconstitutionally broad. Appeals by both Texas and Buchanan to the U. S. Supreme Court were dismissed after the high court decided in another case that it would not hear cases seeking injunctive relief from state laws when re-

lated criminal proceedings had not yet been completed.

Consequently a Texas state court found Buchanan guilty on one charge, innocent on the other. The difference was that he allegedly performed the act behind closed toilet stall doors in the second case, but not in the first.

The California case, supported by San Francisco's Society for Individual Rights, is on behalf of a married heterosexual couple, and two homosexual lovers.

Says Charles A. S. Hall, one of the plaintiffs in the Washington case, "This is one more step toward liberation for me," He noted that his fellow employees at the U. S. Employment Service, a federal agency, has been gossiping now that they "officially" know he is a homosexual. However, his superiors have evidently decided not to take action against him at this time, Hall added.

### GENE LEGGETT SPEAKS TO SMU STUDENTS

"Some of Your Best Friends are Gay" was the topic of a conversation with Gene Leggett on October 27 in the Student Center Lounge of Southern Methodist University.

Leggett, formerly a Methodist minister, told a mixed audience of approximately 150 that gays should regard each other as fellowmen, rather than sex objects. For that reason he does not like gay bars because he feels that they are places where straight society has segregated gays. They are, in a sense, a gay ghetto.

VANDALS RAID THE NATION'S OLDEST GAY BAR-MOTIVE UNKNOWN

Between 2:30 and 9:00 am, Friday, October 29, 1971 vandals borke into the Villa Fontana by pushing in a window air conditioning unit, thereby eliminating the possibility of setting off a burglar alarm. Bill and Ray, owners of the nation's oldest gay bar, know of no reason for the attack. They make no accusation, but believe the job was done by someone who knew the bar well --\$1,000 carefully hidden in the bar was taken. Close to \$3,000 or 4,000 in damage was done to the recently remodeled club as 5 gallons of tar was dumped on the floor, cash register, the walls, columns, and juke box. Shellac was smeared on the new stage floor. Booze was poured all over the records kept for the Texas Liquor Control Board. An \$800 carpet was ruined, and the public address system was destroyed.

No one was reported to have been seen at the bar at the time of entry, and no employees had been fired recently. The bar had been burglerized before, but never maliciously. Apparently the aim was to put this historic bar out of business. A week before, the Villa had received a threatening phone call saying, "You're going to get your's"




## Some of my best friends are...



If some of your best friends were the characters in the new gay flick "Some of My Best Friends Are..." now showing at Interstate's Wilshire Theatre, you might have more serious doubts about being gay yourself. If the basic unhappiness of the characters is any indication, superficial gaity but deep-seated malaise is the lot of the American gay. To that wraped contention, we say bull shit!

This American International film starts with the premise that if you're a lonely homosexual and it's Christmas Eve, you'll probably go to a gay bar. The Blue Jay Bar is presented as a friendly haven for the lonely gay, a place where the relaxed atmosphere and the general air of comraderie allows him to be himself, to drop the mask of protective pretense which he is likely to wear in the straight world.



family and the young Swiss student he met overseas.


Along with these are the sterotypic characters: "classic" giggling and flitting faggots, a student just "coming out," toughs, a scattering of women, and of course the cop with his hand out for protective money from the small-time syndicate type who operates the bar.

Then there are the bartenders, condescending to ward and contemptuous of their gay customers, who work in the bar only for the money; a Jewish-mother type of woman who considers "her boys" her family and lets them know it in a touching little speech to the gathered assemblage after her recuperation from an operation. Finally, one notices the superficially blithe but tough and knowing hat check girl, Fannie Flagg, the star of "Some."

If there is a message in the "throwaway" flick, it seems to be the pointed similarity between the gay and straight worlds, at least at many significant points. Vividly illustrative of this thesis is the "fight" sequence in the bar in which a hustler type attacks a shy drag queen after discovering, while dancing with her, that she is actually male. As she is repeatedly mauled, beaten, and chased from one end of the bar into the T-room, no one in a room clogged with gay bodies comes forward to effectively defend her against her savage nemesis. It would seem that not getting involved in crisis situations is aspervasive a tendency in gay life as in the dominant straight society.


Lest anyone think that "Some" lacks redeeming qualities, its merits lie principally in its intriguing



and attention-riveting characteristics. A stereotypescattered cornucopia of gay bar types, it manifestly exposes the full range of personalities and attitudes present in our special milieu.

There is a consensus, in which we share, that there is an air of artificiality about this flick and that some of the dialogue is too exaggerated to be realistic. One



is left with the unsettling feeling that this is a flick produced by straights (or at least not serious gays) to exploit a captive, gay audience—captive in that movie producers tend to presume that one need only present a film product, no matter how poorly done, with a gay theme in order to guarantee the box-office receipts from movie—going gays. That is, a "gay" flick is presumed to have an automatically "locked—in" audience.

SOMETHING NEW FOR THE SOUTHWEST: 3 IN 1!

After years of "paying their dues" by enduring the lack of a local spa, Dallas area will be treated to the opening of a bath in near-downtown Dallas later this year. As yet unnamed, the spa will join a new bar and new theatre in a "three in one" complex.

Although all three will occupy the same spacious twostory building, the bar will have a separate entrance from that leading to the first-floor theatre and the elevator to the second-floor bath.

A mid-December gala opening is slated for the new development, with a party planned for 150-200 charter members. The charter membership will include leaders of the Dallas metropolitan area community, who will be given a free membership and invitations to participate in special events in the future at the bath and theatre.


Tight security will be one of the most desirable aspects of the new complex, says the entrepreneur developing this Dallas innovation. To be admitted, any one coming to the door must be either a members or the guest of a member. Each member will be issued a laminated membership card including his photo, and he will also choose his own special password, which will be recorded only on the spa's copy of his membership card. On each visit to the bath or theatre, he will present his card and give his special password. Since the customer's individual password will not be listed on his membership card, mere possession of a stolen or found card by a stranger seeking admittance to the 3-in-1 complex would not enable him to be admitted. The customer's photo on the card will serve as an additional check. No one coming to the door "cold turkey," without being a member or being invited by a member, will be admitted.

Closed circuit television surveillance of the lobbies will immediately alert the management to any forced entry by non-members.

Plans for the soon-to-be-constructed bath include a sauna, steam bath, shower area, one or two "social" areas, TV room, and private rooms. As in other baths,


