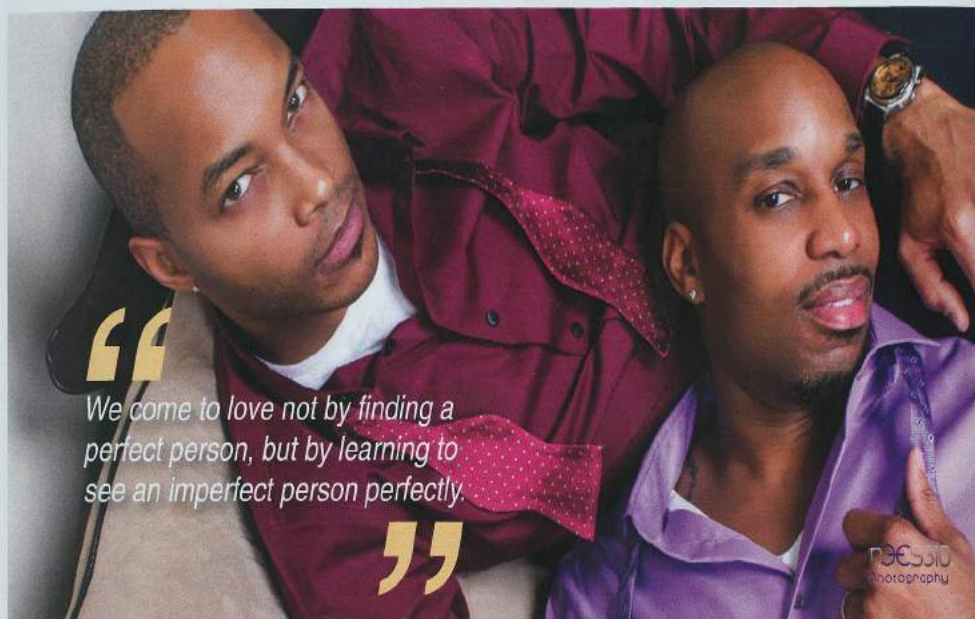

**Did Galveston Co. Sheriff's Department
carry out a death sentence on a gay man?
Sheriff refuses to release any details.**

Jesse C. Jacobs was processed into the Galveston County Jail to serve 15 days for a second DWI offense on March 6, 2015. He served about half of that, and was pronounced dead on March 14, 2015 at University of Texas – Medical Branch in Galveston after being transported from the Galveston County Jail. It's the details occurring before his death that are raising big questions.

Reports filed with the Texas Attorney Generals office and Texas Commission on Jail Standards state Jacobs was unresponsive in his cell and was transferred to UTMB. On March 23rd, 2015 another account was given when the Galveston Sheriff gave a comment to a local reporter stating, "Jacobs was being administered medication and collapsed." The Sheriff also stated to About Magazine, Jacobs was found in his cell, in the medical division by a nurse and deputy while doing their rounds. Three different accounts, from the same official.

Jacobs was processed into the Galveston County Jail and in his possession were medications to

treat chronic severe panic disorder, and Crohn's disease. Accompanying the medications, a letter from Jacob's physician detailing to jail medical officials, his patient's medical needs including his prescription of Xanax. An official Toxicology results showed that Jacobs was not administered his prescribed medications while in custody, contradicting reports that a nurse was administering his drugs when he collapsed. After four days in custody, Jacobs began suffering from repeated seizures and on the seventh day was found unresponsive, due to cardiac arrest.



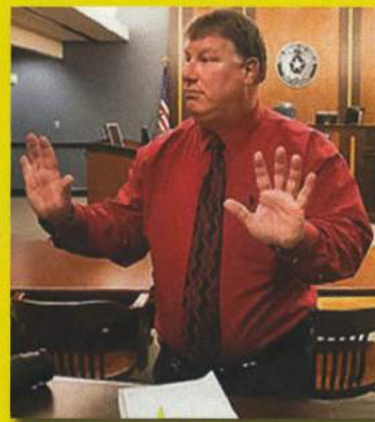

"Jesse was in pain" Diane Jacobs says of her son's condition. "I called the jail and spoke with the medical department and they told me there was no doctor there to help him." According to the family, Jacobs had been receiving Xanax for over 10 years to treat serve anxiety disorder.

The Galveston County Sheriff Henry Trochessett admits that Jacobs died of a seizure condition. "The autopsy report states seizure disorder, natural causes." And added, "I don't know if the family is trying to throw some red flag into the air that we apparently did something to him—when he just died of natural causes in jail."

With no previous history of this disorder, his treating physician, Dr. D.M. La Grone, M.D. asserts the disorder was developed as a result of Jacobs being deprived of his medications while in the jail. Dr. La Grone is a member of the American Board of Psychiatry and Neurology.

Attorney Umeka Lewis Piccolo, the attorney representing Jesse Jacobs and the Jacobs family stated that when the personal belongings of Mr. Jacobs were received, inside were his prescriptions.

"Never opened, not one pill missing." The jail did not provide him his medications.

Sheriff Henry Trochessett told media reporters he would not release any documents or videos out of fear of litigation from the family. As protests and riots continue around the country, and in Texas over the Sandra Bland case; the Jacobs case is being hidden from the family and the public by Galveston officials. A move that shows not all law enforcement agencies are ready to be completely transparent.

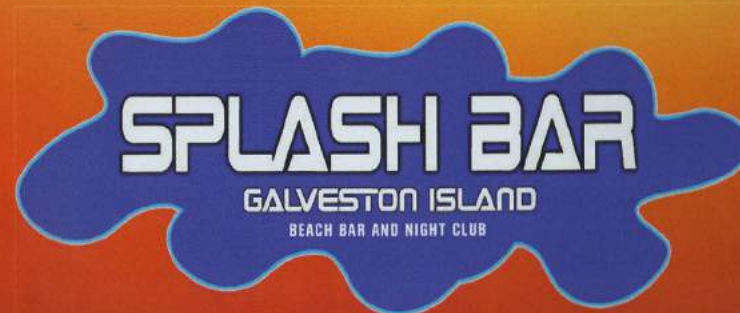

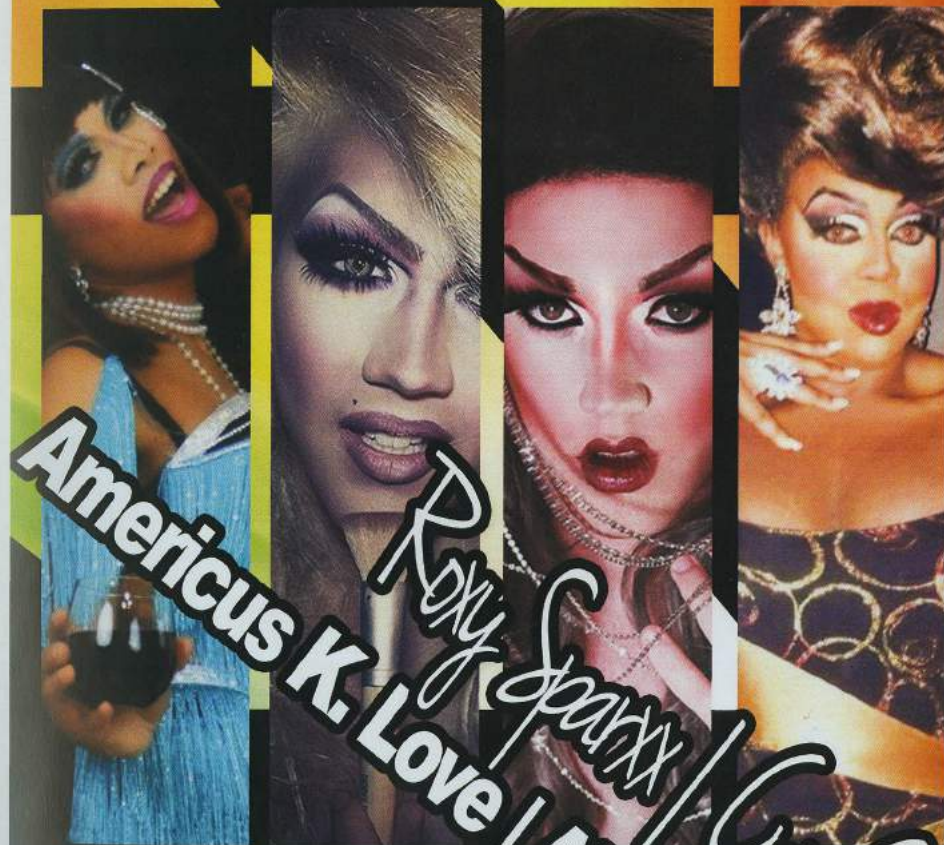

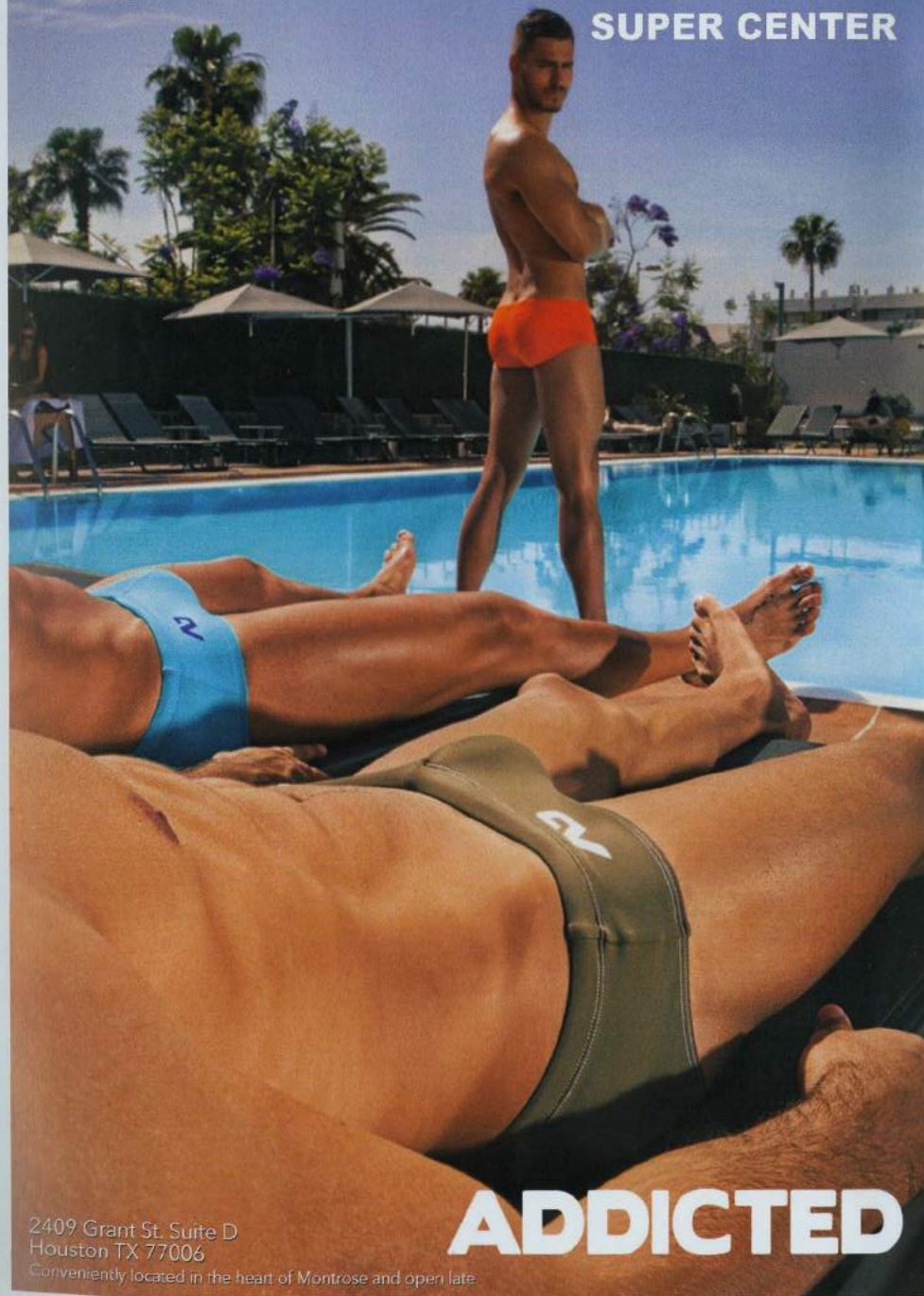
