This corrigendum is issued to correct several author-introduced errors in the originally published version of the article, “For Love, Money and Status, or Personal Growth? A Survey of Young Emirati Women’s Educational Spirations” by Woohyang Sim (Gulf Education and Social Policy Review (GESPR): Volume 1, Issue 1, 2020, pp. 73–90. <https://doi.org/10.18502/gespr.v1i1.7470>). None of the revisions affect the research findings or conclusions presented in the study. The corrections are listed as follows:

1. Firstly, the term “in the public domain” was incorrectly used in the source descriptions of Table 1 (p. 75), Figure 1, and Figure 2 (p. 76). It has been removed from all mentioned instances.
2. An annotation has been added to Figure 2 on page 78 to clarify the enhancements made by the author to the original data.
3. Table 5 on page 81 was missing its source citation, and this omission has been rectified by adding the necessary explanation and citation. Furthermore, a more detailed explanation of the table has been incorporated to provide clearer context.
4. On page 83, in the section discussing “What career aspirations do Emirati women have?”, the reference to “Table 4” was incorrect. It has now been corrected to direct readers to “Table 7,” where the relevant data is found.
5. In the Appendix, Table A1 and Table 7 mistakenly included data from five participants who were not part of the target group. This data has since been removed, and the tables have been updated accordingly. As a result of this adjustment, some numerical values in the text on page 83 have also been revised. Additionally, for clearer interpretation, Table A2 has been added.
6. Figure 4, which was not referenced in the text, has been deleted along with its corresponding note that was previously located below Table 7. In addition to these adjustments, the reference list has been updated to ensure all citations accurately reflect the corrections mentioned above.
7. The sentence “The pattern matrix of a rotated principal component analysis was applied to create composite measure by summing the 9 items asking why participants sought higher education.” has been deleted from page 79 under the heading no. 5 Methodology and Description of Respondents.
