# **GAY/LESBIAN CHAMBER ELECTS SARAH ROOK AS VICE PRES**

bit of local transgender history occurred last month, and it almost went unnoticed. In December, the Greater Houston Gay & Lesbian Chamber of Commerce (GHGLCC) held their annual elections, and quietly voted in TATS member Sara Rook as their Vice President. This marks the first instance of a GLBT organization electing a transgender into their number two position.

It was just one short year ago that the Chamber voted in its first transgender board member, Phyllis Frye. Sara joined the board later, during the course of this past year.

"I was very surprised when I was nominated in the first place," proclaimed a very proud Sara. "There were 2 of us nominated for [vice president] so I figured I wouldn't get it being the new kid on the block." However, it was her hard work over the

year that put her over the top. "I found out I got the second most votes" ever for any board nominee in the

Former Chamber boardmember, Phyllis Frye applauded the election, saying "its placing a TG in such a slot speaks volumes for the Chamber's commitment to diversity and inclusion." The most adamant and vocal stalwart of the Chamber's 'non-inclusion days', Ms. Frve also added that the local transgender community's


sidered for leadership slots is a plus."

Yet, this was not merely a token position for a transgender. After the election a still stunned Sara had to ask the inevitable: was I elected to this merely because I was transgendered? "I was elected," gushed a proud Sara, "because of my achievements as a human being and not because I was a TG person."

### **EDITOR'S RANT**

o this was Christmas ... and what have we done? Another year over ... and a new one just begun.... It's a fitting (if paraphrased) quote - wrapping up the end of the year and the end of the millennium. It's also fitting to close the month with a lyric from the artist whose lyric opened last month's editorial: John Lennon, who was killed twenty years ago on December 8. It's tough enough to think of John Lennon being gone, but it's

really hard to believe that it's been two full decades since his murder. A generation of high school graduates last year grew up knowing of John Lennon as nothing more than a vague historical figure ... someone who died before they were even born.

Truth be told, the anniversary of Lennon's death was one of the big factors in a personal bout of depression this past month. It was tough. Some of that might arguably be attributed to feeling my age - the end of the Era of Youth! The funny thing is, it didn't seem to make much sense to allow that to bother me. Why get this torn up about it twenty years later? If someone had asked, I probably couldn't have really explained it credibly. I'd have likely appeared to be a blithering fool.

many of you will understand. People referred to the death of JFK as 'the end of camelot,' or 'the end of the innocence.' I was only six when he was assassinated - too young to grasp why there was the level of grief exhibited. I couldn't relate.

At about that same time, the Beatles released their first hit; thus beginning their sweeping dominance of the American music scene. Music, I could relate to. Music, I remembered. And I loved the Beatles, even at that age!

For a lot of the older generation (older compared to us children of the 60's - who are now the older generation ourselves), the Beatles signaled the end of the innocence of "Rock & Roll." The Beatles were the first band with long hair and defiant styles, the first band who openly dabbled in taboo drugs and psychedelia, the first band to start out pop, then go counterculture. They were also the first band to explore mysticism, transcendentalism and non-mainstream eastern religions. It was John Lennon who glibly commented about the Beatles being more popular than Jesus.

This one comment released numerous evangelical protests that burned thousands of Beatles albums in ritualistic bonfires around the nation.

Most people took the quote to be what it was - a flip comment from a heady young rock star. But the evangelicals took it to be something else: a full assault on Christianity. Thus, the battle en-

While the Beatles at that particular time may not have seemed all that innocent, as a child growing up, that music to me was innocence. Certainly, relative to today's versions of misogynistic, racist and homo-

phobic rap and shock rock, the Beatles seem quaint and almost pristine by comparison. Songs with lyrics speaking to the almost-obligatory (for that era) love, hope, peace, self-empowerment, and even beyond that to examining social issues with a genuine conscience (e.g. aging concerns in "When I'm 64", loneliness in "Eleanor Rigby", antisocial behavior in "Nowhere Man"), had bonafide qualities that spoke to my generation and to me. As blunt or as coarse as they may have appeared to some, the Beatles - especially John Lennon sought to cut through the bullshit to something more pure: the truth.

So the night that John Lennon was shot was the end of an era for my generation. Now, even Even by explaining this now, I don't know that mere citizens were not safe. Suddenly, innocence was gone. When Steve Ray Vaughan died, I shed tears; but when John Lennon died, I shed none. For weeks I was in a morose state of shock ... numb.

> So why is this grief triggered now - this twenty-year delayed reaction? Though I'm no psychoanalyst, and don't pretend to be, the only conclusion I can come to is it's another end of an era. True, the year 200 occurred a year ago, and I even reported on feeling anticlimactic - I didn't really see what all the hubbub was about. As opposed to the more apocalyptic among us, I went to a club downtown with my friends, Marissa Carter and her mate Bonnie Hibschman. Just a typical New Year's Eve on the town, nothing remarkable.

But this New Year's is the true beginning of the 21st century. This was the true changing of the eras. At least it feels so for me.

This past month we witnessed the culmination of the strangest presidential election results we've ever seen in this country. The campaigns were not pretty, and the aftermath was even less so. First it was too close to call, then one side shut the election count down and declared victory under cloudy circumstance, then the other side filed suit after suit to challenge the results and recount the votes, then the

# LOCAL ORGANIZATION BECOMES NTAC'S 1<sup>ST</sup> GROUP LIFETIME MEMBER

GCTC Issues Challenge To Other Organizations

NTAC PRESS RELEASE — The National Transgender Advocacy Coalition (NTAC) announced that the Houston-based Gulf Coast Transgender Community (GCTC) has become the first transgender organization to become a lifetime member of the fledgling civil rights group. During a brief ceremony at their annual Christmas Party on December 2, GCTC president Jackie Thorne presented a check to two of the founding members of NTAC, Vanessa Edwards Foster and Jessica Redman.

GCTC contributed the initial seed money to NTAC when, as one of her last acts, thenpresident Foster (now of NTAC) committed \$200 to the group at last year's Christmas event. This marks a milestone for the young transgender and intersexed advocacy group. Following on the heels of GenderPAC's announcement of taking the heretofore transgender rights group to a gender expression group, the announcement couldn't have come at a better time.

"We've really been gotten quite a bit of interest lately," said NTAC board member Foster, "especially since Riki Wilchins' announcement that GenderPAC is backing away from 'transgender'. NTAC is now the only national organization focusing on transgender and intersex rights since the announcement by GPAC last week that it was dropping its focus on transgender rights in favor of a broadened focus on supporting all people who suffer gender discrimination." Foster added, "we've now had feelers from around the

nation wondering who is to fill the void.'

"That void," stated Foster, "will be filled by

The Gulf Coast Transgender Community is proud to, again, take the lead in contributing to new transgender organizations," stated GCTC's president, Jackie Thorne. "GCTC contributed the first \$250 that created the International Conference for Transgender Law & Employment Practices (ICTLEP), the initial \$500 for the Texas Association for Transsexual Support (TATS) and the initial \$250 for the Texas Political Action Coalition of Transgenders (TPACT)."

"It's part of GCTC's proud legacy," continued Ms. Thorne, "to think and contribute to what, in the long run, will benefit the entire transgender community - not just our own group. Our tradition is to hop on before the bandwagon gets started!

"On behalf of our group, I issue a challenge to all other transgender groups around the nation to become lifetime members of NTAC. If more in our community were to think globally, instead of in our own self-interests," Thorne finished, "think of how great our community could become."

NTAC praises the attitude of our transgender organizations around the country who, like GCTC, take the initiative to support those who fight for the rights of all gender-gifted individuals. As always, NTAC welcomes any support by either gender groups, or individuals, who wish to contribute their time or resources

to the betterment of the national transgender and intersexed community.

The premier transgender community initiative on Congress will occur the week of May 14, with a plenary training and strategy session on Sunday, May 13.

NTAC, the newest national transgender civil rights organization, is sending out a call to the nation's transgender and intersex community, all supportive family and friends, and helping professionals to unite for a show of strength on Capitol Hill. Founded in 1999, NTAC is currently the only national group with special focus given to education about. and advocacy for, all gender variant citizens.

Many may ask why attempt lobbying a Congress that is numerically stacked against us? While there is no shot at favorable legislation this session, there is still much education to be done with our legislators. NTAC realizes that only by educating our legislators regarding our needs, can we affect

change for our community - and our community has ample need.

Some talk around the nation has centered around a "mandate for morality" this congressional session, and what that means to our community. If indeed there is such a mandate, the last thing any of the target minority communities should do is to disappear or become complacent. ### WINN-DIXIE CROSSDRESSER FILES SEX DISCRIMINATION SUIT

NTAC, Coalition of Groups, Call For Boycott Of 'Image' Conscious Retailer

magine your place of employment notifies you claiming sex discrimithat you're being fired. When you ask their reason, the reply is, "we didn't like what you wore at home the other night." Far-fetched? Not in the eyes of Peter Oiler. And not in the eyes of Winn-Dixie, Inc. - the sixth largest supermarket men's clothes off duty chain in the nation.

Peter Oiler, a 21-year employee with Winn- But the company fired Dixie's suburban New Orleans distribution center, him "because he failed was fired for being a crossdresser.

The retailer claims that having Oiler, a truck driver with a good employment record on the job, was "bad for Winn-Dixie's image," said Eric Ferrero, ACLU spokesperson on the case. It wasn't because of his violating company regulations, wearing female attire at work, or behaving effeminately in the workplace. It was simply because he was honest with his supervisor; honest about wearing women's attire away from the workplace.

Two years ago, rumors that Oiler was gay cir- job." culated around the workplace, and Oiler approached management to have the rumors stopped. During a review this past year, the supervisor inquired as to why that bothered him so much. Peter Oiler matter-of-factly answered: "Because I'm not gay. I'm transgendered." After the supervisor contacted the corporate office, he asked Oiler for his resignation; mentioning it "was bad for the corporate image." Oiler refused to resign, and two months later, he was fired.

"Job performance is not an issue in this case," stated Courtney Sharp, a transgender activist from New Orleans. "The immediate issue is that Winn-Dixie claims that Oiler's crossdressing outside of the workplace, on his own time, was harmful to their corporate image. The broader, more encompassing issue is that Winn-Dixie dismissed an employee because he failed to meet stereotyped expectations of masculinity. Many men and women planned, as well as Winn Dixie's contact informamay fail to meet Winn-Dixie's gender expectations tion, and may be affected by this type of discrimina-

(NTAC) has thrown its full support behind the efforts to have Peter Oiler reinstated. NTAC sees an individual's freedom to express themselves in their personal lives as a basic human right. Transgenders face an inordinate amount of discrimination when transitioning in the workplace. To be terminated from one's employment because one engages in behavior when it is completely unrelated to one's job is simply outrageous.

NTAC joins with a coalition of other progressive organizations in calling for Winn-Dixie, Inc. to immediately reconsider their actions. The corporation's behavior

goes far beyond an employer's

normal sphere of influence to the point of dictating how an individual should live their personal life away from the workplace. NTAC is calling for a boycott of all Winn-Dixie Stores in the nation; and has plans for protests in some strategic Winn-Dixie locations. Additionally, NTAC encourages everyone to take a proactive stance by writing Winn-Dixie's corporate offices and expressing your displeasure over this patently unfair termination.

Sea Shell group itself, and also inclusion in the corporation's employment policies.

In addition to her work with her company, she's also been working diligently with the Chamber on it's Empower event, an open convention of out-and-proud companies, and diversitywelcoming and supportive straight-owned companies and corporations. In fact, because of her work on Empower on behalf of Sea Shell, she was awarded a corporate award from the company's diversity center last year.

Sara also received an award from the Houston Area Teen Coalition of Homosexuals (HATCH) for her volunteer work as a facilitator with the group. HATCH honored Sea Shell with the award because of the work of both Ms. Rook and another member of Sea Shell's steering committee.

It's a far cry from just two short years ago at the Chamber. Back then, transgenders decried being left out of the mission statement. The discussions on the Chamber's lack of inclusion in its mission statement was only the last of the three controversies between the TG community and the major gay and lesbian groups in 1999. However,

it was also the most hotly debated, due to its tim-

Following closely on the heels of the Gay & Lesbian Political Caucus and then the local PFLAG inclusion overtures, the Chamber's issue was the most intensely debated, especially on HAN-Net (the Houston Activists' Network). The negotiations were intense, and tensions were high.

At about the time of the scheduled inclusion vote, Sara became one of the representatives to the Chamber through her employer, Shell Oil. From there, it was just a matter of participating and Sara has!

The progress of both factions of the community has been phenomenal since that time. Phyllis Frye said it best: "Sara Rook being elected Vice President of the Houston Gay and Lesbian Chamber of Commerce is indicative of the growing maturity of both the transgender community and of the Chamber."

"To me it doesn't seem like much," said an ever-modest Sara, "but others say I have made big difference where ever I go." Indeed she has! Our congratulations go out to a history-maker, Sara Rook... 'Way to go!'

first side tried to seal the ballots permanently so no one would ever see the true voting numbers. Then it all went to the Supreme Courts where it was decided on a partisan vote who the president was to be.

COLUMBUS, OH - Franklin County Children's Services in Ohio removed a child from its parents when they tried to enroll the male-born child in school as female. The child, who identifies herself as Aurora and insisted on being a girl from the age of 3, is still in court-ordered foster care, though the parents can visit.

### **Judge Rules TG Teen Can Dress as Female at School**

BROCKTON, MA - A judge ruled a transgendered teen expelled from junior high may return to school as a female. The landmark ruling was based on the premise of freedom of expression.

### DC Settles in Wrongful Death Involving TG

The District of Columbia settled its lawsuit with the surviving members of Tyra Hunter's family.

### IOWA COURT STRIKES DOWN GOVERNOR'S NON-DISCRIMINATION ORDER

This Midwest state became only the second to sign a non-discrimination bill with "gender identity" included. That has now been rescinded due to a court challenge that the governor's executive order overstepped his authority.

### DeKalb, Illinois Enacts TG Non-Discrimination

### People of Los Angeles An Xmas Present for ransgendered

s many of you know by now, just before thanksgiving the Minnesota Court of Appeals issued an opinion in a case brought under the transgender language of the Minnesota Human Rights Act - an opinion which eviscerates whatever semi-legitimacy there may have ever been to Barney Frank's transphobialaden 'Penis Panic.'

That was something to be thankful for. However, I'd been hoping for more.

The Minnesota appellate opinion was direct and to the point - only addressing precisely what needed to be addressed to decide the case.

The transgendered woman who brought the case is a transplant to Minnesota from Texas and possesses a name-and-gender change order from a Texas district court - not entirely unlike a certain author whose words you happen to be perusing at the moment.

Her gender change order was called into question by the trial court in her employment discrimination case. I'd hoped to be able to announce to all of you that the appellate opinion in her suit was the first judicial repudiation of Littleton v. Prange. And, yes, I was hoping that the repudiation would come with numerous citations to my Law & Sexuality article on the case (which, yes, would be some nice egoboo for me.)

But - it didn't happen. Minnesota's employment anti-discrimination statute is clear enough for the court to have said that whatever was on her driver's license - M or F - didn't matter.

We are well into December, now. As I write this, a blizzard is howling outside my window. I'm not much on Xmas, but I'd like to give something to my readers. Unfortunately for those of you not in Los Angeles, California, I can only extend to you holiday thanx for reading my column.

But, for those of you in SoCal, I have this: "As used in this ordinance, the term 'sexual orientation' shall mean an individual having or manifesting an emotional or physical attachment to another consenting adult person or persons, or having or manifesting a preference for such attachment, or having or projecting a self-image not associated with one's biological maleness or one's biological female-

A recitation of part of the Minnesota Human Rights Act? What kind of present is that, Kat?

Close but no cigar. Its not from the MHRA. The Minneapolis city ordinance then? Nope.

Okay - what then? Would you believe: the Los Angeles anti-discrimination ordinance?

Actually, Kat, I wouldn't believe it. I haven't heard anything recently about L.A. considering revising its ordinance to include transgendered people. And you wouldn't - because it already happened.

HRC's WorkNet Employer Database lists Los Angeles as prohibiting discrimination in private employment and notes that the city's ordinance L.A. has "No law covering gender identity."

However, what I quoted above is the definition of "sexual orientation" that is used in the follow-

"It shall be an unlawful employment practice for an employer to fail or refuse to hire, or to discharge any individual, or otherwise to discriminate against any individual with respect to compensaon the basis (in whole or in part) of such individual's sexual orientation"

Really. I'm not making this up. An interesting word 'transgender.' In preparation for writing a

law review article on the case, I ran a search in a case law database for a unique phrase which does appear in them - 'biological maleness.' Only one non-Minnesota case contains that phrase. That 1984 California Court of Appeals decision, Rolon v. Kulwitzky, involved the Los Angeles antidiscrimination ordinance and, though the discrimination at issue was against lesbians, contained the entirety of its definition of "sexual orientation."

I can't adequately describe how shocked I was to see that last clause of the 'definition - language recognized as covering transgendered people which first became part of enacted law in the Minneapolis Civil Rights Ordinance in December, 1975. That coverage has its origins in the battle earlier that year to include transgendered people in a Minnesota state gay rights bill. The bill's backers, including early HRC-oid Steve Endean, were adamantly opposed to including transgendered people in it. Arne Carlson, a Republican state representative who went on to become Governor (the governor who signed the TG-inclusive MHRA in 1993), introduced a transgender-inclusive amendwas enacted in 1979. However, it also adds that ment which, though unsuccessful, was the model for a successful amendment to the Minneapolis ordinance later that year.

It seems as though whoever drafted the Los ing, Section 49.72 (a) (1) of the L.A. Municipal Angeles ordinance in 1979 used the Minneapolis ordinance as a model - which just accentuates the tragedy of how transgendered people were excluded from New York City's ordinance when it was passed in 1986 because its drafters used the narrow language of Wisconsin's state statute. how we are basically our own worst enemy in that we tend to cause division amongst ourselves through personal attacks and in having a "My way is better than your way" attitude. I also talked about how we need to (1) Come together as a community and develop an overall consensus on a common purpose(s), (2) Allow each other, as individuals and as TG groups, to accomplish the purpose(s) as we see fit as long as we are not hindering the efforts of others in accomplishing the purpose(s), (3) Work on dividing and conquering the "opposition.," and (4) Encourage each other, help each other, and offer suggestions that may help others accomplish the purpose(s) in their own way.

### It's Spiritual, Not Political!

We need to realize that we are fighting a war on a spiritual plane, the battlegrounds of the heart and minds, of beliefs and emotions. It is not as much a political battle as it is a spiritual battle. This is also really not a fight as to whether T'ism is a viable lifestyle or not or whether we should be included in anti-discrimination policies or not. Instead, it is really a fight at a much deeper level. It is a fight on a spiritual plane, if you will, within the belief system of people. That is why it has been so hard to get us included into ENDA and in getting T'ism more accepted by many in the political and religious arenas. It is only when you get a person to change their beliefs on T'ism that you will be able to make progress and you can't do it by attacking them or by "forcing" them kicking and screaming into a changed belief on the matter.

### That's My Belief and I Will Not Change It!

When you "attack" a person's belief system head on, especially when they are amongst their peers, you will tend to instill and ingrain that belief. whether right or wrong, even more-so into their very being. Because you are working on a person's belief system, you are working on the emotional level and therefore, the use of logic will more than likely not be as effective at first as you think in changing a person's mind or rather their belief sys-

In order to increase your chances in changing one's belief about a particular subject, you have to win them over emotionally first without attacking their belief system. Once they are open emotionally, then they are open to changing their belief system. How do we do this? By coming to truly understand what they believe and why they believe what they believe. In other words, "Know your enemy." Once this is done, you then must find common ground on which you both can agree and unite. You must find commonality between the two of you whereby you can bring down the defenses and show that you are more alike than first thought. This will then help develop a relationship

whereby trust is built and doors of listening will be In Part 1 of this 3 part series, I wrote about opened. This may take time and may never take place in many cases. However, you are simply seeking out those cases where it is allowed to take place. Once trust is established, you can then find a way to get them to question their beliefs on a particular topic and then offer an alternative idea on the matter. You must be very careful to not attack their belief on the issue or make them feel as if they are being attacked in any way. Otherwise, you will see walls of defense pop back up very quickly and the ground you gained will be lost.

Once the trust factor has been developed between the two of you, they will more than likely be open to your ideas. They may also begin to question some of their beliefs on the issue at hand. At that point, you will have the opportunity to turn their emotions on the issue from being against you to being in favor for you. How can you do this? By subtly hitting them where it "hurts." You may have to show them how it can hurt them financially and or politically by being against it or help them financially and or politically by being for it. You may need to give them a very good personal reason for accepting the idea that makes sense to them. No matter how you approach the emotional aspect of the issue, you must make sure they do not feel attacked in any way. Once they have come to the "other side" then it is very important to re-enforce their changed belief in a positive manner and not attack their peers in any way in front of them.

Once they become open to change both emotionally and belief wise, they are may become open to logical reasoning concerning the issue at hand, may begin to consider the info provided, and then consider whether or not to change their beliefs on the matter. It first has to hit home in their core beliefs and understanding without disrupting the rest of their belief system. This is the hardest battle to fight and is more effectively fought one-on-one, person-by-person, rather than against a whole group of people at once. People are more willing to listen and change their beliefs concerning an issue when they are approached individually outside of the safety of their peers more than when they are surrounded by their peers. Therefore, we can divide and conquer a group of individuals a lot easier by approaching the individual members on an individual basis rather than in a group atmosphere.

### Last Words

We are actually fighting a war fought on the battlegrounds of the hearts and minds, the beliefs and emotions, of those we talk with. Therefore, we must make sure our strategy includes ways of reaching those we talk with on the deeper levels where change needs to really take place and thus possibly cause change upon the surface in the political, religious, and economic arenas. At the same time, we must be careful not to overwhelm them with information. It might be a good idea to feed them in piece meals.

PORTLAND. Oreg. - On December 21 county com-

missioners unanimously enacted a resolution to a counthe basis of sexual orientation or gender identity in employment, housing, and public accommodations. Board chairwoman Beverly Stein compared the struggle for transgender rights to that fought for women's rights in the 1960s and '70s. "People back then used to question why women wanted to bother being treated as equals," Stein said. "I think that when people look back on this 25 years from now, there won't be any question as to whether this should've been done or not.'

ATLANTA, Ga. - Atlanta City Council, Dec. 4, enacted a transgender-inclusive non-discrimination ordinance. The new law states victims of sexual orientation discrimination or gender identity may file a lawsuit in the Municipal Court of Atlanta. But critics say the law won't pass constitutional muster.

Councilman Lee Morris was the only vote against the ordinance. Morris, the sole lawyer on the City Council, says he agrees with the intent of the law. But he says the Municipal Court is not the right venue for such complaints. Morris says that the city's charter does not allow it the power to create a cause of action between private parties, and the Municipal Court there is limited to imposing a \$1,000 fine. "I believe in the principle behind the ordinance," stated Councilmember Morris.

Iowa Transsexuals Can Be Discriminated Against ... Again! A judge in Polk County, lowa, ruled that Gov. Tom Vilsack overstepped his authority when he issued an executive order last year forbidding discrimination against gays, lesbians, and transsexuals in state govemment. Judge Glenn Pille wrote: "By adding the addi-

court concludes that he has infringed upon the legislative authority by creating law."

Republican legislators have staged legal challenges to Democrat Vilsack's executive order ever it was issued in September 1999. "It is our responsibility to write laws," stated senate majority leader Stewart Iverson, a Republican. "The governor did not have the authority to write laws."

Here's an interesting fact: In the 25 years before Bush became Governor of Texas, there were only 3 known Trans people murdered in Texas, all in San Antonio. Two were in 1991 and one in 1993. During the five

> years he was Governor, there have been five known murders - three in Houston in just the last two years. Now he's in the White House. The times, they are a changin' ... and it don't sound good.

> WALLINGFORD, Conn. - Despite accusations of bigotry and intolerance from parents and students, the school board voted for early retirement of a transsexual teacher. Without comment, the eight-board members present accepted 39 year-old Scott Hendricks' early retirement request, which many people have said was forced because the high school agricultural teacher is undergoing a sex change. About eight people, including parents, students, told the board members they were wrong in going ahead with the retirement request.

ASHBURN, Ga. - The Georgia Bureau of Investitywide policy that would make it illegal to discriminate on gation is looking into an attack on a gay man in this small rural town. Robert Martin, 32, remains in critical condition after being beaten with a blunt object and left lying outside an abandoned school. Martin, who lives with his mother and disabled brother, and often wears dresses and women's wigs, was not in women's clothing when he was found.

> Residents say Martin is widely accepted by townspeople but that he often teased by teens. has been harassed for being gay. "Everybody in Ashburn knew him. He was accepted. It wasn't a big deal." - TRENTON, NJ A transsexual corrections officer has filed a lawsuit against New Jersey's department of corrections and nine coworkers. Donna Memmer, 36, an M2F with 15 years of working as a corrections officer, charges that she was harassed after informing her supervisors and coworkers at Trenton State Prison that she was going to undergo a sex change. She said she received different job assignments and benefits from what the other workers had, that coworkers put glue in her car locks and threw trash on her car.
- HONOLULU, Hawaii A man who killed a transvestite in 1993 was sentenced vesterday to the maximum statutory 10 years for manslaughter. Demian McGuire pleaded no contest to the reduced charge under a plea agreement reached in September, nearly seven years after Dinh Van Vo was found dead in his Kapiolani Manor apartment. Vo, 51, an unemployed hairdresser, was found strangled Sept. 6, 1993.

McGuire was indicted on a second-degree murder charge in 1996. McGuire, when arrested, told police he strangled the transvestite after watching a pornographic video showing strangulation scenes.


TROY, Mich. — Police say that a 74-year-old man found dead last August was killed by a nephew who needed inheritance money to pay for a sex change. The transsexual, Harry V. Titlow, was arrested in Chicago last week and is expected to be returned to face murder charges. Police say the uncle, Donald Rogers, had heart trouble and was thought to have died of natural causes.

"Shortly after the death, we received information that there might be more to the death," said Lt. Steve Zavislak. Zavislak said the department believes Titlow, who received \$100,000 after Rogers's death; forced a large amount of vodka down Rogers's throat and then suffocated him. The 33-year-old Titlow, who goes by the name Vonlee Nicole Titlow, has been arrested twice on prostitution charges and has advertised herself for hire in a weekly Chicago newspaper as an escort and dominatrix.

How are they faring with other supremacist groups? Wrote one white supremacist in response to one of the groups: "Gay Aryan Sisters? When we take power we will have special camps for vermin like you." This has to be the epitome of an oxymoron ... with special emphasis given the last half of the word!

- Scottish gay couple jailed for torture.... Two gay men who tortured a former drag queen by stuffing a frozen chicken down his trousers were jailed, the Scottish Daily Record reported. Shaun Whitehead, 42, and Jamie Rawson, 31, were sentenced to eight years each. The court found that the two took Francis Mason hostage in July. In addition to forcing the chicken down Mason's pants, the men also beat him up, gagged him with his underwear, and poured bleach over his head.
- Transgender activist Roslyn Houston was honored with a Tasmanian Award for Humanitarian Activities at a December 4 ceremony in Hobart Town Hall, with dignitaries including the town's mayor. The awards are presented by the Human Rights Week Organizing Committee.

"Ros has taken the lead in educating the Police Service on transgender issues and has been instrumental in advocating against Tasmania's archaic cross-dressing laws," said Human Rights Committee chair, Robert Henderson. "Ros is an example to all Tasmanians of how someone with a good heart and a courageous spirit can work with quiet persistence to successfully break down barriers, overcome stereotypes and promote

ISTANBUL, Turkey \_ There are some things in Turkey it's best not to be, and Demet Demir is all of them: a political activist, a human-rights crusader, an animal lover, an environmentalist, a prostitute and, in a revelation that stunned even her left-wing buddies, a transsexual.

Now Demir's embarking on another quest: equal rights for transsexuals and transvestites. She said Turkey's 3,000 transsexuals and transvestites must be accepted into society. They want freedom of expression, jobs, benefits, education opportunities, and state-issued licenses for prostitutes. Transsexuals find it virtually impossible to find work in Turkey.

SEOUL, S. Korea - An unprecedented move to show a South Korean's sex-change operation online has stirred up controversy in this country of little tolerance of homosexuality and transexuality. South Korea is one of the most conservative Confucian societies in Asia. However, the Internet medicalinformation company and the private clinic involved defended their decision, saying that webcasting the operation would help give a better understanding of transgender surgery.

The surgeon, Chang Song Sun, defended his decision to allow it to be shown on the Internet. "Some people might be horrified," he stated. "I think it will help those who are considering this operation although I don't think the webcast will be the deciding factor for their decision."

# TATS MEMBER GOES TO JACKSONVILLE OVER BEEF WITH WINN-DIXIE

hat, all flights are booked into Jacksonville today? With that question answered by Jo Tittsworth, Director of TriEss International, we started a 15 hour road trip. We drove all night arriving at our motel at 4:30 A.M. With three hours sleep and a greasy buffet breakfast, we found St. Luke's MCC Church. We were all to meet here and formulate the protest over orange juice and donuts.

Terrianne Summers, North Florida Transgender Group, was there when we arrived that cold morning. The sun was up and warm, but I still had on my leather jacket AND leather coat. The cold didn't seem to bother Jo, as she was pumped up. I am not sure with what, but she was definitely ready for the protest at Winn Dixie.

Winn Dixie in Louisiana fired Peter Oiler, a Winn Dixie truck driver of 23 years, for his crossdressing in his home. The Dan, a Facilitator of Jacksonville Area Sexual Minority Youth Network (JASMYN) unlocked the church. College age girls started arriving as we exchanged names and dunked donuts. There were seven girls representing JASMYN; Megan, Shannon, Lindsey, Kerry, Garrett, Stacy and Malena. These girls became the backbone of our protest, as they had plenty of signs for all to carry.

Trans=Action and Bobby Young from Tampa came in about this time. I was dead, as I worked the night before we left, but Jo was talking to everyone and throwing their names back to me to write down. I hope I got them all right.

We left for Winn Dixie headquarters and parked on the side street their truckers use. This is where I panicked, as about two dozen (off the clock?) Winn Dixie workers were at what appeared to be a break area close to where we parked. Across the street from them were two police cars. I waited in the car as Jo walked up and conferred with Jessica Archer, Director, Florida Organization for Gender Equality (FORGE), who happened to be on her cell phone with the ACLU (Continued on Page 5)



Jo and I started waving to the truckers, especially the Winn Dixie trucks, and gesturing for them to blow their horns. Numerous truckers waved and honked, adding to the cacophony at the protest site. A few cars surprised us by continually honking and hollering as they drove by. JO

started shouting, "Hello America" and got it confused and said, "Happy America"! She sure is a hoot and a great road trip companion!

When the sun started it's downward stretch, our girls from JASMYN seemed to go in slow motion. A few sat down, but kept their signs held high. As the rallies' final minutes approached, we PM.... West Bound and Down. huddled together for a group picture in front of Winn Dixie's corporate sign. I heard of other protest's in other Winn Dixie cites, but JAX's protest

had two things the others didn't. That was two Texans in boots that were ready to go the distance!

We regrouped at the church for feedback (debriefing?) and to say our good-bys. Jessica asked what we noticed during the day. The answers were varied..."The cars passing by seemed to be supporting us". One driver shouted, "Go back to work".

Jo mentioned that while she was waiting at the corner for me to bring the car up, a lot of Winn Dixie employees came out after we left to have



their smoke break. We made an impact on these employees for sure! Monica and Jessica did a rough count and stated about 12,000 cars saw the protest. Of over 40 supporting organizations, over 30 were represented at this protest.

Jo and I were back on the interstate at 3:15



NTAC PRESS RELEASE

National Transgender Advocacy Coalition, (NTAC), has signed onto the call for continuation of action against the Winn-Dixie Corporation. NTAC has joined a broader coalition of activists, organizations, and supporters who wish to express dismay over Winn-Dixie's discriminatory treatment of a transgendered employee.

The recent protests on Jan 5, 2001, followed a boycott started on Dec. 18, 2000. At the heart of the protests and boycott were issues surrounding Peter Oiler's iob termination on Jan 5, 2000. Mr. Oiler, a truck driver for Winn-Dixie in the New Orleans area, was employed for 21 years by the company before being fired because he crossdresses away from work. In October 1999, amid rumors that he was gay, Mr. Oiler, who is married, confided to a supervisor that he is transgendered.

Within three days, management asked Oiler to resign, saying that someone had seen him cross-dressing off duty; and how this could be bad for the corporate image. When he refused to resign, he was terminated.

Eric Ferrero, one of Peter Oiler's ACLU attorneys from New York, said the specifics of the case could not be commented upon, but was quick to express appreciation for all the support from the GLBT community. Winn-Dixie spokesman Mickey Clerc said the company could not comment on any pending litigation.

Jessica Archer, director of the Florida Organization for Gender Equality (FORGE), was coordinator of the protest at Winn-Dixie's corporate headquarters in Jackson-

ville, FL "I feel it is always important to stand up when there's discrimination or bigotry of any kind," Ms. Archer said. Her group wants Winn-Dixie to begin company wide diversity training, gender education, draft antidiscrimination language for employment policies, and to publicly acknowledge diversity is welcome at the company, and to realize it is vital to a safe, productive work environment.

The Winn-Dixie action saw an unprecedented, broad-based coalition form; which organized a massive e-mail and phone campaign directed at the company's corporate offices. In addition to the protest in Jacksonville, there were similar protests organized at other Winn-Dixie locations, including the division offices in New Orleans.

Since its debut in 1997, I've only voluntarily watched three complete episodes of the show. The total would be four, but I missed the first of this year's Cindy episodes.

By now, most of you know that Cindy was an attractive, confident, intelligent pre-operative maleto-female transsexual who entered the McUniverse as a client and ended up dating one of the McLaw-Firm's legal McBeagles (I'm not even going to attempt to keep track of the names of the show's characters; I can't stand any of them, even Lucy Liu's character.)

As part of a larger legislative package, the street with a McLawFirm secretarial job, without Democratic leadership introduced the Protecting Civil Rights for All Americans Act. This legislation includes six different provisions that show a commitment to basic human rights.

> The first section is federal hate crimes legislation that includes sexual orientation. The second is a study that will explore the national problem of racial profiling. Section three would give more money to the Legal Services Corp., which provides legal representation to low income individuals and families. The fourth section is legislation to outlaw discrimination based on genetics. The fifth section is legislation that outlaws employment discrimination based on sexual orientation. The final section deals with increased funding for law enforcement agencies that deal with enforcing civil rights laws.

During a press conference immediately in front of Park Bench #1276, Greblehcats acknowledged Cindy should be back a bit earlier than that some transgender activists will not support the Protecting Civil Rights of All Americans Act because protections on the basis of gender identity or expression are excluded. Greblecats notes, however, that in 1998, the Human Rights Campaign passed a resolution supporting civil rights for all Americans regardless of sexual orientation or gender identity. The Human Rights Campaign has also been engaged in real and meaningful work for transgendered people on Capitol Hill since September of 1995. In addition, the Human Rights Campaign maintains an extensive list of all activities which indicate their support.

## CROSSDRESSING SHERIFF'S NFPINY FORGEN TO RESIGN

FAYETTEVILLE, NC - In what's turning out to be a repeat of the Winn-Dixie case, a cross-dressing Cumberland County Sheriff's deputy says he was forced to resign after someone outed his lifestyle.

Richard Silvestri resigned Oct. 5, the day after Capt. Van Parker advised him in a memo that an internal investigation was being conducted regarding possible violations of unbecoming conduct, failing to obey a direct order and other allegations.

"The possible policy violations relate to your making public your transgender lifestyle, how that admitted lifestyle affects your ability to perform your duties as a deputy sheriff and to interact with your co-workers and the public perception of any apparent endorsement by the Sheriff's Office of such a lifestyle," the memo

Silvestri, 47, said he resigned because he did not want a witch hunt that would hurt his friends and family. Now, however, he wants his job back, saying his personal life is his busi-

"I don't bring it to work," he said. " I've gotten a lot of support from a lot of officers. I was good at what I did. I did my job. The accusation was that I wasn't doing my job, and that's bologna. I want my job back.

In the memo from Parker, Silvestri is also accused of disobeying a direct order by wearing earring studs to work.

Silvestri, who served 20 years as an Army paratrooper, was married 25 years before his divorce was finalized this month. He has two grown sons.

It's yet another example of how even heterosexual crossdressers are no longer safe from the scrutiny, judgment and prejudice that was once primarily the reserve of transsexuals.

n January 1997 I wrote an article for the TATS newsletter in which I gave a little snapshot of what it's like to be a transgendered African-American female. It reflected my thoughts at that period in my life and I felt that it was time for an overdue sequel to that article.

It's January 2001 and I have been transistioning for almost 6 years now (time flies when you're having fun). There are some major strides that I have made in my life since then. I am integrated back into my family's lives and have a niece that adores her aunt. I still have many of my pre-transistion friends and talk to them frequently on the phone or e-mail them. I have new friends, both transgender and non-T who have replaced those associates who split when I began transistion. In short, I'm deliriously happy for the first time in my life and comfortable with the person I see in the mirror every moming.

However, there are times when somebody puts a nasty cup in my Kool-Aid. I still get a little pissed about the time I got called the Nword in Cousins several years ago, and I had a little drama with my former T-roommate when she called me a sellout because of the activism I was doing and she also asserted that I was 'too bourgie' to hang out with the peeps at Rascals.

Let's start with that drama with my ex-roommate. My roomie was sixteen years younger than me and I ripped her a new one after that comment passed her lips. I am proud of my heritage as an African-American and resent being compared to Clarence Thomas and emphatically told her that. I also won't apologize for the fact that I'm middle class, a TK (teacher's kid), grew up in the 'hood, am blessed with intelligence, have a college education and make good money working for a Fortune 500 com-

The bottom line is that when I am lobbying on behalf of the T-community, at work, or just hanging out one of the things people are going to notice is my skin color, and there isn't a damned thing I can do about that. Since the good old USA has done everything based on skin color since the 17th century, I won't hold my breath that those attitudes will change in the 21st century. All I can do is be the best person I can be, and if some bigots and playa haters in the T and non-T community don't like that

they can go to Hades.

There is nothing more difficult in this society than being a Black male, with the exception of being a Black female trapped in a Black male's body. To be Black in America is to endure daily slings and arrows in terms of negative comments, prejudicial assumptions about your abilities (or lack thereof), and just dealing with a world in which the messages sent about you and your people are overwhelmingly negative or racist in content. Just last week at work I tongue-lashed a passenger who made the mistake of saying in front of me that all Black people were brainwashed into voting 90% against George Junior. She said this after she looked at my ID badge and verbally changed my last name from Roberts to Lewin-

I don't miss the days before transistion when women would switch their purses to their opposite arm as I walked by, or clerks would follow me around stores as-

suming I was going to steal something, or the three times I was pulled over for Driving While Black. In the 1983 DWB incident the White cop that pulled me and my friends over had the nerve to ask us what we were doing over in SW Houston when our licenses had South Park addresses on them. (We had just left a Black club on Fondren and W Bellfort and Fondren Southwest at that time was about 85% white). It wasn't all bad, though. I led a fairly interesting life on the other side, I just never felt comfortable being male and that makes it very difficult to deal with the issues that you face being a Black male.

Another aspect of being a Black transsexual is the 'First Black' or loneliness factor that you are constantly battling. I was the only African-American at the 1999 Texas Lobby Day and I will probably be the Lone Sista again, and I'm the only one at the TATS meetings that I can make. Sometimes the Lone Sista Syndrome hits when the conversation turns to music groups that I didn't grow up listening to or when I'm trying to discuss a point with a conservative trannie whose exposure to what African-Americans think has been filtered through AM talk radio. Don't get me wrong, I like everyone in TATS and Sarah DePalma, Phyllis Frye, and Vanessa have been my mentors in terms of my growth as an activist, but there are days I feel underappreciated and wish I wasn't "The Black Trannie". I get tired sometimes of having to act as the spokesperson for all Black trannies and wish I had other Black T-peeps willing to step up and take some of the responsibility and load off my shoulders. But as Dorothy Height once stated: 'When you're a Black woman you seldom get to do what you just want to do; you always "do what you have to do" and being an activist is what I want, need and have to do. So is being a role model.

There are many Black trannies here in Houston, but many are stealth and are reluctant to have any public contact with yours truly because of my activist profile. There are others that don't wish to associate with me because they don't know me and echo the same sentiments that my ex-roomie uttered, and there are a few that I don't want near me because they care more about the street life's easy money than working 40 plus hours in corporate America and making it legitimately. I do have some Black T-friends, but most are out-of-state with the exception of my girl Jordan (not her real name) who works more than I do and lives across town. Jordan is a UH alum (like me), possesses a drop-dead hourglass figure, and when we do get together we talk for hours on a wide range of subjects. Dawn Wilson and I are the same way when we hang out. It's just nice to be able to talk to someone that shares your cultural background and has gone through the same trials and tribulations that you have.

In 1892 Anna Julia Cooper stated that "When and where I enter... then and there the whole race enters with me." I am discovering after almost six years of transistion that statement applies to me as a transgendered African-American female. I accepted this challenge in 1995 and I will never forget that I am trying to live up to a legacy of Black women such as Harriet Tubman, Barbara Jordan, Coretta King, my mother, and my grandmothers. Am succeeding? I believe the answer is yes.

"I hope to give our community a voice in the enforcement of discrimination laws in San Francisco," Sparks, 50, said in an interview after the ceremony in Mayor Willie Brown's office. "Even in San Francisco, transgender people are still stereotyped," she said. "Transgenders are fine as long as they're street theater. As soon as we move into the apartment next door or use the bathroom, then we become a problem."

The first meeting of her unpaid, four-year term will come next week. "Finally, we have a part in helping ourselves rather than having to rely on the help of others," Sparks said. "For so long, we've been on the outside looking in."

Rights Commission investigates and mediates discrimination complaints, monitors city contracts for compliance with city nondiscrimination policies and certifies minoritywomen-owned and businesses in city con-

"We've tried to reach out to the transgender community so that our city commissions reflect the diversity of San Francisco," Brown said. "Theresa helps . . . brings representation that we didn't have." There are an estimated 15,000 to 18,000 transgender men and women living in San Francisco.

Leno, who attended the ceremony, said Sparks' appointment accomplishes one of the Transgender Civil Rights Task Force first goals: getting more transgender men and women into city jobs and commission slots. "Theresa brings human understanding and mindedness to the commission," Leno said.

In Part 1 of this series, I wrote about how we are basically our own worst enemy in that we tend to cause diin having a "My way is better than your way" attitude. I also talked about how we need to (1) Come together as (1) a community and develop an overall consensus on a common purpose(s), (2) Allow each other, as individuals and as TG groups, to accomplish the purpose(s) as we count what I have written in Part 1 & 2 of this series, to see fit as long as we are not hindering the efforts of others in accomplishing the purpose(s), (3) Work on dividing and conquering the "opposition," and (4) Encourage each other, help each other, and offer suggestions that may help others accomplish the purpose(s) in their own cases? It is more acceptable and also includes, in one's

In Part 2, I wrote about how we are actually fighting a war fought on the battlegrounds of the hearts and minds, the beliefs and emotions, of those we talk with. Therefore, we must make sure our strategy includes ways of reaching those we talk with on the deeper levels where change needs to really take place and thus possi- (2) bly cause change upon the surface in the political, religious, and economic arenas.

### Include or Not Include, That is the Question!

It seems to me that the GLB leaders that are pushing for ENDA are not really interested in including the T Community. Think about it, the opportunity to include us within their fight, within their agenda, was avoided during their speeches at the Democratic National Convention. If they wanted us to be included, that was the perfect place to mention the T-community, on national T.V. We have and continue to push and push and push inclusion without much headway. It doesn't seem to me that we will be included anytime soon. All we seem to hear is rhetoric saying, "We will support you!" However, their actions seem to say, "We don't want to really include you." Maybe I am wrong in my perceptions and assumptions on this matter. The point I think we need to realize is that, if they really want to include us they will, otherwise, we are beating our heads against a brick wall or we need to approach the leaders of the GLB from the approach mentioned in Part 2 of this series.

### A Greater Benefit

Why does it seem that the GLB leaders that are promoting ENDA do not want to include us? Probably because they see a greater benefit of NOT including us in ENDA versus including us. They feel that ENDA will pass easier with us NOT on it. If the benefits of including Transgenderism were greater than not having it included then they would include it. What do you think? They say that we should not worry about being included for now, because once the current form of ENDA passes they will work to get us included later. Right! I have a feeling that if ENDA passes they will become complacent on the matter and enjoy the victory and not fight as hard, if at all for our inclusion. That is usually how human nature works. Therefore, I suggest a different approach.

### A T-Only Version of ENDA: EGENDA

I wonder if it would actually be easier to get a T-only

version of ENDA passed. Maybe we could call it something like EGENDA (Employment Gender Expression Non-Discrimination Act) or some other name. Whatever vision amongst ourselves through personal attacks and we call it, I feel that we need to make sure that the T-only

> Replaces the term "Transgender" with the term Gender Expression (GE) or Gender Role (GR),

> Why? Because it may be possible, taking into acget a T-only version of ENDA under the radar by making it more acceptable in using new terminology. Why do you think the term "sexual orientation" is used instead of "homosexuality," "gay," "lesbian," or "bi-sexual" in many mind, the heterosexual community. However, it seems to be becoming associated more and more with primarily the homosexual community in people's minds now. Using the terms "gender expression" or "gender role" includes everyone both male and female and at this time does not carry any negative connotations to them.

Does not include sexual orientation, and

The term "sexual orientation" and "transgender" are much brighter red flags than "gender role" or "gender expression." Also, the words "sexual orientation" have been bounced around so much that they are almost automatically related to homosexuality in the minds of many which is still taboo in society as a whole and in many politicians minds. The term "transgender" seems to have the same stigma attached to it. That is why it may be better to use the expressions "gender expression" and or "gender role." It may be easier for more to swallow, especially those sitting on the fence and thus even go somewhat undetected by their mental radar unlike if the terms "sexual orientation" and or "transgender" were

Is attached to other bills by T-friendly politicians. In finding T-friendly politicians that will attach a Tonly version of ENDA to another bill that is very likely to be passed and needs to be passed it will help us get it under the radar or at least increase our possibility of getting it passed. This is what happened with President Bush. He said, "No new taxes" during his campaign and then when he took office a bill was presented to him with a tax bill attached to it. He felt that it was more beneficial to sign the bill with the added tax bill than it was to not sign it. In essence, he was forced to pass "new taxes" even though he did not want to and thus become a liar concerning his statement of "No new taxes." Why not do

### We Want Sexual Orientation Included

Now, I know that there will be those within the T-Homosexual Community that would not like sexual orientation removed from the T-only version of ENDA. Let me ask, "Who needs to know what your sexual orientation is?" The reason why we need ENDA is because the employer makes sexual orientation an issue in the work place. But just as heterosexuals are expected to keep their private affairs out of the work place we should also. If the current form of ENDA is passed then that will cover the sexual orientation part of your life. If only EGENDA is passed then that would protect the gender expression part of your life and possibly the sexual orientation if approached right. If both ENDA and EGENDA are passed then 100% of your lifestyle will be protected.

For example.

- What if you do not pass as the opposite sex? More than likely, your employer will see you according to your body's birth sex and not your gender. In this case EGENDA would protect you. If you are a T-Homosexual and not passable as the opposite sex and you are dating someone with a body sex opposite of yours, your employer will probably see you as a heterosexual rather than homosexual. That means that the sexual orientation issue will most likely not be an issue and EGENDA would protect you in regards to the gender expression
- What if you did pass as the opposite sex of your body's birth sex and they hired you as a woman thinking that your body sex is female and you started dating women? Your employer would probably see you as a homosexual. In this case, ENDA would protect you if it were passed. If it was not and EGENDA was passed then you could, if approached right, be protected under EGENDA. If they later found out that your body's birth sex was opposite of what it portrays now, then EGENDA would still protect you.

Most people see Transgender individuals as homosexuals, even though the majority of the T-community is not. This is especially true among heterosexual males. I feel that if we can...

- Disassociate sexual orientation from the Tcommunity,
- Get those we are talking with educated about the nature of T'ism, and
- Get them to see it as a gender expression/role issue and or possibly a sex discrimination issue (i.e. individuals born with female bodies are allowed to wear clothes that are malish in nature while those born with male bodies are not allowed to wear clothes that are femalish in nature without losing their job or being harassed for doing so.).

... we just may open up more doors for acceptance.

### **Outside Help**

Sometimes, in order to bring down the castle, you have to enter it through the back doors and the secret tunnels and attack from within. If we could get some of the major corporations that already have made headway by including us in their anti-discrimination policies (i.e. Shell, Chase, and etc.) to lobby with us, we might increase our chances of success. How would it help if we could get some of the big lobbyists (i.e. pharmaceuticals from which we purchase our medicines and hormones from, the oil industry, and etc.) to include EGENDA in some of their lobbying efforts? How would it help to get those in the medical, mental health, and legal professions (both T's and Non-T's) that work with the Transgender community to join us? What if we could convince ministers of faith that understand the Transgender issues to lobby with us? What if add a more personal touch by having more of the understanding and accepting parents and children of Transgender individuals joining us in our lobbying efforts? I wonder what kind of effect we would

legislation. "Political progress is always incremental. Now is the time for gays and lesbians to secure their civil rights. Much education is needed before transgendered people can secure their rights. We are just glad that the Human Rights Campaign invites us to their fundraisers. That is progress enough for our members."

Grebleheats also is happy that the Human Rights Campaign once bought her donuts during a lobby day breakfast in 1998. That was the only food she had that week so she remains grateful.

Greblehcats remains confident that once the Protecting Civil Rights for All Americans Act passes this year that the bill will be amended to include protections based on gender identity and expression. The Human Rights Campaign promised this to the transgender community. We have no reason to think that the Human Rights Campaign will not keep their promise to our community.

When asked if it was a coincidence that her name had much in common with the name of the HRC political Director, Greblehcats indicated that it was just a coincidence. "There is nothing backwards about HRC or the people associated with them. Such claims are just misinformation about HRC". Greblecats.

A number of legislators said they could not support bills, but that they could help in other ways. One way was to take a walk, meaning that they would be absent when voting occurred, thus


against. Others said that they would not block votes for a bill to leave committee to get on the floor. All in all, it was terrific. These were the people who made and changed the laws in the

# **4S IN HOUSTON**

The most recent one gives every indication of being a biasrelated crime; however there are no hate crime statutes in Texas, and the current proposal will not include transgenders. Police have arrested Aurelio Campos, 19, alias Wayo Campos, in connection with the shooting death.

In the second killing, that of local female impersonator Brandi Houston, police are seeking

# EGROUND: HOUSTON! THE WAR FOR OUR RIG

n a hastily called meeting, approximately 45 of Houston's most politically active Gay, Lesbian and Transgendered leaders met at the Hollyfield Center on a Saturday morning to discuss something the community has anticipated for some time. The meeting assembled by the brand new mayoral liaison to Houston's GLBT community, Janine Brunjes, and chaired by both Mayor Lee Brown and Councilmember Annise Parker, was an open community discussion to gauge the community's opinion and seek some direction by consensus. At issue was a likely referendum to come up before the city's voters.

What had originally arisen as an attempt to include same-sex domestic partners in the city's benefits package became a political football by the city council's more conservative members: namely Todd and Orlando Sanchez. Both councilmembers Todd and Sanchez, with backing from councilmembers, Mark Ellis and Bert Keller, decided to push the same-sex benefits issue to a referendum vote - in other words, to have the city's voters decide the issue. Little did we know the outside forces contacted or how ugly this

situation was going to be. Thus, a meeting was called to get community feedback and to strategize the next move in regards to the referendum. Representing the transgender community at the meeting were three of the four most politically active trans-folks in the city: TATS members Sarah DePalma (Exec. Dir. of TGain), Jessica Redman (VP of the Houston Gay & Lesbian Political Caucus), and yours truly. Phyllis Frye, now retired, declined the invitation.

The result of the referendum was that months later, when the city's races came along, a "Straight Slate" of candidates was coalesced and won most all of the following election races. It was like being Jewish surrounded by swastikas or a Person of Color surrounded by burning crosses."

History has proved this will be an ugly fight, and indeed it was confirmed even before the meeting. Sarah DePalma received a call from our friend in Colorado Springs, Dianna Ciccotello, who monitors the goings on of the Focus on the Family (FOF) / Gary Bauer-James Dobson folks. According to Dianna's report, FOF had already declared Houston to be "the next battleground."

As if to emphasize that, the following week during the city council meeting, a 'straight slate' of arch-conservatives one-upped the GLBT strategy. The group took the initiative to push for their own referendum: change the City Charter in order to prevent any future considerations or laws protecting anyone who is gay, lesbian, bisexual or transgendered. The opposition has officially fired the first salvo over our forward bow!

Thusly engaged, we go into battle; and we'll need all hands on deck! As history is our teacher, it will be ugly! More importantly, our friends on city council - Mayor Brown, Annise, and anyone else on council who supports us - will take their share of shots. They will be targets in the next elections.

Our task is two-pronged: become heavily involved in PVA and the upcoming referendum battle, and also work diligently to keep our friends on city council - most especially, Mayor Brown and Annise! Fear will push all of us off the fence, either into action or into the closet. Those of us community leaders have our tasks cut out for us. So lock and load ... it'll be a long fight!

a Georgia man in connection with that murder.

According to a news reports, the body of 29 year old Francisco Javier Luna (femme name unknown to us) was found at around 4:30 AM Sunday, March 4, in a parking lot in the 7800 block of Avenue E in Magnolia Park area on Houston's East End. The "man masquerading as a woman" was shot four times - in the face, abdomen and shoulder - after a witnesses heard an altercation and several gunshots. Luna's body was found lying beside a maroon Dodge Dynasty with paper dealer tags. Luna was dressed en femme, with a brown ladies' wig found near the body.

"We've ID'ed the shooter," HPD Det. C.T. Mosqueda told the Houston Voice on March 8 regarding the Luna murder. The following day, 19 year-old Aurelio Campos was arrested and charged in connection with murder. However, there will be no hate crimes charges to add to that.

Police are uncertain how Campos and Luna met, but believe the two arranged to meet downtown. "Basically, the victim was told by this particular suspect to meet him at the 7800 Block of Canal," Det. Mosqueda said. "We don't know if it was a drug deal or a sexual-type deal."

Mosqueda said witnesses saw Luna enter the passenger seat of Campos' vehicle. "There was some type of activity in the vehicle - we don't know what - but something occurred that set the suspect off and he jumped out of the car and ran around to the other side and shot the victim."

The victim then reportedly exited the vehicle and fell the ground where Campos allegedly shot Luna several more times. Campos then fled the

"Information provided to TGAIN suggests that this was a definite hate crime" declared TGAIN executive director, Sarah DePalma. "I cannot begin to express the anger I feel that if this should turn out to be a crime committed due to hate, it would not be covered under either of the proposed hate crime bills working through the Texas Legislature. Anyone who would like to know why transgenders are not included in this legislation should contact the Lesbian / Gay Rights Lobby of Texas."

The previous murder was more sketchy, as it was reported first as a murder, then natural causes and finally back to a murder. Brandi Houston, a local performer in at EJ's and similar venues, was found dead in her apartment on January 26. Though a performer, it was reported Ms. Houston lived for the most part as Brandi.

Original word from GCTC president Jackie Thorne was that Brandi killed, dead of a broken neck. Later police had given a contradictory scenario. Former Imperial Court emperor Bob Bouton had mentioned a couple days later that it was thought that Brandi had died of a massive heart attack, and that the other circumstances were subsequent to the heart attack.

However, it was learned after last month's newsletter went out that indeed Brandi's death had been ruled a homicide. The police are seeking NJ. As yet, her relatives have not been located.

These two murders now make up 2/3 of the transgender murders to date, as reported by the Remembering Our Dead site (www.gender.org/remembering).

During that period in the early mid-90's, she was one of the original members of what eventually became Transsexual Menace.

Kelly had moved down to Houston from New York in August of last year. She hoped to start anew in an attempt to get her life in order, and found some limited success upon first arriving. She was active for a time in the Unity Committee meetings planning the upcoming Unity Banquet, and also had non-TG friends down in the Clear Lake area as well.

According to one of her close friends in New York, she was despondent over her job prospects when she'd last spoken with her on Valentine's Day. Though she'd really made a push for permanent employment. Kelly was finding only unfulfilling temporary positions. Her only known next of kin is her father, perhaps living in Bayonne

# NY CITY COUNCIL POISED TO BAR TG DISCRIMINATION

fler months of behind-the-scenes wrangling at New York's City Hall, a change in the city's human-rights law, giving explicit protection to transgender individuals, could soon become law. The March 7 report stated City Council Speaker Peter Vallone had given the go-ahead the week before for the bill to be considered in the General Welfare Committee. The proposed bill has languished in the city attorneys' office for eight months.

The speaker's office held up the potentially controversial bill, sponsored by Councilmembers Bill Perkins and Margarita Lopez, because discrimination by gender already is covered in the human-rights law. The proposed amendment would prohibit discrimination based on gender identity, self-image, appearance, behavior or expression, whether or not it is 'different from that traditionally associated with the legal sex assigned to that person at birth."

"Gender to me is male or female," said democratic Councilmember Lopez of Manhattan in a report to the New York Post. "It does not include those perceived to be male but who dress like a female." Councilmembers Lopez and Perkins found that victims of discrimination were often made into pariahs, lost jobs and apartments, and were refused service in public accommodations such as restaurants

Council officials said the bill was in limbo while they waited for clarification from city lawyers. That clarification never came. "The Corporation Counsel indicated that they would send something in writing and the absence of that means we have to move ahead," democratic Councilmember Perkins of Harlem stated.

Mayor Giuliani's position on the matter is so far unclear, and city lawyers did not comment.

A spokesman for the city's Commission on Human Rights, Andres Roura, said transgender city residents, including pre- and post-surgery transsexuals, are already protected by law. "It's not a protected class by itself, but they are protected under our gender category," he said.

But advocates argue the law is ambiguous. "If the law is written in black and white, then its clear," said Victoria Cruz of the Anti-Violence Project, who describes herself as a female born with male organs.

The first hearing has been tentatively scheduled




# SARAH DePALMA LOBBIES <del>CONGRESS</del> CAUCUS




It wasn't merely a token appearance. Sarah was there not only to speak on her personal history, but also to teach a bit of Lobbying 101. And indeed,

The organizing group, Street Transgender Action Revolutionaries, or STAR, has recently had new life resuscitated into it by one of its founders, Sylvia Rivera. The move by the board of NTAC only highlights the history and fresh new direction undertaken by this storied group.

beginning of the murder trial of the two men charged in Amanda Milan's death. Ms. Milan, a transgendered woman wellknown and well-liked among New York's street-workers, had her throat slashed in front of dozens of witnesses in the early morning hours of June 21 last year. The killing drew national attention due to the reactions of the bystanders at the scene. After 20-year-old Duayne McCuller sliced Milan's jugular, leaving her dying on the city sidewalk, nearby cabbies who watched the incident stood by cheering and applauding. Both McCuller and accomplice Eugene Celestine - the man charged with both encouraging him and supplying the knife - go on trial sometime in April.


Ms. Milan's death and bystanders' response inspired outrage from the

transgender national community. An outpouring of grief and anger drew an estimated 300-plus to a candlelight vigil in memory of the victim - unprecedented for the death of a street-worker. it Most notably New galvanized York's gay, lesbian, bisexual and transgender community like nothing since ... Stonewall! Thus it's fitting that Ms. Rivera,

widely credited with instigating the Stonewall Riots in 1969, resurrects her creation from that era to coordinate the Amanda Milan Vigil in 2001.

The officer, traffic lieutenant Brian Lunan at the county's Eastside sub-station, informed Sheriff Ralph Lopez of the change on February 20. Initially reticent, Lopez recently ended weeks of speculation by holding the news conference allowing Lt. Lunan to proceed with counseling and the transition process.

the incident drew immediate ire. Less than a week after the news hit, Rev. Fred Phelps of Topeka's Westboro Baptist Church - and creator of the GodHatesFags website - began the expected denunciations. Not willing to let that suffice, he then concocted an obscenely cartoonish flyer depicting the Sheriff in leather harness and fishnet hose.

"I support lieutenant Lunan's constitutional right to make individual choices. That is my official position," said Bexar County Sheriff, Ralph Lopez in a March 5 press conference on KSAT TV. "This is something that is covered under the Americans With Disabilities Act," stated Lopez in regards to questions about the transitioning. Sheriff Lopez. The sheriff intended to abide by that decision.

Meanwhile as the press conference took place inside, the church group from Kansas and counter-demonstrators sparred verbally outside the county sheriff's department. Leading the circus-like demonstration was Rev. Fred Phelps himself, railing against Lunan's decision and Sheriff Lopez' support.

Phelps and several members of the Westboro Baptist Topeka, Church from demonstrated with signs and even got into arguments with several people. "Thou shall not libel mankind with woman kind, that is abomination," Phelps blasted. "That will take

your soul to hell!"



Lunan has been a lieutenant at the Eastside substation since 1997 and has been with the sheriff's department since 1985. Lopez said that he has already given the officer permission to start the transition process by allowing Lunan to grow her hair and to start dressing as a woman soon.

The lieutenant is said to be well respected. "I respect him as a supervisor ... to me it doesn't matter if he's a male or a female ... I still believe he can do the job," Metcalf said. While there's still work to be done regarding pronouns, the officers at Bexar County Sheriff's Dept. are to be applauded for

their loyalty and their open minds. In an environment as frequently oppressive as South Texas, progressive mindsets such as theirs are very refreshing indeed.



Regretfully, though, I now resign my position of editor for this newsletter.



Afterward the arresting officer came back into the room and asked De Souza if she was a man or woman. The assault and battery charge was dismissed in 1997. The policeman who arrested De Souza has




TAIPEI, Taiwan - A deepening recession and lack of jobs is persuading men in Taiwan that they would be better off as women. A new report shows an increasing number of men in the country with transsexual leanings are resorting to sex change operations as a way out of economic problems.

It is hard for effeminate men in Taiwan to find satisfactory employment, especially during this economic downtum, and more and more are determined to shed their manhood so they can get jobs such as female entertainers. Most have the operations carried out in Thailand, reports the China Times, and after the surgery almost all keep their original identity secret.
