### 1. 2021 Annual General Meeting

## 1.1 Establishment of Quorum

In accordance with Chapter VI Clause 28 of the Constitution, there is quorum to transact business with 17 out of 45 members (37.78%) present.

#### 1.2 Call to Order

Chairman Mr Toh called the meeting at 1pm to order and thanked everyone for setting aside valuable time to attend the 2021 AGM. Besides providing an overview of last year performance, the AGM will also present Sian Chay's 2021 Financial Statement, 2021 annual report and adaption of Board Resolution on Constitution amendment.

#### 1.3 Adoption of Agenda

The agenda was adopted as presented.

### 2. Confirmation of Minutes of Previous Meeting

There being no question from the floor, the minutes of 2020 AGM were confirmed and adopted as proposed by Mr Raymond Chua Swee Wah and seconded by Mr Yap Seng Teck.

### 3. Report

## 3.1 Adoption of 2021 Annual Report

The 2021 Annual Report has been sent to all members. Details of the events and activities during Covid has been included in the Report for your perusal. The Report was presented at the meeting, there being no question from the floor, 2021 Annual Report was proposed for confirmation and adoption by Dr Simon Keak Lai Heng and seconded by Mr Ng Cher Yen. Please refer to the attached for details.

### 3.2 Adoption of 2021 Audited Statement

Auditor UHY Lee Seng Chan has performed the audits for Sian Chay's 2021 accounts which are deemed to have fulfilled requirements. The Audited Statement has been sent to all members for member's perusal. Mr Michael Ong Kian Meng, Partner of UHY Lee Seng Chan & Co reported the financial highlights of 2021 to the floor. There being no further question raised, the Audited Statement 2021 was adopted and accepted as proposed by Mr Raymond Chua Swee Wah and seconded by Mr Kenny Lim Oon Cheng.

#### 3.3 Appointment of Auditor for 2022

The appointment of UHY Lee Seng Chan as the auditor for the financial year 2022 was tabled for consideration. The motion to appoint the auditor was proposed by Mr Yong Kee Tong Clifton and seconded by Mr Ng Cher Yen. The meeting voted unanimously in favour of adopting the resolution to appoint UHY Lee Seng Chan as auditor for the financial year 2022.

### 3.4 Seeking Member Approval

### 3.4.1 Constitution Amendment

In view of Sian Chay's future development plan to better benefit more people by providing higher quality holistic TCM and welfare services, and to ensure the Constitution is comprehensive in its coverage, Chairman and his team has suggested amendments to the Constitution. (The last amendment was in 2018).

The final amendment took place on 15 June 2022 during the 84<sup>th</sup> Term (2021-2023) 4<sup>th</sup> Board meeting, 9 out of 11 Board members attended the meeting, achieving an attendance of 81.81%. All 9 Board members present for the meeting have given their support (100%) for the amendments, proposed by Dato' Seri Jackson Teo Ngiang Heng PBM, seconded by Mr Clifton Yong Kee Tong.

The revised proposal has been sent to the members for reference along with the notice of 2021 Annual General meeting, and presented to the members attending the meeting. The chairman urged members to comment on the proposal.

As At 29/06/2021, the secretariat received a total of 29 Members Approval Form (64.44%) supporting the Constitution amendment.

## 4.3.Update of Member Listing
