

PUBLIC VOTING AND LUCKY DRAW FOR CHINGAY: ROAD TO UNESCO MURAL DESIGN COMPETITION

Terms and Conditions

1. Organiser

1.1. The Chingay: Road to UNESCO Mural Design Competition Public Voting (the “**Voting**”) and Lucky Draw (the “**Draw**”) are organised and conducted by People’s Association (“**PA**”).

1.2. By taking part in the Voting and the Draw, you (also referred to herein as the “**Participant**”) confirm that you acknowledge and accept all the terms and conditions set out herein (“**Terms and Conditions**”).

2. Voting and Draw Details

2.1. The Voting and the Draw will be conducted as part of the Chingay: Road to UNESCO Mural Design Competition (“**Competition**”) organised by PA.

2.2. Subject to these Terms and Conditions:

2.2.1. the Voting is open to Participants who cast a vote for any of the ten (10) shortlisted mural designs in the Competition from 1 November 2025, 10:00am to 31 December 2025, 11:59pm; and

2.2.2. all Participants who cast a vote for any of the ten (10) shortlisted mural designs in the Competition will be automatically entered into the Draw. No separate registration or additional action is required from the Participants. By voting, the Participants consent to their inclusion in the Draw.

3. Eligibility and Participation

3.1. To be eligible for the Voting and the Draw, Participants must be 18 years old and above at the time of participation.

3.2. Each participant is entitled to only one (1) entry into the Voting and the Draw.

3.3. Employees of PA are not eligible to participate in the Voting and the Draw.

4. Methodology and Winner Selection

4.1. Winners of the Draw will be determined through a system-generated random draw conducted within ten (10) working days after the announcement of the winning mural design of

the Competition and under the supervision of an independent appointed scrutineer.

4.2. A total of fifty (50) unique winners will be drawn for the Draw. Each winner will receive 20,000 yuu points (worth S\$100 each). If the winner also has a valid PAssion Card membership, he/she will receive an additional 20,000 yuu points (worth S\$100 each).

4.3. Winners of the Draw are selected at random, and the chance of winning depends on the total number of eligible entries received during the qualifying period.

5. Prize Allocation and Redemption

5.1. All prizes will be awarded is in the form of yuu Points, credited directly to the respective winners' yuu Singapore Rewards Club account ("**yuu account**").

5.2. Each winner must:

5.2.1. have a valid and active yuu account to receive the prize of 20,000 yuu points (worth S\$100 each); and

5.2.2. have a valid PAssion Card membership to receive the additional prize of 20,000 yuu points (worth S\$100 each).

5.3. yuu points will be credited within fourteen (14) days after the winners have been notified.

5.4. Prizes are non-exchangeable and non-transferable and shall be subject to such terms and conditions which PA may impose.

5.5. PA reserves the right to substitute any prize with another of equivalent or similar value at its sole discretion without prior notice or liability.

6. Notification of Winners

6.1. Winners will be notified by PA via SMS and/or email, based on the contact details as provided at the time of participation in the Voting.

6.2. A notification will also appear within the yuu app to confirm the successful crediting of the awarded points.

6.3. Participants are responsible to ensure that their contact details as provided at the time of participation in the Voting are accurate and up to date.

7. Unclaimed Prizes

7.1. If the prize cannot be credited due to an invalid or inactive yuu account, PA will make reasonable efforts to contact the affected winner during the prize claim period.

7.2. If the prize remains unclaimed or uncredited two (2) months after the winner has been notified, he/she is deemed to have forfeited and irrevocably given up and waived all rights to the prize.

7.3. No further claims, extensions, or substitutions will be entertained once the prize is forfeited.

8. Responsibility for Participation

8.1. To the extent permitted by law, each Participant agrees not to hold PA, its affiliated organisations and event partners, as well as its/their respective officers, employees and agents liable for any loss, injury or damage suffered by him/her as a result of his/her participation in the Voting and/or the Draw.

9. General Terms

9.1. The Participants agree to comply with all prevailing laws as well as all reasonable instructions and requests made by PA. If in doubt, Participants should seek clarification from PA.

9.2. PA may in its sole discretion and without liability:

9.2.1. modify, suspend, or terminate the Voting and/or the Draw at any time without prior notice; and/or

9.2.2. disqualify any participant or entry that is found to be tampered with or in violation of any of these Terms and Conditions.

9.3. Participants agree to check Chingay's official website (www.chingay.gov.sg) for any updates or modifications to these Terms and Conditions and ensure that they familiarise themselves with these Terms and Conditions. Should any dispute arise in connection with the Voting and/or the Draw, or with the interpretation or implementation of these Terms and Conditions, PA's decision will be final and binding upon the Participants.

10. Use of Personal Data

10.1. By participating in the Voting and the Draw, Participants consent to the collection, use, and disclosure of their personal data by PA and its affiliated organisations for the purpose of:

10.1.1. administering the Voting and the Draw, including but not limited to, verifying the identity and eligibility of the Participant, contacting the Participant, and publishing the name of the Participant (if the Participant is a winner) on Chingay's official website (www.chingay.gov.sg); and

10.1.2. receiving from PA and/or its affiliated organisations marketing messages relating to PAssion Card membership services, programmes, products, announcements, promotions, contests and newsletters provided by PA, its affiliated organisations and/or programme partners, (b) receiving other messages on programmes, courses, events, memberships and/or services run or provided by PA and/or its affiliated organisations and (c) for community outreach, bonding and/or engagement purposes.

10.2. All personal data will be handled in accordance with the Personal Data Protection Act 2012.
