I would like to say those who have **contributed** to the **evidence** whether publicly or anonymously, both new and old. **Thank you**, a lot of people underestimate the amount of money a Roblox studio owner can make, an example is this, search up how much the popular bloxfruit game makes, it is rumored he profited and made close to a million or more on many of the games.

To the former mods who have resigned upon the revealing of this information, I respect you for holding on to your principles and morals.

The main point of the previous document was to spread awareness and this may be an unpopular viewpoint but the development team, the Community Director (Harrison) and the few mods who stayed are **NOT** at fault, the blame is on jackjenningsdev and jackjenningsdev **alone**. Nobody else was complicit in his alleged crimes.

1. Purpose of This Document

The purpose of this document is to clearly distinguish **verifiable facts** from **unverified claims or allegations** related to recent events involving Chesapeake Studios and individuals previously associated with its leadership.

This document exists to:

- Inform the Chesapeake Studios community using **only independently verifiable information**
- Clearly label information that remains **alleged, unresolved, or unconfirmed**
- Reduce misinformation, speculation, and rumor
- Promote transparency without drawing conclusions beyond available evidence

This document does **not** seek to determine guilt, assign intent, or influence legal outcomes.

2. Commitment to Accuracy & Transparency

1. Purpose of This Report

This report provides a **facts-only summary** documenting verifiable events, public statements, and observable platform-level information related to leadership changes and governance continuity at Chesapeake Studios.

4. Leadership & Ownership Representations

4.1 Public Statements

The following reflects **exact language** used in public communications:

“Hi @everyone, It is with a heavy heart that I announce my departure from Chesapeake Studios. I've been given another opportunity which unfortunately will leave me unable to fully dedicate myself to this studio. Chesapeake Studios will be lead moving forward by the talented production team and the Development Operations Manager, @HeyBob. This transition has been in the works for some time, and should not adversely impact operations. The team is looking forward to continuing to provide authentic, quality-focused games to our existing and growing audience. I am grateful for the support of our development team throughout my time at the helm. It has been a privilege growing this studio from a single self-built game to a dynamic team of 12. I look forward to watching from the sidelines as Chesapeake continues to grow.”

“Hi @everyone We respect and support Jack's decision to step away from the company. Studio operations will continue as before as we focus on exciting new games to our existing and growing audience. We have also been working on compliance and other policy related changes that have led to some discord related disruptions, and we apologize that these events have coincided. We have some amazing new projects and updates close to release that we're proud and excited to share with you all. Expect some follow up announcements soon!”

No interpretation or paraphrasing has been applied.

4.2 Observable Platform-Level Access

Following the leadership announcement:

- Administrative or elevated access remained visible on one or more platforms
- Platform role listings did not immediately reflect full removal of privileges
- Continued access was observable through public interfaces

These observations document **what was visible**, not why it occurred.

5. Relationship & Governance Context

Based on publicly accessible information:

- The individual identified as CEO has a publicly verifiable familial relationship with the former owner
- This relationship is documented through open-source sources

No conclusions are drawn regarding governance influence or control.

6. External Legal Record Reference (Existence Only)

Public court search portals list records associated with an individual sharing the same name as the former owner.

Limitations:

- Charges are not characterized
- Identity is not legally confirmed
- Outcomes are not predicted

This information is included solely to explain why public scrutiny has occurred.

7. Findings (Procedural)

- Observable platform access does not fully align with publicly stated disengagement
- Public documentation of governance transition steps is limited
- Transparency regarding access revocation remains unclear

Following the initial release of public documents, additional independent review was conducted to verify which claims could be substantiated through public records and open-source research.

2. Verifiable Legal Record Information

Public Ontario court records show:

- Records exist under the name **Jackson Jennings** in Thunder Bay, Ontario
- Two criminal case entries are listed
- One entry includes a publication ban
- A plea hearing date of **January 22, 2026** is listed

No conclusions are drawn beyond these procedural facts.

3. Identity Consistency (Name & Location)

- The court records list **Jackson Jennings** in Thunder Bay, Ontario
- The former Chesapeake Studios owner is publicly identified as **Jack Jennings** in Thunder Bay
